Enclosed are the budget recommendations from the Legislative Fiscal Office (LFO) for the Board of Tax Practitioners.

The 2023-25 LFO recommended budget for the Board of Tax Practitioners includes \$1,144,206 Other Funds and 2 positions (2.00 FTE). The LFO recommended budget represents a decrease of \$22,763, or 2%, from the 2021-23 legislatively approved budget and a decrease of \$29,659, or 2.5%, from the current service level.

The 2023-25 LFO recommended budget includes:

- \$59,659 Other Funds reduction in facilities rental expenditures to reflect savings realized from the Board terminating its lease agreement and closing its office in February 2023 to become a remote state agency going forward.
- \$30,000 Other Funds increase in the Board's Attorney General line item to cover the cost of billings from the Department of Justice and Office of Administrative Hearings for contested case hearings, which were higher than expected in the 2021-23 biennium.

Package 801 LFO Analyst Adjustments

Package Description

This package decreases the Board's Other Funds expenditures by \$29,659. This amount reflects a decrease of \$59,659 in rental costs, since the Board terminated its lease agreement and closed its office in February 2023 to become a remote state agency. The Board anticipates that it will periodically use office space provided by the Department of Administrative Services free of charge. In addition, this package includes a permanent increase of \$30,000 Other Funds for the Board's Attorney General costs to help defray the cost of billings from the Department of Justice and the Office of Administrative Hearings for contested case hearings, which were higher than expected in the 2021-23 biennium.
