The foundation of the Governor's mission focused approach is **customer service**.


State Government must focus on the basics. The pandemic put an incredible strain on our state government. Our systems have been stress tested under extreme pressure and showed us where we can and must do better.



On Loan Positions

To leverage other funding sources, the Office utilizes state agency funding to cover costs of certain staff who are "on loan". There are eight positions that functionally report to the Governor's Office however the position is funded in a state agency. For example, the Health Policy Advisor is an Oregon Health Authority employee so federal Medicaid funding can be leveraged.

Governor's Budget Policy Option Packages

Package: 090 Analyst Adjustments

This package funds three positions to support the agency – Housing Advisor, Behavioral Health Advisor, and continues the State Wildfire Programs Director. Additionally, this package increases vacancy savings to 5 percent of Salaries and Wages.

Impact: Increase of \$0.5 million total funds, 3 positions, 3.00 FTE

Package: 101 Transfer Culture Change Position to DAS

This package transfers the Director of Affirmative Action Director position from the Office of the Governor to the Department of Administrative Services Cultural Change Office.

Impact: Decrease of \$0.3 million total funds, -1 position, -1.00 FTE

Policy Option Packages

Package: 092 Statewide AG Adjustment

Purpose: This package reduces Attorney General rates by 4.62 percent to reflect adjustments made in the Governor's Budget.

Impact: Decrease of \$9,353 total funds

Package: 093 Statewide Adjustment DAS Charges

Purpose: This package represents adjustments to State Government Service Charges and DAS pricelist charges for services made in the Governor's Budget.

Impact: Decrease of \$73,175 total funds
