### Support Funds and Financial Aid



### A quick snapshot:

Oregon is 45th in the nation for state funding per full-time equivalent student at our public universities.

Nationwide, community colleges saw the greatest enrollment declines as the populations they serve also faced the greatest disruptions from the pandemic.



Funding for student aid has failed to keep pace with the soaring costs of food and housing across Oregon.

Oregon's two financial aid programs, the Oregon Opportunity Grant and Oregon Promise, delivered \$657 per full-time student in 2020. That's well below the U.S. average of \$830.

### Why These Investments Matter

Minimizing Tuition Increases and Cost



When the state doesn't invest, there is a a heavy reliance on student tuition and fee dollars in the absence of state appropriations

Maintaining Current Programs and Services



If the state doesn't fund at least current service levels, wraparound services and programs will be cut.

\$400 Million

# **Oregon Tribal Student Grant (OTSG)**

\$40 million

### These are high-impact investments!



An investment of \$400 million would nearly double the number of students at the current award levels.



OOG recipients show remarkable progress through college and university, compared to other low-income students



Native American students in Oregon enroll in college and university less, have greater levels of financial need, and take longer to complete than the median student. The OTSG is a significant attempt to close these gaps and improve the wage and career prospects of tribal learners.


#### **Inflation**



Groceries have increased in price more than 12% from this time last year.



Housing Crisis In the last year Oregon's homeless population has increased by 22.5%.







SNAP EA's and End of The Public Health Emergency



#### **Retention Crisis**

Over 20% of Oregon college students do not finish college.



### **Designation**



A public institution of higher education may apply for a "Hunger Free Campus" designation. To be eligible, they have to take demonstrated steps to show the State they are committed to this work.

### **Grant Funding**



Once an institution receives designation, they can apply for grant funding to provide moneys for **funding student basic needs programs** and innovations at public institutions of higher education

### **Examples of HFC Funding Use**





#### **Housing Resources**



Connect students to housing resources and services.





Staff the food pantry/basic needs center to stay open more days/hours.

Set up clothing closets for job interviews and internships.



# \$50 million in savings

Represented by courses with the no-cost and low-cost schedule designation during the 2019-21 biennium!

## 47% cheaper AAOT degrees

The average materials cost for the community college Associate of Arts Oregon Transfer (AAOT) degree in 2021 is 47% lower than when the program began in 2015!

### What will the funding impact be?

Expand the open application OER grant program at ~\$10 in student savings per \$1 spent

Expand professional development for faculty to adopt OER at up to ~\$35 in student savings per \$1 spent



Increase personnel to support additional high-quality, equity-focused OER development and translation

Expand outreach on impact reporting and statewide coordination

Support for affordable course materials is effective and high impact



Spending on textbook affordability has a multiplier effect



Affordable textbooks are an essential component of a comprehensive statewide affordability strategy

# Disabled Student Success Task Force (SB 572)



### Disabled students are being left behind



Disabled students are 33% less likely to graduate on time compared to their non-disabled peers. (source)



Only  $\frac{1}{3}$  of disabled students inform their college of their disability due to lack of institutional support. (source).



OSA's survey of students across the state in the Spring of 2022 had numerous disabled students report that they did not feel supported academically and did not have accommodations that met their needs. This entails a lack of support from both instructors and accessibility offices.



There is no statewide standard for students accessing disability accommodations or institutions implementing disability accommodations.

# How will SB 572 help?

SB 572 will establish a legislative Task Force on Ensuring Post-Secondary Educational Opportunities for Individuals with Disabilities. The task force shall investigate whether statutory changes, institutional policy changes or financial investments would improve the experience and outcomes of students with disabilities.
