Reveille Case Management Process

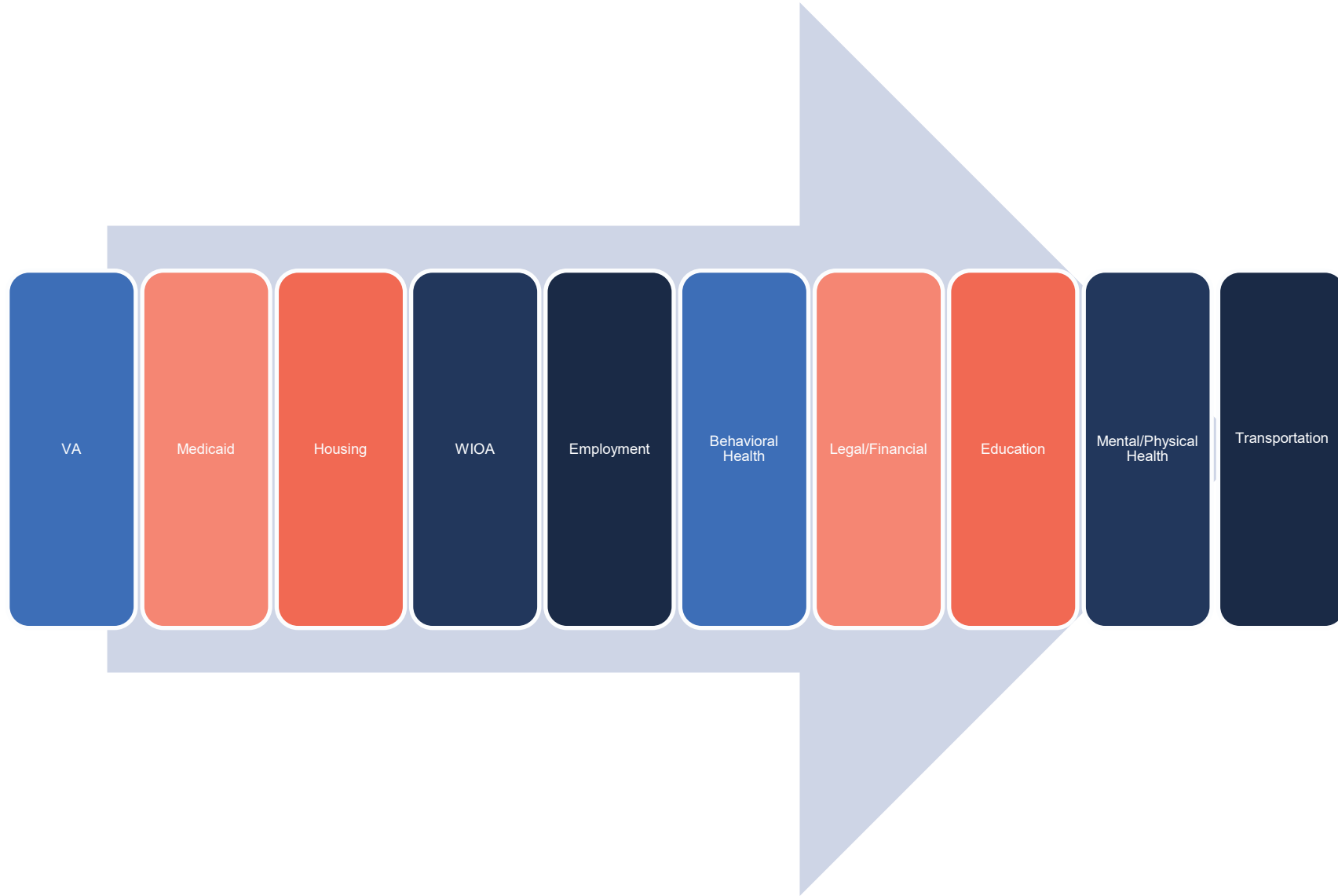

Housing Program Oregon

Housing on 6th Avenue, Lane County

Formerly the Econo Lodge Motel, this housing was purchased by Fortify Holdings, LLC. Built in 1971, two buildings with two-floors and 68 units. Built in 1971 with a stick built, partially brick veneer. It is approximately 14,332 square feet and currently has 68 units. Currently utilized for emergency sheltering by the Oregon Department of Human Services, Office of Resilience and Emergency Management and Reveille.

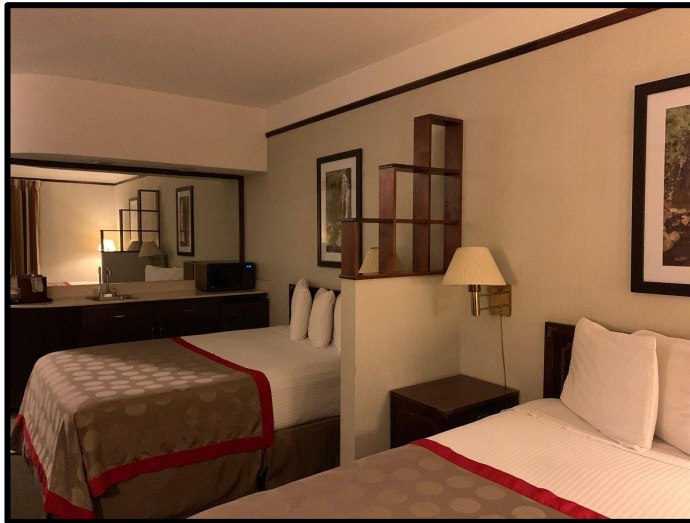


AN INNOVATIVE SOLUTION BOTH SHORT TERM AND LONG TERM:

Mission

The mission of CWT services is to provide support to Veterans living with mental illness or physical impairment with barriers to employment to secure and maintain community based competitive employment. CWT serves different Veteran populations in different ways with three distinct programs:

- **Transitional Work (TW)**
Mental health and substance diagnosis and out of work for a year or more. Work assignments at the VA, 40 hours a week for 6-12 months \$12/hr.
- **Supported Employment (SE)**
SMI diagnosis, assigned a case manager for individualized, vocational, case management.
- **Community-Based Employment (CBES)**
Mental health diagnosis and unemployed for less than a year. assigned a case manager for individualized, vocational, case management.

Memorandum of Agreement with Reveille Allows:

- **Underserved Veterans can be placed at the Reveille Foundation Program**
- **Veterans can progressively work several jobs right on Reveille Campus – Security, Project Management, Case Management, Landscape, Custodial**
- **Veterans gain job skills as they reintegrate into the job market – VA pays for a portion of these positions until they find permanent employment**
- **Reveille can offer housing and employment almost immediately**

Reveille Goals:

- Create an all-inclusive Campus of Housing, Behavioral Health, Case Management and Employment/Training on Site
- Create a Sustainable Program that draws on Housing Vouchers and Billing Medicaid for Behavioral Health and Wraparound Services
- Work Together with Amazing Community Partners with Regular Communications

Challenges with the Financial Model

Challenges with the Housing Financial Model:

- HUD Rates are Much Lower than Current Market Rates
- There is a large Population of At-Risk and Homeless Clients who are not Eligible for HUD Vouchers because of Evictions and Other Barriers
- Non-profits are hindered to Sustain Operations if Most of their Income Passes through for Rent/Mortgage Payments
- Housing and Facilities are Difficult to Keep Maintained and Up to Standards

Shift The Paradigm

Assisting Nonprofits in Purchasing Properties Will:

- Ensure these Properties remain Low Income Housing in Perpetuity
- Allow the Nonprofit to Accept More People
- Facilities will have more budget to maintain the property, offer more financial incentives and increase services and programming
- Lead to Quicker Pathways to Private, Permanent Housing

RFP opens January 2024

Due February

Reviewed April

Awarded in May *Not Acquisition but Refurbishment

- **City of Eugene CDBG – Total Award - \$?**
 - For Local Service Providers
 - * Not Acquisition but Refurbishment
- **State Land Acquisition Funds**
 - Short Term Loans for Five Years
 - Upfront Money While You Get Lone to Repay
- **Oregon Community Foundation – TurnKey 3.0?**
 - Closed this year
- **Federal – Congressionally Delegated Funding**
 - Closed this year
- **Low Income Tax Credits**
 - Must use a Development Consultant
 - Pays for up to 75% of the project, Mortgage the other 25%
 - Housing Development Corporation
 - Guardian
