The Legislative Fiscal Office (LFO) recommendation for the District Attorneys is to fund the agency at \$16.4 million General Fund and 36 position (36.00 FTE), which is an 8.2% increase over the 2021-23 legislatively approved budget. The recommendation includes two policy packages:

- \$280,000 General Fund for funding for grand jury recordation; and
- \$550,000 General Fund (one-time) for the final reconciliation of personal service costs for the biennium. This package includes a request that the Department of Administrative Services unschedule \$550,000 General Fund pending the District Attorney's submission of a final reconciliation of personal service costs for the biennium to the Legislative Fiscal Office.

## Package 107 Grand Jury Recordation

Package DescriptionThis package appropriates \$280,000 General Fund for the cost of grand jury recordation (SB 505, 2017), which requires county district attorneys to electronically record all grand jury proceedings and to store and maintain copies of the audio recording. The appropriation includes the following:

Statewide transcription service for district attorney offices - Private vendor(s) by which counties access service - Department of Justice to procure and administer statewide contract(s) at an estimated cost of \$150,000 General Fund.

Storage, licensing, and archiving of grand jury recordings - Department of Justice to provide segregated hosting, security, backup, maintenance, and customer support, including associated licensing cost at an estimated cost of \$115,000 General Fund.

Annual training on grand jury recording equipment - Judicial Department to bill the District Attorney on a fiscal year basis for annual training(s) on the recording equipment for up to \$15,000 General Fund.

## Package 801 LFO Analyst Adjustments

<u>Package Description</u> This package appropriates \$550,000 General Fund, on a one-time basis, to fund the reconciliation of anticipated personal service costs for 2023-25 biennium.

The package provides funding for the final reconciliation of Other Payroll Expenses, which becomes necessary due to a variance between an individual district attorney's health benefit plan choice versus the cost estimate in the budget. A portion of the variance may be offset by vacancy and/or other savings. A similar budget adjustment has been funded by the legislature in the last four of the past biennia.

LFO Recommendation Approve the package, on a one-time basis.

<u>Budget Instructions</u> Request that the Department of Administrative Services unschedule \$550,000 General Fund pending the District Attorneys submission of a final reconciliation of personal service costs for the 2023-25 biennium to the Legislative Fiscal Office for review and approval of the amount to be scheduled for expenditure and that is net of any estimated budgetary savings for the biennium.
