What is Psilocybin?

Psilocybin is a naturally occurring psychedelic compound found in over 200 species of mushrooms that grow around the world.



What is Ballot Measure 109, The Oregon Psilocybin Services Act?

- **Manufacturer Licenses**
 - 22 applications, 3 licenses issued, 55 pending in TLC
- **Laboratory Licenses**
 - 2 applications, 1 license issued, 4 pending in TLC
- **Service Center Licenses**
 - 19 applications, 3 licenses issued, 15 pending in TLC
- **Facilitator Licenses**
 - 59 applications, 8 licenses issued, 6 pending payment, 164 pending in TLC
- **Worker Permits**
 - 272 applications, 84 permits issued, 27 pending payment, 102 pending in TLC



What are Psilocybin Services in Oregon?

Psilocybin will only be administered to persons 21 years or older in licensed service center settings under the supervision of trained and licensed facilitators.

Who will be licensed as facilitators?



- 21 years of age or older
- High School Diploma or equivalent
- Complete OHA approved training program
- Pass training program comprehensive exam
- Oregon resident for two years (expires 2025)
- Pass regulations exam administered by OHA
- Pass background check

Oregon Psilocybin Services Development Phase

- Oregon Psilocybin Advisory Board and its subcommittees:
 - **19 board meetings and 110 subcommittee meetings**
- Two rulemaking events in 2022:
 - **12 hours of public listening sessions** offered in English, Spanish, American Sign Language (ASL), and in CART captioning
 - 6 Rules Advisory Committees: **62 members, 13 meetings, and 39+ hours of discussion** on draft rules
 - 2 public comment periods for rulemaking: **44 days, hundreds of written comments, 5 public hearings** on rules offered in English, Spanish, American Sign Language (ASL), and in CART Captioning, **10 hours of public testimony**
- TLC development
 - Training program curriculum applications on **June 6, 2022**
 - License applications on **January 2, 2023**
- Fact sheets and training videos in **English, Spanish, and American Sign Language**
- Application guides, licensing application guides, additional resources
- Outreach to over **100 community-based organizations**, held culturally responsive circles with communities, and provided **presentations for 50+ organizations, conferences, and events**
- Responded to **hundreds of inquiries**, phone calls, meetings requests, presentation requests, and public records requests
- OPS distribution list, **13,700+ subscribers**
