





- Implementation of Climate, Health, and Housing Institute leadership development program.



Local & Tribal Public Health Authorities

- Identify climate risks & priority populations
- Estimate health impacts
- Identify strategies
- Develop & implement a plan
- Evaluate effectiveness & improve
- Required for LPHAs



OHA Environmental Public Health Section



- Centering community & environmental equity
- Implement ~20 programs with ~40 staff
- Provide technical expertise to legislature, state & local environmental & emergency response agencies, general public
- Excludes Public Water Systems, Radiation Protection



Healthy Homes and Schools

- Healthy Homes Grant Program (NEW general fund)
- Lead Paint Hazards (federal grant & fees)
- Childhood Lead Poisoning Prevention (federal grant)
- Toxic Free Kids Program (general fund & fees)
- Radon Awareness (federal grant)
- Clandestine Drug Lab (interagency agreement w/DEQ)

New Policy Capacity:

• Healthy Homes & Schools Strategist (GF Modernization)

Climate and Health Program

- State Climate and Health Program (federal grant)
 - Evidence base for human health risks from climate change-driven hazards
 - Equity partner for natural resource agencies
 - Technical assistance to public health system & natural resource agency partners
 - Tribal, County, Community Based Organizations (GF modernization)

- Climate Equity Strategist Position (GF Modernization)
- Emerging Environmental Threats Strategist Position (GF Modernization)
- Land use and Built Environment Position (GF Modernization)



Environmental Toxics Program

- Human Health Toxicology Team (federal grant and general fund)
- Public Health Assessments for Superfund and other contaminated sites (federal grant)
- Toxics consults to legislature, state and local environmental and emergency response agencies, general public (federal & gen'l)
- Co-implement Cleaner Air Oregon industrial air toxics healthbased regulatory program with DEQ (fee-based interagency agreement)

Public Health Surveillance

- Env. Public Health Tracking Data & Informatics (federal grant)
 - Epidemiologist interpreting env. & health outcome data
 - Data access via Tracking Portal
 - Data Equity Strategist Position
- Environmental Justice Mapping Tool w/DEQ (general fund)
- Healthy Waters Advisories: fish consumption, harmful algae
 blooms, beach water quality (federal grants & GF)
- Pesticide Exposure, Safety and Tracking (interagency agreement w/ODA)
- Occupational Health (interagency agreement w/OHSU)
- **Domestic Well Safety** (pending 2023 general fund request)

New policy capacity

• Water & Climate Epidemiologist (GF Modernization)



Food, Pool and Lodging Safety

- All fee-funded
- Center of technical expertise and regulatory consistency supporting Local Public Health Authority licensing and inspection
- Foodborne Illness Prevention Program oversight of 17,000 food service facilities
- Pool & Spa Safety Program oversight of 3,500 facilities
- Lodging Safety Program oversight of 2,500 facilities




- ~4500 domestic wells serving 12,000 people
 - ~3400 Umatilla County
 - ~900 Morrow County
- High nitrates reduce ability of blood to carry oxygen
- Acute: bottle-fed babies and exposure during pregnancy; Chronic: a concern for all
- State providing testing, water provisioning, treatment systems

 2515 Safe Drinking Water
 Act-regulated (76%)
 804 Very Small State


 804 Very Small State Regulated (24%)

- "Community" typically
 municipally-run system
- "Non-Community" systems such as schools, campgrounds



Funding Sources – Public Water Systems

Drinking Water Services Section – 2021-2023 Biennial Budget



- Base federal funding ~\$7 to 9
 million/year
- 2021 Bipartisan Infrastructure Law will boost funding 2023-27
- OHA has received requests for 84 projects totaling \$574M – compared to ~\$35M available
- Governor Kotek call: state supplemental funding to reduce the gap
