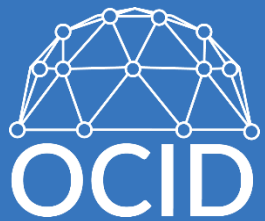

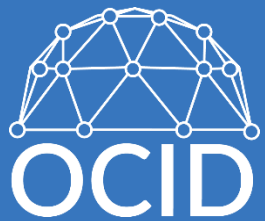

OCID Timeline Past, Present, and Future

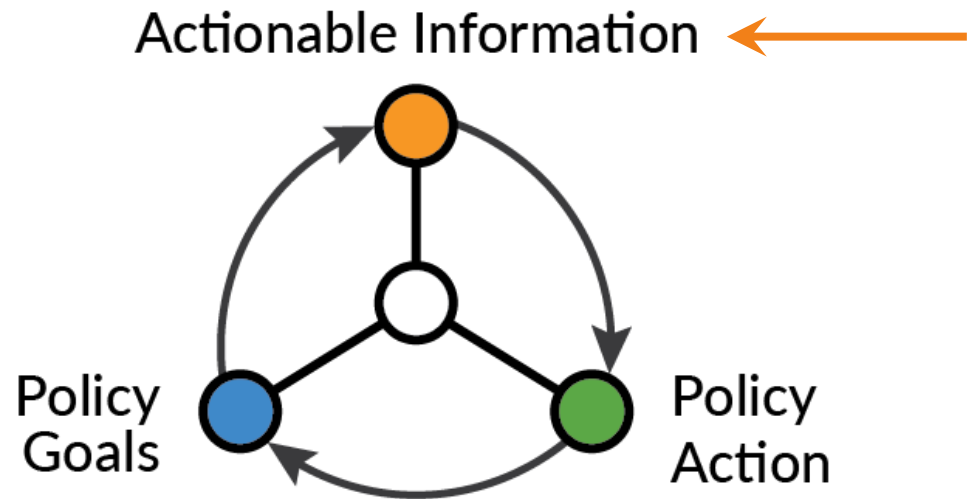

Core Policymaking Components



Oregon Child Integrated Dataset (OCID)

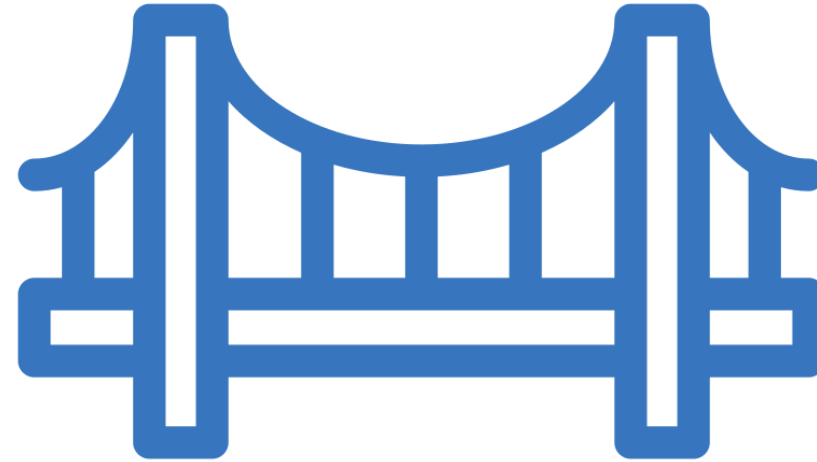
- Non-partisan, objective resource to improve the well-being of all children in Oregon
- Oregon-specific, cross-program data across childhood starting in 2001
- Responsive and accessible in-depth analyses and interactive data visualizations
- Guided by state policymakers and community leaders

OCID's Data Landscape

 - › Children's System of Care Data Dashboard (SB1)

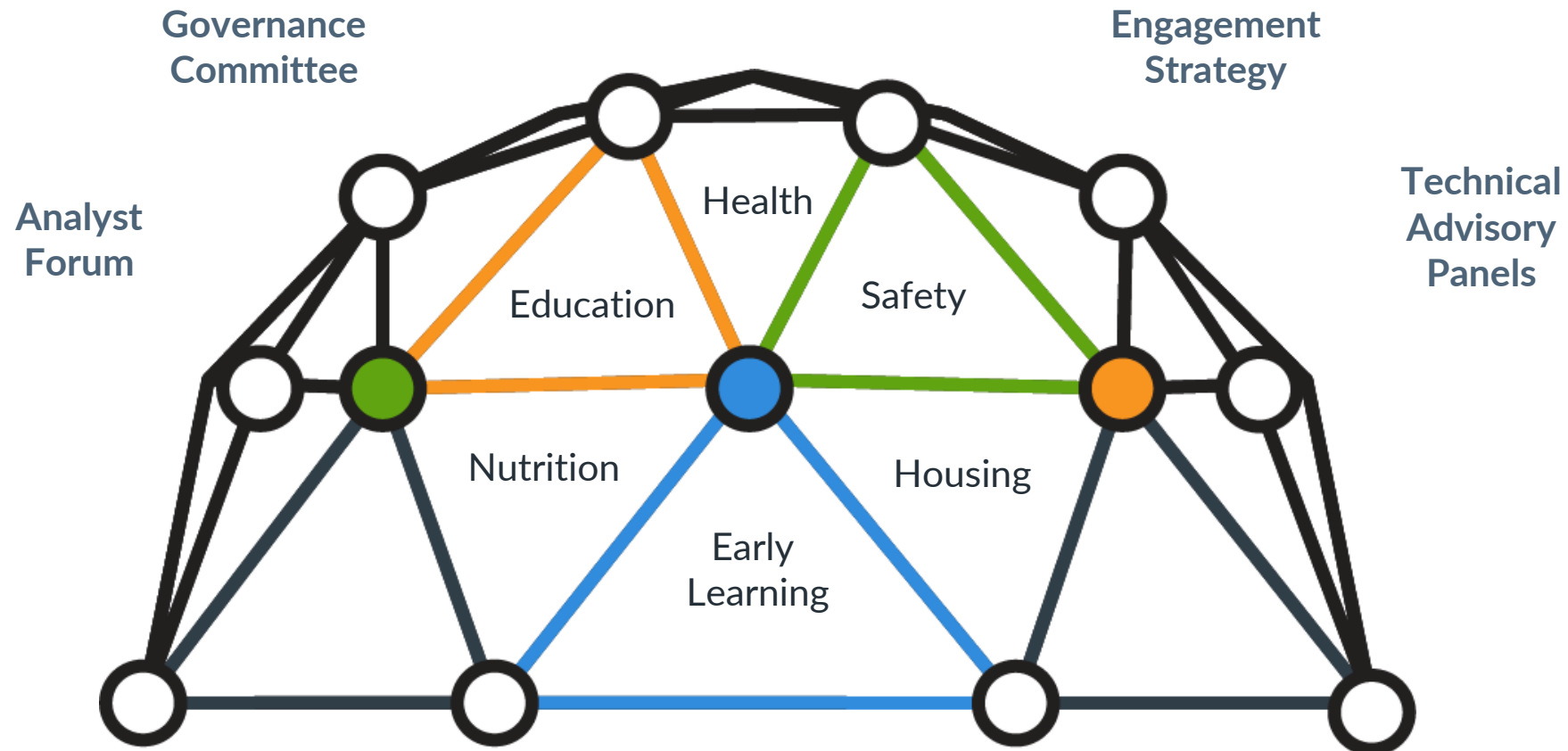


DATASET ADMINISTRATION

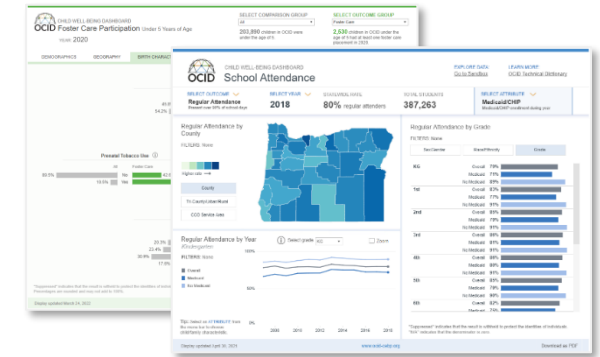


OCID's Products: Data for Policymaking



- **Child Well-being Dashboard**

- › Provide public access to data on key indicators of child well-being using geographic, demographic, and cross-program attributes
- › Permit exploration of interactions, investigate trends, and formulate key questions



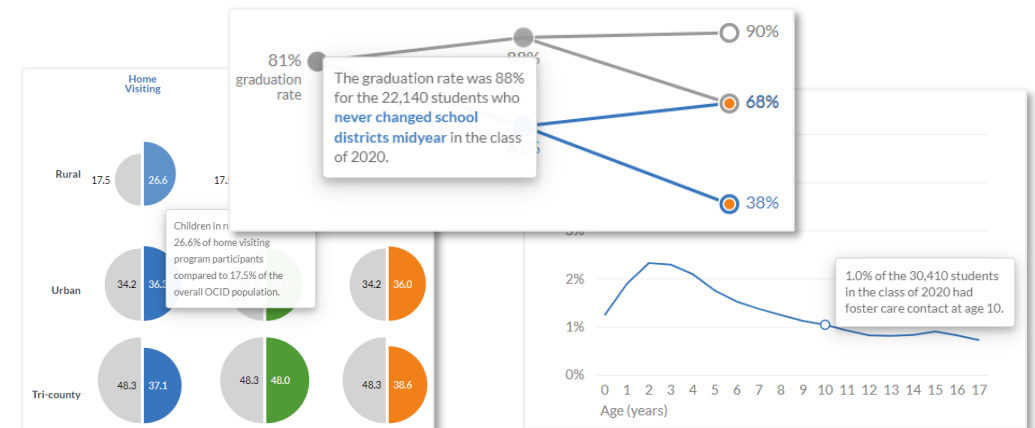
- **Analyses to Date**

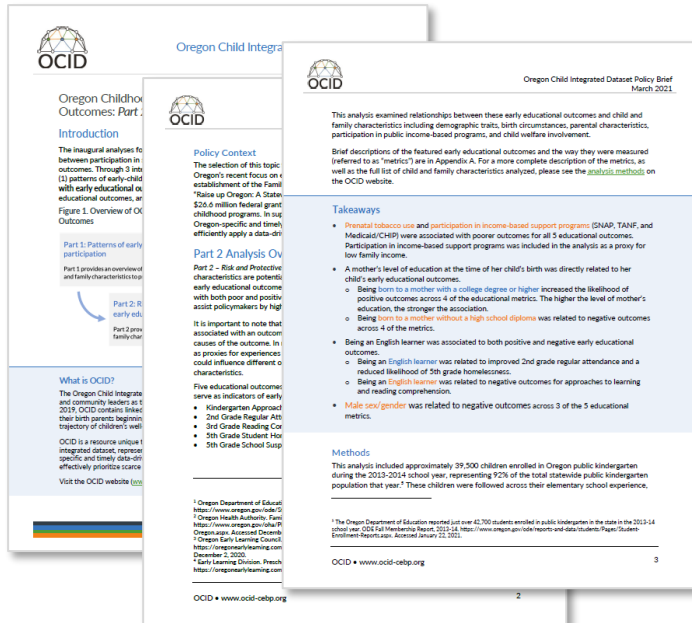

OCID Analysis

Childhood Program Participation and Early Educational Outcomes



POVERTY INDICATOR

Enrollment in Medicaid/CHIP, SNAP and/or TANF in the first 5 years of life

Background

- Analysis of a single cohort of students for potential risk and protective factors associated with 5 early educational metrics
 - › Kindergarten Approaches to Learning
 - › 2nd Grade Regular Attendance
 - › 3rd Grade Reading Comprehension
 - › 5th Grade Student Homelessness
 - › 5th Grade School Suspensions

Selected Key Findings

- Indicators of early childhood poverty were associated with poorer outcomes for all 5 educational metrics.
- Children with very low income (10,633 students with TANF) were chronically absent in 2nd grade at 2.5 times the rate of their non-enrolled peers (25% versus 10%).

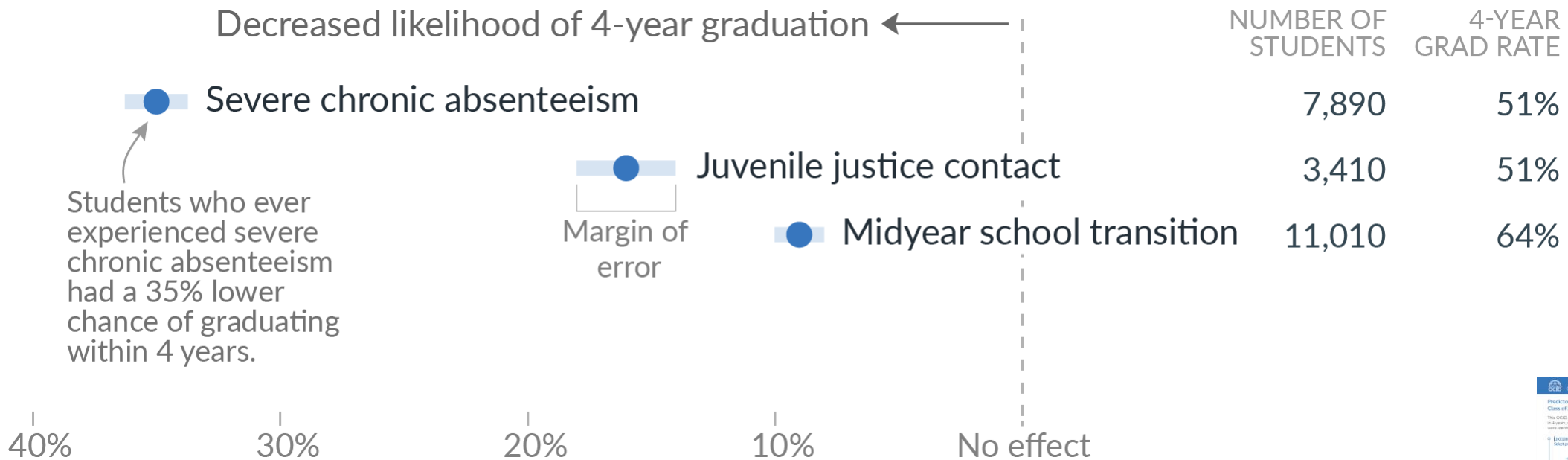
High School Class of 2020 Highlights

Oregon High School Class of 2020 Analytic Series

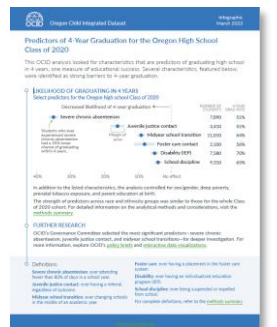


LIKELIHOOD OF GRADUATING IN 4 YEARS

Select predictors for the OCID high school Class of 2020



In addition to the listed characteristics, the analysis controlled for sex/gender, disability, school discipline, deep poverty, prenatal tobacco exposure, parent education at birth, and foster care involvement. The strength of predictors across race and ethnicity groups was similar to those for the whole Class of 2020 cohort.



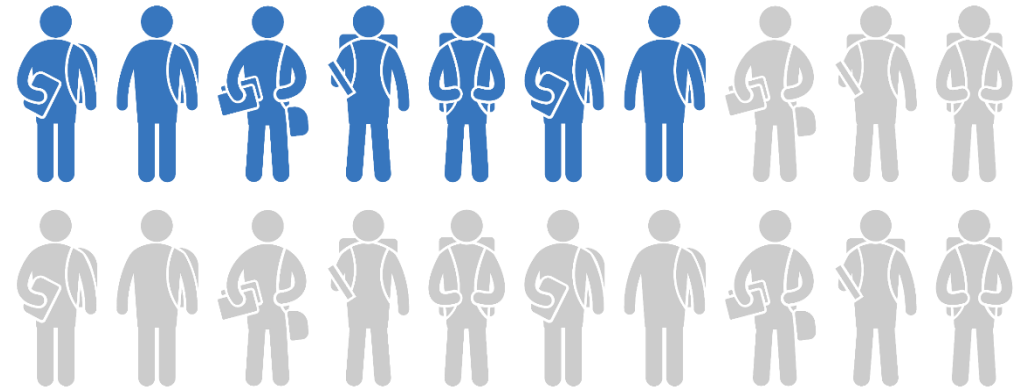
OCID uses enrollment in income-based support programs as proxies for experiences or exposures to poverty that cannot be measured accurately and completely with available data.

- Proxy for **deep poverty**
 - › Enrollment in Temporary Assistance for Needy Families (TANF)
 - Income eligibility is 37% federal poverty level
- Proxy for **very low income**
 - › Enrollment in Supplemental Nutrition Assistance Program (SNAP)
 - Income eligibility is 185% federal poverty level
- Proxy for **low income**
 - › Enrollment in Medicaid/CHIP
 - Income eligibility is up to 300% of federal poverty level for children

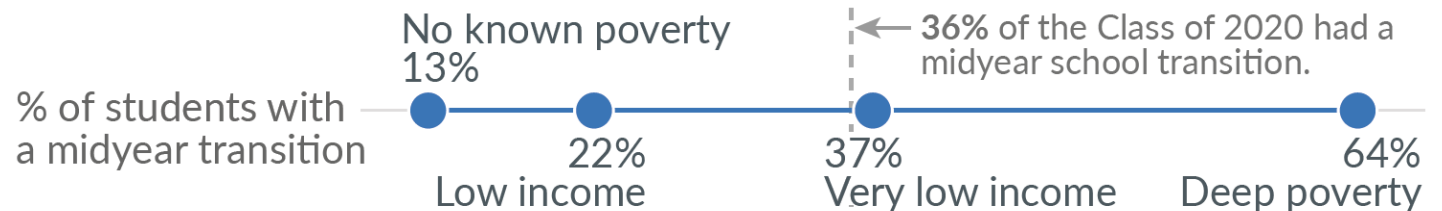
Oregon's Class of 2020 Series: Midyear School Transitions



36% of students in the Class of 2020 ever changed schools midyear.



A disproportionate proportion of students who ever experienced deep poverty also had at least 1 midyear school transition (**64%** or **5,350 students**).



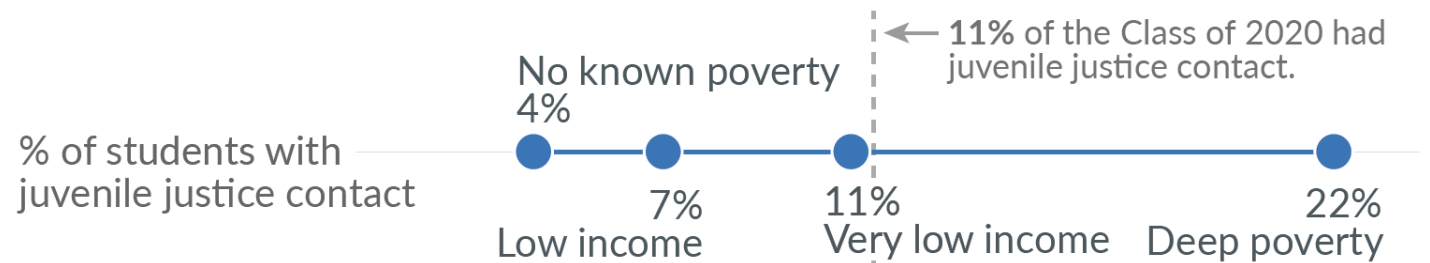
Oregon's Class of 2020 Series: Juvenile Justice Contact



11% of students in the Class of 2020 ever had justice system contact.



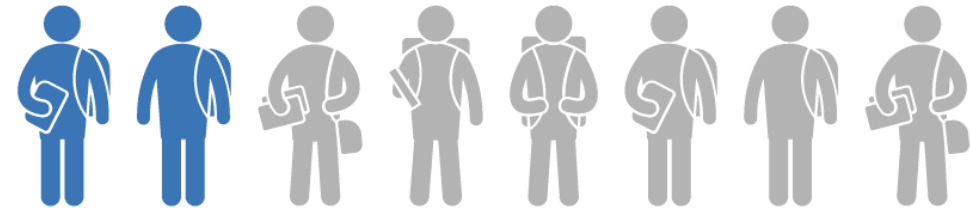
A disproportionate proportion of students who ever experienced deep poverty also had juvenile justice system contact (**22%** or **800 students**).



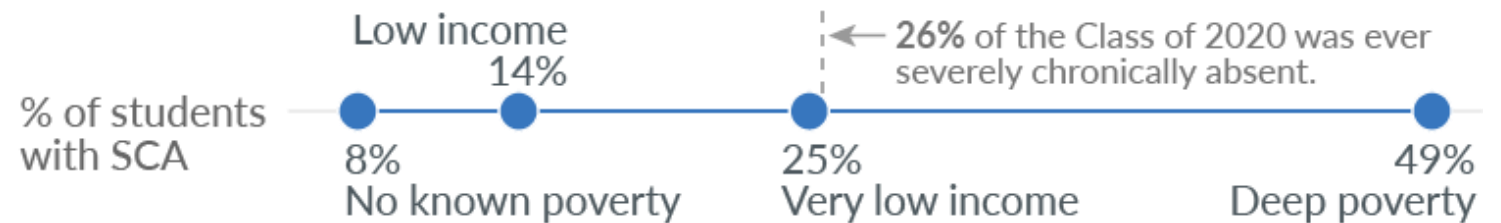
Oregon's Class of 2020 Series: Severe Chronic Absenteeism (SCA)



26% of students in the Class of 2020 were ever severely chronically absent.



A disproportionate proportion of students who ever experienced deep poverty were also severely chronically absent (**49%** or **4,130 students**).

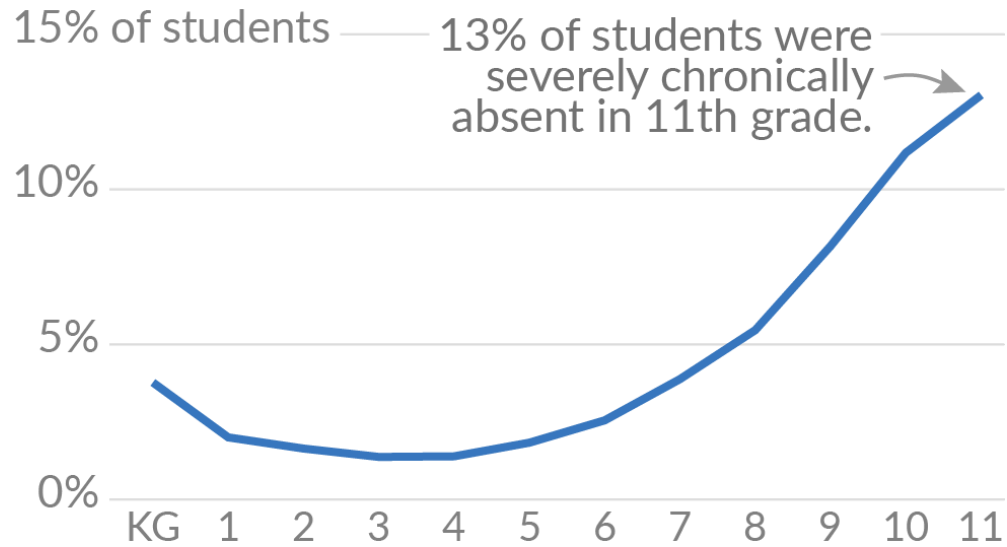

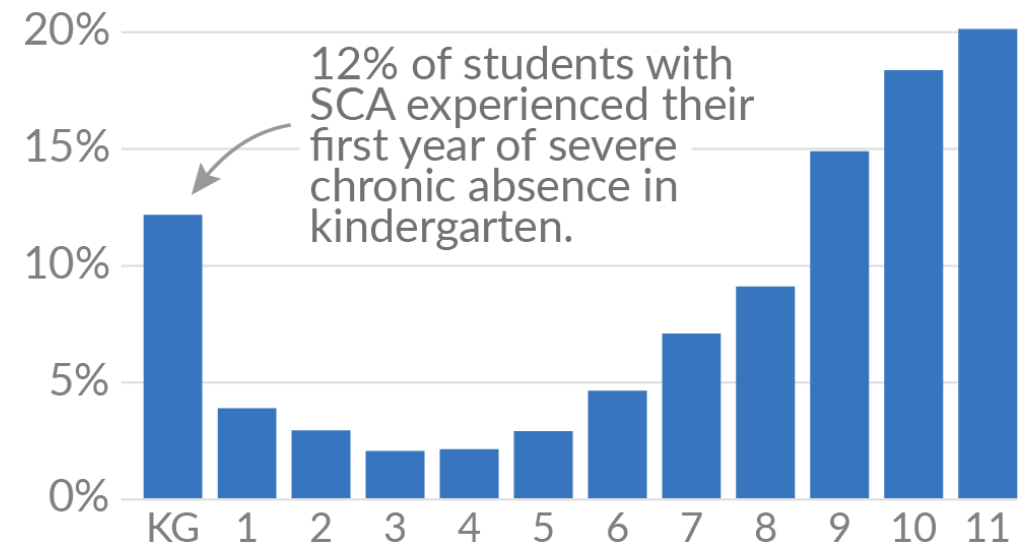


Timing of SCA

FIRST YEAR OF SCA

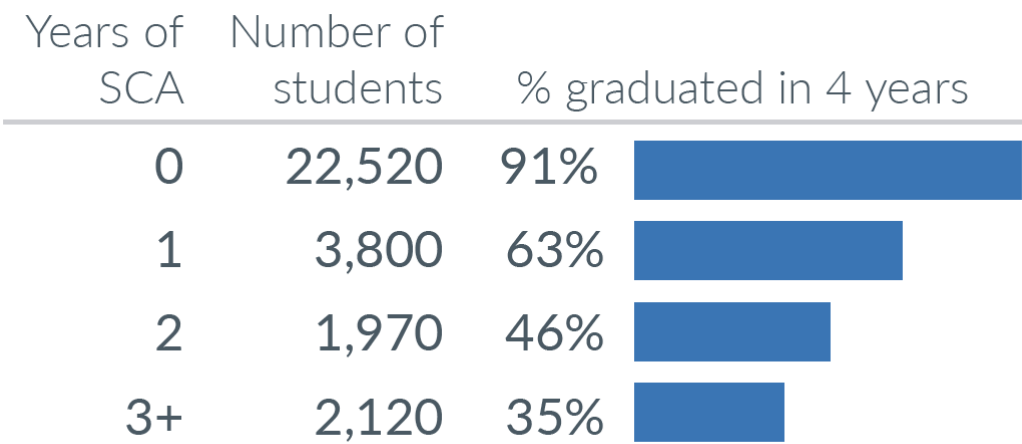

4-year High School Graduation Rates

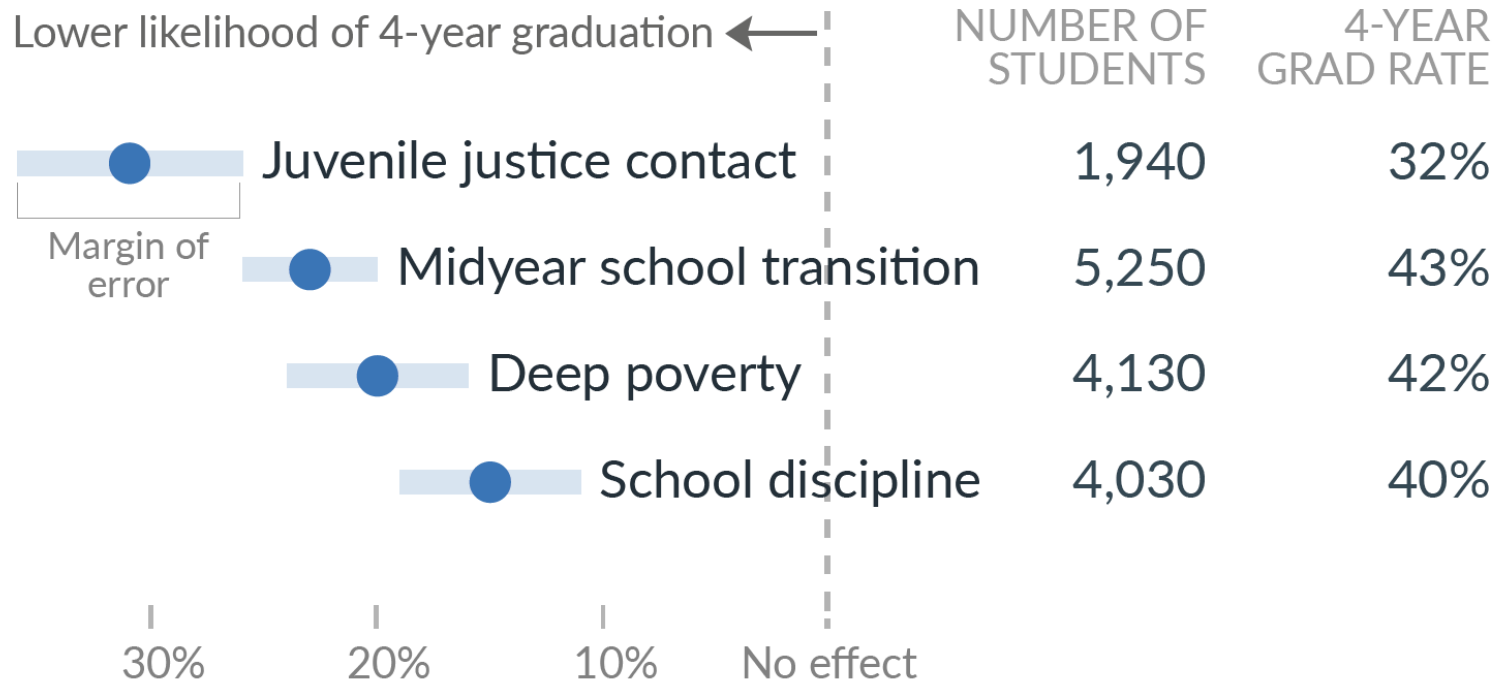
GRADUATION RATE BY TOTAL YEARS OF SCA

TOP BARRIERS TO 4-YEAR GRADUATION FOR STUDENTS WITH SCA



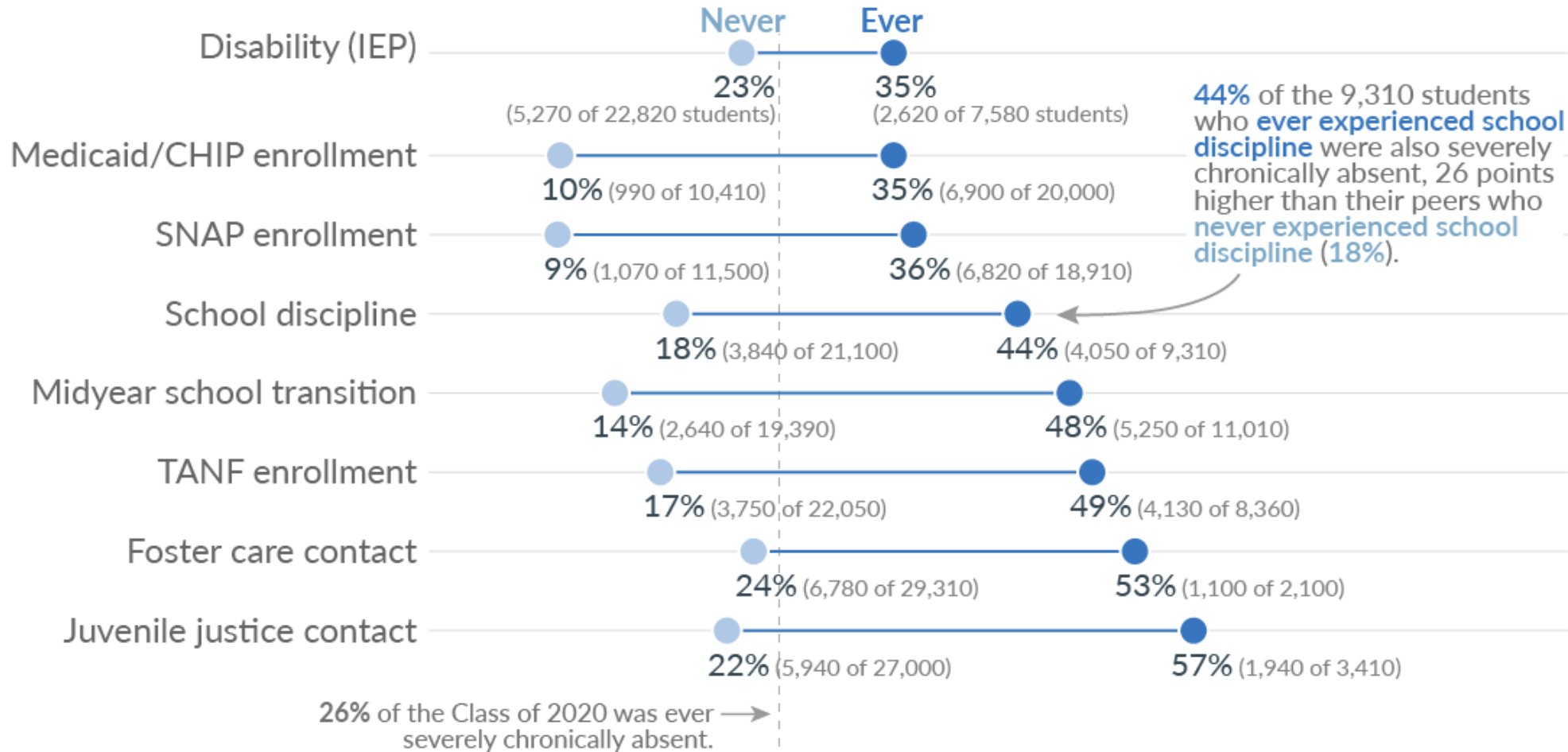
Deep poverty is defined here as ever being enrolled in TANF. In addition to the listed characteristics, the analysis controlled for sex/gender, disability, and very low income.

Key Takeaways

- 1 Ever having SCA is one of the top 3 barriers to 4-year graduation identified in OCID's analysis.
- 2 26% of the Class of 2020 experienced SCA at least one year in school; students who ever experienced deep poverty had higher rates.
- 3 Students with multiple years of SCA had decreased 4-year graduation rates.
- 4 For students with SCA, experiences with juvenile justice involvement, mid-year school transitions, deep poverty, or school discipline create additional barriers to 4-year graduation.

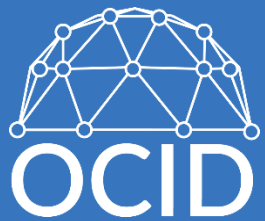

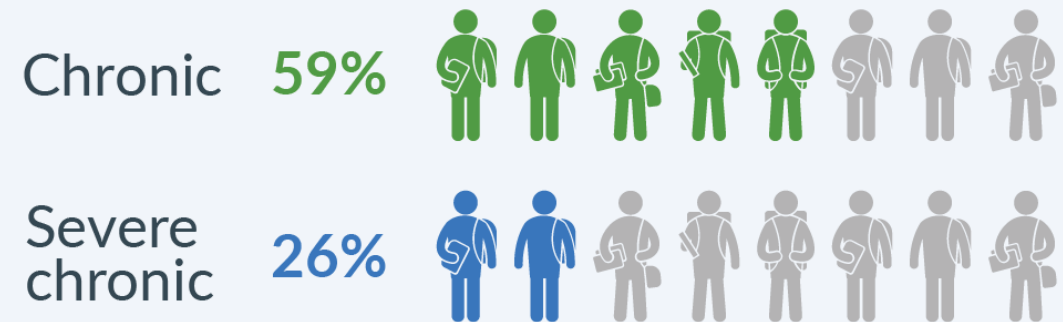
Oregon's Class of 2020 Series: Severe Chronic Absenteeism (SCA)



Differentiating from Chronic Absenteeism

- **Chronic absenteeism** means attending **90%** or fewer school days in a year
- **Severe chronic absenteeism** means attending **80%** or fewer school days in a year
