Attached are Legislative Fiscal Office (LFO) recommendations for the 2023-25 biennial budget and key performance measures for the Department of Fish and Wildlife.

The recommended budget of over \$537 million total funds supports 1,362 positions (1,175.63 FTE) and represents a 10.3% increase over the 2021-23 legislatively approved budget (LAB), and a 17.5% increase over the 2023-25 current service level (CSL). This increase is driven by a total of \$80 million in recommended packages, including \$11 million General Fund, \$16 million Other Funds, and nearly \$53 million in Federal Funds expenditure limitation. This investment is represented in 22 policy packages, inclusive of four that are funded through the state's Drought Package, which provided \$3 million General Fund and four positions (4.00 FTE) to focus on instream needs, temperature monitoring and delivery of drought resilient projects. Other notable investments include support for the Private Forest Accord; positions to add capacity to existing programs, including those with federal partnership; funding to upgrade the agency's website; Federal Funds expenditure limitation for acquisition of the Minam River Wildlife Area; over \$41

million in Federal Funds expenditure limitation for anticipated grants; and position related technical adjustments.
