#### STATE BOARD OF DIRECT ENTRY MIDWIFERY

The Governor has appointed the following individual to the State Board of Direct Entry Midwifery subject to Senate confirmation.<sup>1</sup>

### **Appointment/Confirmation Authority**

ORS 687.470 (2021)

#### Statement of Economic Interest<sup>2</sup>

Not required.

### **Statutory Requirements**<sup>3</sup>

The board consists of seven members appointed by the Governor and subject to confirmation by the Senate.<sup>4</sup> All members of the board must be residents of this state. Members serve three-year terms and at the pleasure of the Governor.

Four members must be licensed direct entry midwives (KLEIN, PETTIBONE, FISHER, MANCE). Board members required to be licensed direct entry midwives may be selected by the Governor from a list of three to five nominees for each vacancy, submitted by a professional organization representing direct entry midwives.

One member must be a certified nurse midwife (MORALES).

One member must be a licensed physician involved, at the time of appointment, in obstetrical care or education (SMITH).

One member must be a member of the public (**PETERS**).

## **Duties and Authority**

The board must elect a chairperson and adopt rules to govern its proceedings.5 The board must adopt rules for the administration of direct entry midwifery licensing, practice, and discipline.6
