WORKERS' COMPENSATION MANAGEMENT-LABOR ADVISORY COMMITTEE

The Governor has appointed the following individual to the Workers' Compensation Management-Labor Advisory Committee subject to Senate confirmation.¹

Statutory Requirements³

The committee consists of 11 members, 10 of whom are appointed by the Governor and subject to confirmation by the Senate.⁴ Five appointees must be from organized labor and represent subject workers (CALZIA, GRAIL, **MERRICK**, STRICKLAND, WEDDELL), and five members must represent subject employers (DUCKWALL, HEARN, MCKENZIE, PRIEST, VACANT). The Director of the Department of Consumer and Business Services is an ex officio member (STOLFI). Appointed members serve three-year terms.

Duties and Authority

The committee provides an effective forum for business and labor to meet, explore, and resolve issues involving the workers' compensation system.⁵ The committee must:⁶

- biennially review the standards for evaluation of permanent disability and recommend to the director factors to be included or such other modification of application of the standards as the committee considers appropriate;
- biennially review and make recommendations about permanent partial disability benefits:
- advise the director regarding any proposed changes in the operation of programs funded by the Workers' Benefit Fund and review any plan the agency devises to increase the balance of the fund;
- report the committee's findings to the director for such action as the director deems appropriate; and
- report to the Legislative Assembly such findings and recommendations as the
 committee considers appropriate, including a report on: decisions of the Supreme
 Court and Court of Appeals that have significant impact on the workers'
 compensation system; adequacy of workers' compensation benefits; medical and
 legal system costs; adequacy of assessments for reserve programs and
 administrative costs; and the operation of programs funded by the Workers'
 Benefit Fund.
