Testimony Submission Form

Please submit written testimony using the form below. Written testimony may only be submitted for bills that are scheduled for a public hearing. Testimony must be received within 48 hours after the start time of the committee meeting at which the public hearing is held. Testimony submitted after the 48-hour time period will not be uploaded to OUS. If you are not able to submit your testimony within the open record window, feel free to submit your testimony to your legislator or to committee members directly.

Please use discretion with your personal information in written testimony. DO NOT include personal information that you do not want displayed to the public. All meeting materials, including your name and any personal information contained in the submitted form, except for your email, are posted to OUS and are accessible to all major search engines, including Google, Bing, and Yahoo.

ATTENTION ALL PUBLIC EMPLOYEES:

The restrictions imposed by the law of the State of Oregon on your political activities are that "No public employee shall solicit any money, influence, service or other thing of value or otherwise promote or oppose any political committee or promote or oppose the nomination or election of a candidate, the gathering of signatures on an initiative, referendum or recall petition, the adoption of a measure or the recall of a public office holder while on the job during working hours. However, this section does not restrict the right of a public employee to express personal political views."

It is therefore the policy of the state and of your public employer that you may engage in political activity except to the extent prohibited by state law when on the job during working hours. (ORS 260.432)
