WHAT THE MEASURE DOES:

Directs specified agencies that provide temporary housing to displaced individuals in an emergency to ensure the housing is safe and in compliance with state and federal laws relating to discrimination. Clarifies "specified agency" includes Department of Emergency Management, Oregon Housing and Community Services, or the Department of Human Services. Clarifies, for purposes of Act, that temporary housing is considered to be a dwelling as defined by Oregon Law related to discrimination in selling, renting or leasing real property (ORS 659A.421) and the Federal Fair Housing Act. Allows specified agency administering federal emergency response resources to provide similar or equivalent resources to community members ineligible for these resources for any reason, including immigration status, subject to specified agency funding availability. Declares emergency, effective on passage.

ISSUES DISCUSSED:

- Struggles of families displaced by 2020 Almeda wildfire
- Barriers to undocumented community members in accessing Federal Emergency Management Agency disaster support
- Provisions of amendment

EFFECT OF AMENDMENT:

Replaces the measure.

BACKGROUND:

ORS 401.185 describes the temporary provision of housing when the Governor or U.S. President has declared a state of emergency or major disaster in Oregon. State law directs the Governor to coordinate with federal agencies to arrange temporary housing for disaster victims, and to make the units available to local governments.

The Federal Emergency Management Agency (FEMA) provides direct housing resources to disaster survivors whose primary home is destroyed or is unlivable as a result of major damage caused by the disaster, or who has no other practical temporary housing options available within a reasonable commuting distance due to a lack of available rental resources. FEMA indicates that, to qualify for disaster assistance, the applicant must be either a U.S. citizen, non-citizen national, or qualified non-citizen based on specifications.

House Bill 3462 A directs the Department of Emergency Management, Oregon Housing and Community Services, and the Department of Human Services, in the provision of temporary housing to displaced individuals in an emergency, to ensure the housing is safe and in compliance with state and federal laws relating to discrimination. The measure allows these agencies to provide similar or equivalent resources to community members ineligible
