### WHAT THE MEASURE DOES:

Requires that any official ceremony or other event held by state government to commemorate Memorial Day or Veterans Day be held on a legal holiday. Requires Director of Oregon Department of Veterans' Affairs (ODVA) to notify legislative presiding officers at least 30 days in advance if ceremony is to be held on day other than legal holiday. Directs ODVA to ensure that members of the public have access to attend, or participate in, official ceremonies or other such events. Declares that it is expectation of Legislative Assembly that all state-owned and state-maintained facilities, memorials, and war memorials are to be in clean condition and good repair for Memorial Day and Veterans Day, as well as for any other ceremony or other event that may be held to commemorate those two holidays. Directs the Department to report to interim legislative committees, by September 15 of each year, on the conditions of state-owned or state-maintained veterans facilities, memorials and war memorials.

#### **ISSUES DISCUSSED:**

- Ceremonies for Veterans Day and Memorial Day
- Condition and state of repair of memorials and war memorials

#### **EFFECT OF AMENDMENT:**

Replaces process for holding ceremonies and events on days other than the legal holiday by specifying that Director of Oregon Department of Veterans' Affairs shall notify presiding officers of circumstances at least 30 days prior to the legal holiday, to the extent possible. Replaces provisions related to condition of facilities and memorials with provision stating expectation of Legislative Assembly that all state-owned and state-maintained facilities, memorials, and war memorials are to be in clean condition and good repair for Memorial Day, Veterans Day and ceremonies related to both days. Requires Director to communicate expectation to all state agencies in advance of every Memorial Day and Veterans Day.

#### **BACKGROUND:**

Memorial Day traces its origins to 1868, when it was originally known as Decoration Day, intended to honor the Union soldiers who lost their lives during the Civil War. Prior to being observed nationally, there were several such recognition days held locally. The National Cemetery Association traces the origin to Columbus, Georgia, where the Ladies Memorial Association was formed to clean up the city's cemetery and, in the words of a letter published in the local newspaper, "to wreathe the graves of our martyred dead with flowers." By 1890 the occurrence was held in every state, eventually leading Congress to declare the last Monday in May as Memorial Day.

Veterans Day also originated as a date of recognition with a different name. On November 11, 1919, President Woodrow Wilson commemorated the one-year anniversary of the end of hostilities in what would later be known

as World War I. The day was known as Armistice Day until the end of World War II, when General Dwight Eisenhower picked up on the idea of a fellow veteran to dedicate the day to veterans of all wars, and later signed the bill as President in 1954.

House Bill 3421 A requires the Director of the Department of Veterans' Affairs to ensure that all state-owned and/or state-maintained veterans' facilities, memorials for honoring veterans, and war memorials are in clean condition and good repair for Memorial Day, Veterans Day, and other events held to commemorate those days. The measure provides a process for notifying legislative leaders in advance of any plans to hold events on days other than the legal holidays.
