Summary of Revenue Changes

House Bill 2717 appropriates \$65,496 General Fund to the Department of Early Learning and Care (DELC) to license and oversee outdoor child care programs as defined in the measure.

Summary of Education Subcommittee Action

House Bill 2717 adds outdoor child care programs to the definition of child care facility. The bill requires the Early Learning Council to adopt rules governing the operation of outdoor child care programs and establishes certification and oversight provisions to be administered by the Office of Child Care (OCC) within DELC. The bill requires outdoor preschool providers to receive certification to operate and those applications will be reviewed and processed by OCC. Providers must demonstrate adequate sanitation, maintenance, food preparation, and food storage areas.

To perform the necessary work required, the bill appropriates \$65,496 General Fund to DELC. This appropriation will provide \$48,039 General Fund for one new permanent, full-time Compliance Specialist 2 position (0.25 FTE). This position will conduct site visits, complete inspections, and review applications for certification from outdoor child care program providers. In addition, \$17,457 General Fund is provided for position-related Services and Supplies costs and a one-time cost of \$5,560 to cover consultation with the Attorney General during rulemaking. Rule development for the new provider type and setting will be handled with existing staff.
