Summary of Revenue Changes

SB 900 provides a one-time appropriation of \$5,000,000 General Fund to the Criminal Justice Commission (CJC) to develop and administer the Organized Retail Theft Grant Program.

Summary of Public Safety Subcommittee Action

SB 900 establishes the Organized Retail Theft Grant Program for the 2023-35 biennium. This grant program is designed to assist cities, counties, the Oregon State Police, and community-based organizations with addressing and prosecuting organized retail theft. Funding supports a limited duration Program Analyst 3 position (0.75 FTE) at an estimated cost of \$186,598 to develop and implement the grant program at CJC. After this position is funded, CJC will have \$4,813,402 remaining to provide as grants to eligible entities.
