House Bill 2038 relies on \$157,600 Other Funds revenue from the Oregon Government Ethics Commission's (OGEC) assessment funding model to cover costs for upgrading the Department's electronic filing system to accept new information as outlined in the measure.

### **Summary of General Government Subcommittee Action**

House Bill 2038 will provide \$157,600 Other Funds expenditure limitation on a one-time basis to OGEC to upgrade the Department's electronic filing system. The bill adds new filing requirements when reporting certain sources of income on the statements of economic interest that public officials and candidates for public office are required to submit to OGEC on an annual basis.
