Summary of Revenue Changes

House Bill 2763 appropriates \$431,562 General Fund to the Oregon Business Development Department (OBDD) to provide the resources necessary to staff the State Public Bank Task Force established in the bill.

Summary of Transportation and Economic Development Subcommittee Action

House Bill 2763 creates a State Public Bank Task Force to study and make recommendations for establishing a state public bank. House Bill 2763 specifies the membership of the task force, which will be made of up 19 members. The task force is required to submit a final report to an appropriate interim or standing committee of the Legislative Assembly by September 1, 2024. The bill sunsets the task force on January 2, 2025. House Bill 2763 directs OBDD to provide the staff support for the task force.

The Subcommittee recommended a one-time \$431,562 General Fund appropriation and one limited duration full-time position (0.63 FTE) to provide OBDD with the resources necessary to staff the State Public Bank Task Force. Funding will be used to hire an Operations and Policy Analyst 4 to staff the task force, provide compensation for non-legislative members of the task force, contract for research, and pay for position-related and other Services and Supplies costs.
