HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2001

On page 4 of the A-engrossed bill, delete lines 40 through 45 and insert:

"SECTION 7. In addition to and not in lieu of any other appropriation, there is appropriated to the Housing and Community Services Department, for the biennium beginning July 1, 2023, out of the General Fund, the amount of \$1,202,432, to perform the duties of the department under sections 1 to 5 of this 2023 Act.

"SECTION 7a. Notwithstanding any other law limiting expenditures, the amount of \$143,969 is established for the biennium beginning July 1, 2023, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and federal funds received from charges, but excluding lottery funds and federal funds not described in this section, collected or received by the Oregon Department of Administrative Services, for the Chief Operating Office, to perform the duties of the department under sections 1 to 5 of this 2023 Act."

On page 6, delete lines 24 through 31 and insert:

"SECTION 10. The Department of Land Conservation and Development may provide technical assistance and award grants to local governments to enable them to implement the provisions of ORS 197.286 to 197.314 and to take other actions to incentivize the production of needed housing within the jurisdiction of the local government.

"SECTION 11. In addition to and not in lieu of any other appropriation, there is appropriated to the Department of Land Conservation and Development, for the biennium beginning July 1, 2023, out of the General Fund, the amount of \$3,500,000, to provide technical assistance and award grants under section 10 of this 2023 Act.

"SECTION 11a. Notwithstanding any other provision of law, the General Fund appropriation made to the Department of Land Conservation and Development by section 1 (1), chapter 438, Oregon Laws 2021, for the biennium ending June 30, 2023, for the planning program, is increased by \$100,560 to adopt rules and to work on housing production strategies and targets as provided in this 2023 Act.

"SECTION 11b. In addition to and not in lieu of any other appropriation, there is appropriated to the Department of Land Conservation and Development, for the biennium beginning July 1, 2023, out of the General Fund, the amount of \$2,675,884, to adopt rules and to work on housing production strategies and targets as provided in this 2023 Act.".

On page 37, line 27, after the period delete the rest of the line and delete line 28.

After line 36, insert:

"(6) Loan proceeds and other moneys recovered under this section shall be paid to the Housing and Community Services Department and deposited with the State Treasury for credit to the General Fund and are available for general governmental expenses.".

After line 41, insert:

"SECTION 49a. In addition to and not in lieu of any other appropriation, there is appropriated to the Housing and Community Services Department, for the biennium beginning July 1, 2023, out of the General Fund, the amount of \$248,366, to administer grants and loans made under section 47 of this 2023 Act.".

On page 38, delete lines 22 through 25 and insert:

"SECTION 53. In addition to and not in lieu of any other appropriation, there is appropriated to the Oregon Facilities Authority, for the biennium beginning July 1, 2023, out of the General Fund, the amount of \$3,613,925, for deposit into the Oregon Facilities Authority Account to be used for the purposes of section 51 of this 2023 Act.

"SECTION 53a. Notwithstanding any other law limiting expenditures, the amount of \$3,613,925 is established for the biennium beginning July 1, 2023, as the maximum limit for payment of expenses by the Oregon Facilities Authority from the Oregon Facilities Authority Account, created under ORS 289.130, for the purposes of section 51 of this 2023 Act.

"SECTION 53b. Notwithstanding any other law limiting expenditures, the amount of \$263,925 is established for the biennium beginning July 1, 2023, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the State Treasurer, for the purpose of oversight and administration of financing by the Oregon Facilities Authority under section 51 of this 2023 Act.".

On page 48, after line 35, insert:

"SECTION 69a. In addition to and not in lieu of any other appropriation, there is appropriated to the State Department of Agriculture, for the biennium beginning July 1, 2023, out of the General Fund, the amount of \$524,762, to develop and administer the grant program under section 67 of this 2023 Act.".
