## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies provisions relating to reproductive health rights.

Modifies provisions relating to access to reproductive health care and gender-affirming treatment.

Modifies provisions relating to protections for providers of and individuals receiving reproductive and gender-affirming health care services.

Creates crime of interfering with a health care facility. Punishes by maximum of 364 days' imprisonment, \$6,250 fine, or both. Creates right of action for person or health care provider aggrieved by interference with health care facility.

Makes statutory change to achieve gender neutral language with respect to unlawful employment discrimination because of sex.

Declares public policy regarding interstate actions arising out of reproductive health care and gender-affirming treatment. Prohibits public body from participating in interstate investigation or proceeding involving reproductive health care and gender-affirming treatment. Creates exceptions. Prohibits clerk of court from issuing subpoena if foreign subpoena relates to reproductive health care or gender-affirming treatment. Declares that Oregon law governs certain actions arising out of reproductive health care or gender-affirming treatment provided or received in this state.

Repeals criminal provisions relating to concealing birth.

**Appropriates moneys from General Fund to Higher Education Coordinating Commission for allocation to Office of Rural Health, for purposes of providing grants through rural qualified health center pilot project.**

**Appropriates moneys from General Fund to Oregon Health Authority for specified expenses.**

Declares emergency, effective on passage.

## A BILL FOR AN ACT

Relating to health; creating new provisions; amending ORS 15.430, 109.640, 109.650, 161.005, 192.345, 192.820, 192.822, 192.826, 243.144, 243.877, 418.307, 435.215, 435.225, 436.225, 659.880, 659A.029, 675.070, 675.540, 675.745, 676.177, 677.190, 677.225, 677.320, 678.111, 685.110, 689.405 and 743A.067 and section 10, chapter 45, Oregon Laws 2022; repealing ORS 109.610, 109.660, 167.820, 435.200 and 435.435; and declaring an emergency.

**Be It Enacted by the People of the State of Oregon:**

## REPRODUCTIVE HEALTH RIGHTS

**SECTION 1. ORS 435.205 to 435.235 and 659.880 are added to and made a part of sections 2 to 4 of this 2023 Act.**

**SECTION 2. As used in sections 2 to 4 of this 2023 Act:**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (1) “Contraception” includes:

2 (a) Steroidal, chemical, physical or barrier, natural or permanent methods for preventing  
3 the union of an ovum with the spermatozoon, or for preventing the subsequent implantation  
4 of the fertilized ovum in the uterus;

5 (b) All postcoital methods, drugs or devices to prevent pregnancy; and

6 (c) Any other process, device or method to prevent pregnancy.

7 (2) “Public body” means a public body as defined in ORS 174.109 and the Oregon Health  
8 and Science University.

9 (3) “Reproductive health” means reproductive processes, functions and systems at all  
10 stages of life.

11 (4) “Reproductive health care” includes family planning and contraception, pregnancy  
12 termination services, prenatal, postnatal and delivery care, miscarriage management,  
13 fertility care, sterilization services, treatments for sexually transmitted infections and re-  
14 productive cancers and any other health care and medical services related to reproductive  
15 health.

16 **SECTION 3.** Every individual has a fundamental right to make decisions about the  
17 individual’s reproductive health, including the right to make decisions about the individual’s  
18 reproductive health care, to use or refuse contraception, to continue the individual’s preg-  
19 nancy and give birth or to terminate the individual’s pregnancy.

20 **SECTION 4.** (1) Any person may bring an action against a public body, or an officer,  
21 employee or agent of a public body, for injunctive relief to enforce the requirements of  
22 sections 2 to 4 of this 2023 Act.

23 (2) The court may award reasonable attorney fees and costs to a prevailing plaintiff in  
24 an action under this section.

25 (3) ORS 30.260 to 30.300 apply to an action under this section.

26 **SECTION 5.** ORS 659.880 is amended to read:

27 659.880. (1) A public body [*as defined in ORS 174.109*] or, except as provided in ORS 435.225,  
28 an officer, employee or agent of a public body may not:

29 [(1)] (a) Deprive a consenting individual of the choice of [*terminating the individual’s*  
30 *pregnancy*] **exercising the individual’s reproductive health rights under section 3 of this 2023**  
31 **Act;**

32 [(2)] (b) Interfere with or restrict, in the regulation [*or provision*] of benefits, facilities, services  
33 or information, the choice of a consenting individual to [*terminate the individual’s pregnancy*] **exer-**  
34 **cise the individual’s reproductive health rights under section 3 of this 2023 Act;**

35 [(3)] (c) Prohibit a health care provider, who is acting within the scope of the health care  
36 provider’s license, from [*terminating or assisting in the termination of a patient’s pregnancy*] **provid-**  
37 **ing reproductive health care information and services to a consenting individual;** [*or*]

38 [(4)] (d) Interfere with or restrict, in the regulation [*or provision*] of benefits, facilities, services  
39 or information, the choice of a health care provider, who is acting within the scope of the health  
40 care provider’s license, [*to terminate or assist in the termination of a patient’s pregnancy.*] **to provide**  
41 **reproductive health care information and services to a consenting individual;**

42 (e) Subject an individual to criminal or civil liability or penalty, or otherwise deprive the  
43 individual of any rights, based on the individual’s actions or omissions in exercising the  
44 individual’s reproductive health rights under section 3 of this 2023 Act, including any action  
45 or omission affecting an actual, potential or alleged pregnancy outcome; or

1 (f) Subject any person to criminal or civil liability or penalty, or otherwise deprive any  
2 person of the person's rights, based solely on the person's actions in the provision of aid,  
3 assistance, resources or support to an individual in the exercise of the individual's repro-  
4 ductive health rights, provided that the person's actions do not otherwise violate the laws  
5 of this state.

6 (2)(a) Nothing in this section is intended to prevent the application of laws, rules, ordi-  
7 nances or taxes that affect the method or manner of sales or distribution of contraceptive  
8 devices or the provision of reproductive health care, provided that the laws, rules, ordinances  
9 or taxes are designed to promote public health and safety and do not unreasonably burden  
10 public access to contraception or other reproductive health care.

11 (b) Nothing in this section requires a public body to provide or pay for reproductive  
12 health care.

13 **SECTION 6.** ORS 435.215 is amended to read:

14 435.215. *[The refusal of any person to accept family planning and birth control services shall in*  
15 *no way affect the right of such person to receive public assistance, medical assistance, as defined in*  
16 *ORS 414.025, or any other public benefit and every person to whom such services are offered shall be*  
17 *so advised initially both orally and in writing. Employees engaged in the administration of ORS*  
18 *435.205 to 435.235 shall recognize that the right to make decisions concerning family planning and*  
19 *birth control is a fundamental personal right of the individual and nothing in ORS 435.205 to 435.235*  
20 *shall in any way abridge such individual right, nor shall any individual be required to state the reason*  
21 *for refusing the offer of family planning and birth control services.]*

22 (1) **An individual's acceptance or refusal to accept reproductive health care information**  
23 **and services may not:**

24 (a) **Be grounds for the loss of any privilege or immunity to which the individual is oth-**  
25 **erwise entitled; or**

26 (b) **Affect the individual's right to receive public assistance, medical assistance, as de-**  
27 **defined in ORS 414.025, or any other public benefit.**

28 (2) **An officer, employee or agent of a public body who is engaged in the provision of re-**  
29 **productive health care information and services:**

30 (a) **Shall advise every individual to whom the officer, employee or agent of a public body**  
31 **provides reproductive health care information and services, both orally and in writing, of the**  
32 **rights described under subsection (1) of this section;**

33 (b) **Shall recognize that the right to make decisions concerning reproductive health care**  
34 **is a fundamental personal right of the individual and that nothing in ORS 435.475 or 435.485**  
35 **or sections 2 to 4 of this 2023 Act or ORS chapter 436 in any way abridges that right; and**

36 (c) **May not require any individual to state the reason for accepting or refusing the offer**  
37 **of reproductive health care information and services.**

38 **SECTION 7.** ORS 435.225 is amended to read:

39 435.225. (1) *[Any employee of the Oregon Health Authority]* **An officer, employee or agent of**  
40 **a public body** may refuse to accept the duty of offering *[family planning and birth control]* **repro-**  
41 **ductive health care information and** services to the extent that such duty is contrary to the  
42 personal or religious beliefs of the *[employee]* **officer, employee or agent.** However, such  
43 *[employee]* **officer, employee or agent** shall notify the immediate supervisor in writing of such re-  
44 fusals in order that arrangements may be made for eligible *[persons]* **individuals** to obtain such in-  
45 formation and services from another **officer, employee or agent.**

1       **(2) If an officer, employee or agent of a public body refuses to provide reproductive health**  
2 **care information and services as provided in subsection (1) of this section, the public body**  
3 **shall immediately make arrangements for an individual to receive reproductive health care**  
4 **information and services from another officer, employee or agent of the public body.**

5       **(3) [Such refusal shall] The refusal of an officer, employee or agent of a public body to**  
6 **provide reproductive health care information and services under subsection (1) of this sec-**  
7 **tion may not be grounds for any disciplinary action, for dismissal, for any interdepartmental**  
8 **transfer, for any other discrimination in employment, or for suspension from employment, or for any**  
9 **loss in pay or other benefits.**

10       **SECTION 8.** ORS 109.640, as amended by section 14, chapter 349, Oregon Laws 2021, is  
11 amended to read:

12       109.640. (1) **As used in this section, “reproductive health care” has the meaning given that**  
13 **term in section 2 of this 2023 Act, except that “reproductive health care” does not include**  
14 **the voluntary sterilization of a minor under 15 years of age.**

15       **[(1)] (2) Notwithstanding subsection (3) of this section, a minor of any age may give con-**  
16 **sent, without the consent of a parent or guardian of the minor, to receive reproductive**  
17 **health care information and services from a physician, physician assistant licensed under ORS**  
18 **677.505 to 677.525, nurse practitioner licensed under ORS 678.375 to 678.390, pharmacist licensed**  
19 **under ORS chapter 689 or naturopathic physician licensed under ORS chapter 685 [may provide**  
20 **birth control information and services to any person without regard to the age of the person], who is**  
21 **acting within the provider’s scope of practice.**

22       **[(2)] (3) A minor 15 years of age or older may give consent, without the consent of a parent or**  
23 **guardian of the minor, to:**

24       (a) Hospital care, medical or surgical diagnosis or treatment by a physician licensed by the  
25 Oregon Medical Board or a naturopathic physician licensed under ORS chapter 685, and dental or  
26 surgical diagnosis or treatment by a dentist licensed by the Oregon Board of Dentistry, *except as*  
27 *provided by ORS 109.660].*

28       (b) Diagnosis or treatment by a physician assistant who is licensed under ORS 677.505 to 677.525  
29 and who is acting pursuant to a collaboration agreement as defined in ORS 677.495.

30       (c) Diagnosis and treatment by a nurse practitioner who is licensed by the Oregon State Board  
31 of Nursing under ORS 678.375 and who is acting within the scope of practice for a nurse practi-  
32 tioner.

33       (d) Except when the minor is obtaining contact lenses for the first time, diagnosis and treatment  
34 by an optometrist who is licensed by the Oregon Board of Optometry under ORS 683.010 to 683.340  
35 and who is acting within the scope of practice for an optometrist.

36       **SECTION 9.** ORS 109.650 is amended to read:

37       109.650. (1) **If a physician, physician assistant, nurse practitioner, pharmacist or**  
38 **naturopathic physician provides reproductive health care information or services to a minor**  
39 **as described in ORS 109.640 (2), the physician, physician assistant, nurse practitioner,**  
40 **pharmacist or naturopathic physician may not disclose to the minor’s parent or legal**  
41 **guardian information regarding the information and services provided unless:**

42       **(a) The minor has authorized the disclosure in writing;**

43       **(b) The disclosure is authorized under ORS 192.567; or**

44       **(c) The disclosure is otherwise required by federal law.**

45       **(2) If a hospital or a physician, physician assistant, nurse practitioner, naturopathic physician,**

1 dentist or optometrist **provides care, diagnosis or treatment to a minor as** described in ORS  
2 109.640 (3), **the hospital, physician, physician assistant, nurse practitioner, naturopathic**  
3 **physician, dentist or optometrist** may advise [a] **the minor's** parent or legal guardian [of a  
4 *minor*] of the care, diagnosis or treatment [of] **provided to** the minor or the need for any treatment  
5 of the minor, without the consent of the minor, and is not liable for advising the parent or legal  
6 guardian without the consent of the minor.

7 **SECTION 10.** ORS 418.307 is amended to read:

8 418.307. (1) A physician licensed by the Oregon Medical Board, a naturopathic physician li-  
9 censed under ORS chapter 685, a dentist licensed by the Oregon Board of Dentistry or a hospital  
10 licensed by the Department of Human Services is authorized to treat a child who is ward of the  
11 court or is a dependent or delinquent child in accord with the best medical judgment of the physi-  
12 cian, naturopathic physician, dentist or responsible official of the hospital and without consent if:

13 (a) Because of the general state of the child's health or any particular condition, the physician,  
14 naturopathic physician, dentist or responsible official of the hospital determines that in the medical  
15 judgment of the physician, naturopathic physician, dentist or responsible official prompt action is  
16 reasonably necessary to avoid unnecessary suffering or discomfort or to effect a more expedient or  
17 effective cure; and

18 (b) It is impossible or highly impractical to obtain consent for treating the child from the  
19 child-caring agency, the child's parent or the child's legal guardian.

20 (2) No charge of assault or battery shall be made against a physician, naturopathic physician,  
21 dentist or hospital official or employee who provides medical treatment pursuant to subsection (1)  
22 of this section.

23 (3) A minor child described in subsection (1) of this section [*who is 15 years of age or older*] may  
24 consent to medical treatment [*pursuant to*] **as provided in** ORS 109.640.

25 **SECTION 11.** ORS 436.225 is amended to read:

26 436.225. (1) In obtaining informed consent for sterilization a physician, physician assistant or  
27 nurse practitioner must offer to answer any questions the individual to be sterilized may have con-  
28 cerning the proposed procedure, and must provide orally all of the following information or advice  
29 to the individual to be sterilized:

30 (a) Advice that the individual is free to withhold or withdraw consent to the procedure at any  
31 time before the sterilization without affecting the right to future care or treatment;

32 (b) A description of available alternative methods of family planning and birth control;

33 (c) Advice that the sterilization procedure is considered to be irreversible;

34 (d) A thorough explanation of the specific sterilization procedure to be performed;

35 (e) A full description of the discomforts and risks that may accompany or follow the performing  
36 of the procedure, including an explanation of the type and possible effects of any anesthetic to be  
37 used; and

38 (f) A full description of the benefits or advantages that may be expected as a result of the  
39 sterilization.

40 (2) A natural parent, or a legal guardian or conservator of a minor child or protected person  
41 appointed under ORS chapter 125, may not give substitute consent for sterilization.

42 (3) Whenever any physician, physician assistant or nurse practitioner has reason to believe an  
43 individual 15 years of age or older is unable to give informed consent, no sterilization shall be per-  
44 formed until it is determined by a circuit court that the individual involved is able to and has given  
45 informed consent. Whenever the court determines, under the provisions of this chapter, that a

1 person lacks the ability to give informed consent, the court shall permit sterilization only if the  
2 person is 18 years of age or older and only upon showing that such operation, treatment or proce-  
3 dure is in the best interest of the individual.

4 (4) **Notwithstanding section 3 of this 2023 Act**, informed consent may not be obtained while  
5 the individual to be sterilized is:

6 (a) In labor or childbirth;

7 (b) Seeking to obtain or obtaining an abortion; or

8 (c) Under the influence of alcohol or other substances that affect the individual's state of  
9 awareness.

10 **SECTION 12.** ORS 743A.067, as amended by section 12, chapter 45, Oregon Laws 2022, is  
11 amended to read:

12 743A.067. (1) As used in this section:

13 (a) "Contraceptives" means health care services, drugs, devices, products or medical procedures  
14 to prevent a pregnancy.

15 (b) "Enrollee" means an insured individual and the individual's spouse, domestic partner and  
16 dependents who are beneficiaries under the insured individual's health benefit plan.

17 (c) "Health benefit plan" has the meaning given that term in ORS 743B.005, excluding Medicare  
18 Advantage Plans and including health benefit plans offering pharmacy benefits administered by a  
19 third party administrator or pharmacy benefit manager.

20 (d) "Prior authorization" has the meaning given that term in ORS 743B.001.

21 (e) "Religious employer" has the meaning given that term in ORS 743A.066.

22 (f) "Utilization review" has the meaning given that term in ORS 743B.001.

23 (2) A health benefit plan offered in this state must provide coverage for all of the following  
24 services, drugs, devices, products and procedures:

25 (a) Well-woman care prescribed by the Department of Consumer and Business Services by rule  
26 consistent with guidelines published by the United States Health Resources and Services Adminis-  
27 tration.

28 (b) Counseling for sexually transmitted infections, including but not limited to human  
29 immunodeficiency virus and acquired immune deficiency syndrome.

30 (c) Screening for:

31 (A) Chlamydia;

32 (B) Gonorrhea;

33 (C) Hepatitis B;

34 (D) Hepatitis C;

35 (E) Human immunodeficiency virus and acquired immune deficiency syndrome;

36 (F) Human papillomavirus;

37 (G) Syphilis;

38 (H) Anemia;

39 (I) Urinary tract infection;

40 (J) Pregnancy;

41 (K) Rh incompatibility;

42 (L) Gestational diabetes;

43 (M) Osteoporosis;

44 (N) Breast cancer; and

45 (O) Cervical cancer.

1 (d) Screening to determine whether counseling related to the BRCA1 or BRCA2 genetic  
2 mutations is indicated and counseling related to the BRCA1 or BRCA2 genetic mutations if indi-  
3 cated.

4 (e) Screening and appropriate counseling or interventions for:

5 (A) Tobacco use; and

6 (B) Domestic and interpersonal violence.

7 (f) Folic acid supplements.

8 (g) Abortion.

9 (h) Breastfeeding comprehensive support, counseling and supplies.

10 (i) Breast cancer chemoprevention counseling.

11 (j) Any contraceptive drug, device or product approved by the United States Food and Drug  
12 Administration, subject to all of the following:

13 (A) If there is a therapeutic equivalent of a contraceptive drug, device or product approved by  
14 the United States Food and Drug Administration, a health benefit plan may provide coverage for  
15 either the requested contraceptive drug, device or product or for one or more therapeutic equiv-  
16 alents of the requested drug, device or product.

17 (B) If a contraceptive drug, device or product covered by the health benefit plan is deemed  
18 medically inadvisable by the enrollee's provider, the health benefit plan must cover an alternative  
19 contraceptive drug, device or product prescribed by the provider.

20 (C) A health benefit plan must pay pharmacy claims for reimbursement of all contraceptive  
21 drugs available for over-the-counter sale that are approved by the United States Food and Drug  
22 Administration.

23 (D) A health benefit plan may not infringe upon an enrollee's choice of contraceptive drug, de-  
24 vice or product and may not require prior authorization, step therapy or other utilization review  
25 techniques for medically appropriate covered contraceptive drugs, devices or other products ap-  
26 proved by the United States Food and Drug Administration.

27 (k) Voluntary sterilization.

28 (L) As a single claim or combined with other claims for covered services provided on the same  
29 day:

30 (A) Patient education and counseling on contraception and sterilization.

31 (B) Services related to sterilization or the administration and monitoring of contraceptive drugs,  
32 devices and products, including but not limited to:

33 (i) Management of side effects;

34 (ii) Counseling for continued adherence to a prescribed regimen;

35 (iii) Device insertion and removal; and

36 (iv) Provision of alternative contraceptive drugs, devices or products deemed medically appro-  
37 priate in the judgment of the enrollee's provider.

38 (m) Any additional preventive services for women that must be covered without cost sharing  
39 under 42 U.S.C. 300gg-13, as identified by the United States Preventive Services Task Force or the  
40 Health Resources and Services Administration of the United States Department of Health and Hu-  
41 man Services as of January 1, 2017.

42 (3) A health benefit plan may not impose on an enrollee a deductible, coinsurance, copayment  
43 or any other cost-sharing requirement on the coverage required by this section. A health care pro-  
44 vider shall be reimbursed for providing the services described in this section without any deduction  
45 for coinsurance, copayments or any other cost-sharing amounts.

1 (4) Except as authorized under this section, a health benefit plan may not impose any re-  
2 strictions or delays on the coverage required by this section.

3 (5) This section does not exclude coverage for contraceptive drugs, devices or products pre-  
4 scribed by a provider, acting within the provider's scope of practice, for:

5 (a) Reasons other than contraceptive purposes, such as decreasing the risk of ovarian cancer  
6 or eliminating symptoms of menopause; or

7 (b) Contraception that is necessary to preserve the life or health of an enrollee.

8 (6) This section does not limit the authority of the Department of Consumer and Business Ser-  
9 vices to ensure compliance with ORS 743A.063 and 743A.066.

10 (7) This section does not require a health benefit plan to cover:

11 (a) Experimental or investigational treatments;

12 (b) Clinical trials or demonstration projects, except as provided in ORS 743A.192;

13 (c) Treatments that do not conform to acceptable and customary standards of medical practice;

14 (d) Treatments for which there is insufficient data to determine efficacy; or

15 (e) Abortion if the insurer offering the health benefit plan:

16 **(A) Has a certificate of authority to transact insurance in this state issued by the De-**  
17 **partment of Consumer and Business Services; and**

18 **(B) Excluded coverage for abortion in all of its individual, small employer and large employer**  
19 **group plans during the 2017 plan year.**

20 (8) If services, drugs, devices, products or procedures required by this section are provided by  
21 an out-of-network provider, the health benefit plan must cover the services, drugs, devices, products  
22 or procedures without imposing any cost-sharing requirement on the enrollee if:

23 (a) There is no in-network provider to furnish the service, drug, device, product or procedure  
24 that is geographically accessible or accessible in a reasonable amount of time, as defined by the  
25 Department of Consumer and Business Services by rule consistent with the requirements for pro-  
26 vider networks in ORS 743B.505; or

27 (b) An in-network provider is unable or unwilling to provide the service in a timely manner.

28 (9) An insurer may offer to a religious employer a health benefit plan that does not include  
29 coverage for contraceptives or abortion procedures that are contrary to the religious employer's  
30 religious tenets only if the insurer notifies in writing all employees who may be enrolled in the  
31 health benefit plan of the contraceptives and procedures the employer refuses to cover for religious  
32 reasons.

33 (10) If the Department of Consumer and Business Services concludes that enforcement of this  
34 section may adversely affect the allocation of federal funds to this state, the department may grant  
35 an exemption to the requirements but only to the minimum extent necessary to ensure the continued  
36 receipt of federal funds.

37 (11) An insurer that is subject to this section shall make readily accessible to enrollees and  
38 potential enrollees, in a consumer-friendly format, information about the coverage of contraceptives  
39 by each health benefit plan and the coverage of other services, drugs, devices, products and proce-  
40 dures described in this section. The insurer must provide the information:

41 (a) On the insurer's website; and

42 (b) In writing upon request by an enrollee or potential enrollee.

43 (12) This section does not prohibit an insurer from using reasonable medical management tech-  
44 niques to determine the frequency, method, treatment or setting for the coverage of services, drugs,  
45 devices, products and procedures described in subsection (2) of this section, other than coverage



1 required by subsection (2)(g) and (j) of this section, if the techniques:

- 2 (a) Are consistent with the coverage requirements of subsection (2) of this section; and
  - 3 (b) Do not result in the wholesale or indiscriminate denial of coverage for a service.
- 4 (13) This section is exempt from ORS 743A.001.

9 **SECTION 13.** As used in sections 13 to 17 of this 2023 Act:

10 (1) “Emergency contraception” has the meaning given that term in ORS 435.252.

11 (2) “Medication abortion” means abortion provided by medication techniques.

12 (3) “Public institution of higher education” means:

- 13 (a) A community college operated under ORS chapter 341;
- 14 (b) A public university listed in ORS 352.002; or
- 15 (c) The Oregon Health and Science University.

16 (4) “Student health center” means a clinic or health center operated by a public institu-  
17 tion of higher education that provides health care services to students.

18 **SECTION 14.** Student health centers in this state shall provide enrolled students with  
19 access to emergency contraception and medication abortion.

20 **SECTION 15.** (1) No later than January 1 of each year, the Oregon Health Authority shall  
21 provide guidance to each public institution of higher education regarding the required con-  
22 tents of the plans described in subsection (2) of this section, taking into consideration the  
23 varied capacities of the institutions to provide services, including an institution’s ability to  
24 directly provide medication abortions through a student health center or, if the institution  
25 does not operate a student health center, by providing information to students about how to  
26 obtain a medication abortion off-campus. In developing the guidance, the authority shall  
27 consider, at a minimum:

28 (a) Whether the institution has an operational student health center on campus;

29 (b) The institution’s proximity to a hospital, clinic or other facility which provides  
30 medication abortions;

31 (c) The availability, convenience and cost of public transportation between the institution  
32 and the closest facility that provides medication abortions; and

33 (d) Whether the institution employs health care workers on campus.

34 (2) No later than April 1 of each year, each public institution of higher education shall  
35 submit a plan to the authority. The plan must demonstrate how the institution will ensure  
36 its students have access to medication abortions, including having in place equipment, pro-  
37 tocols, patient educational materials, informational websites and training for staff.

38 (3) No later than July 1 of each year, the authority shall determine whether each  
39 institution’s plan submitted under subsection (2) of this section is adequate in proportion to  
40 the institution’s capacity to provide services and, if the authority determines that an  
41 institution’s plan is inadequate, shall provide further guidance to the institution with reme-  
42 dial measures for developing an adequate plan.

43 (4) No later than September 15 of each year, the authority shall submit a report in the  
44 manner provided by ORS 192.245 to the interim committees of the Legislative Assembly re-  
45 lated to health care. The report must include, at a minimum, the following information for

1 each reporting period:

2 (a) A list of each public institution of higher education that submitted a plan required  
3 under this section to the authority that the authority found adequate, a list of each public  
4 institution of higher education that is actively developing a remedial plan and a list of each  
5 public institution of higher education that has not submitted an adequate plan to the au-  
6 thority.

7 (b) The number of emergency contraception medications or devices dispensed and  
8 medication abortions prescribed by student health centers, disaggregated, to the extent pos-  
9 sible, by student health center.

10 (c) The total amount of funds distributed by the authority through the Student Health  
11 Center Reproductive Health Grant Program to each public institution of higher education  
12 and its respective student health center under section 17 of this 2023 Act.

13 (d) The total amount of funds expended on the provision of emergency contraception and  
14 medication abortions and the sources of those funds, disaggregated by function and, to the  
15 extent possible, by student health center.

16 (5) The collection of data and preparation of reports required under this section shall be  
17 conducted in accordance with state and federal privacy law.

18 **SECTION 16.** (1) There is established in the State Treasury, separate and distinct from  
19 the General Fund, the Student Health Center Reproductive Health Grant Fund. Interest  
20 earned by the fund shall be credited to the fund. The fund consists of moneys appropriated,  
21 allocated, deposited or transferred to the fund by the Legislative Assembly or otherwise and  
22 of any donations or grants received for the purpose of the fund. Moneys in the fund are  
23 continuously appropriated to the Oregon Health Authority for the purpose of awarding  
24 grants as provided under section 17 of this 2023 Act.

25 (2) Moneys in the fund may be used to pay the costs of the authority, both direct and  
26 indirect, associated with administration of the Student Health Center Reproductive Health  
27 Grant Program under section 17 of this 2023 Act, including the costs of hiring staff and  
28 maintaining a system of financial reporting on all aspects of the grant program.

29 **SECTION 17.** (1) The Oregon Health Authority shall administer the Student Health Cen-  
30 ter Reproductive Health Grant Program to provide grants to a public institution of higher  
31 education in this state to comply with the requirements of section 15 of this 2023 Act. The  
32 authority shall by rule establish the process by which a public institution of higher education  
33 may apply for grant monies and eligibility criteria for the grant program.

34 (2) At a minimum, grants provided under this section may be used to:

35 (a) Purchase equipment used to provide medication abortions;

36 (b) Fund necessary facility and security upgrades;

37 (c) Pay costs necessary to enable the student health center to deliver telehealth services;

38 (d) Pay to train staff to provide medication abortions;

39 (e) Reimburse staff costs and offset clinical revenue while staff are in trainings; and

40 (f) Purchase billing specialist consultation.

41 (3) The authority may adopt any rules necessary for the administration of the grant  
42 program.

43 **SECTION 18.** (1) The guidance described in section 15 (1) of this 2023 Act is first due  
44 January 1, 2025, and every January 1 thereafter.

45 (2) The plans described in section 15 (2) of this 2023 Act are first due April 1, 2025, and

1 every April 1 thereafter.

2 (3) The determinations and guidance described in section 15 (3) of this 2023 Act are first  
3 due July 1, 2025, and every July 1 thereafter.

4 (4) The report described in section 15 (4) of this 2023 Act is first due September 15, 2025,  
5 and every September 15 thereafter.

6  
7 (Gender-Affirming Treatment)  
8

9 **SECTION 19.** Section 20 of this 2023 Act is added to and made a part of the Insurance  
10 Code.

11 **SECTION 20.** (1) As used in this section:

12 (a) “Carrier” has the meaning given that term in ORS 743B.005.

13 (b) “Gender-affirming treatment” means a procedure, service, drug, device or product  
14 that a physical or behavioral health care provider prescribes to treat an individual for  
15 incongruence between the individual’s gender identity and the individual’s sex assignment  
16 at birth.

17 (c) “Health benefit plan” has the meaning given that term in ORS 743B.005.

18 (2) A carrier offering a health benefit plan in this state may not:

19 (a) Deny or limit coverage under the plan for gender-affirming treatment that is:

20 (A) Medically necessary as determined by the physical or behavioral health care provider  
21 who prescribes the treatment; and

22 (B) Prescribed in accordance with accepted standards of care.

23 (b) Apply categorical cosmetic or blanket exclusions to medically necessary gender-  
24 affirming treatment.

25 (c) Exclude as a cosmetic service a medically necessary procedure prescribed by a phys-  
26 ical or behavioral health care provider as gender-affirming treatment, including but not  
27 limited to:

28 (A) Tracheal shave;

29 (B) Hair electrolysis;

30 (C) Facial feminization surgery or other facial gender-affirming treatment;

31 (D) Revisions to prior forms of gender-affirming treatment; and

32 (E) Any combination of gender-affirming treatment procedures.

33 (d) Issue an adverse benefit determination denying or limiting access to gender-affirming  
34 treatment unless a physical or behavioral health care provider with experience prescribing  
35 or delivering gender-affirming treatment has first reviewed and approved the denial of or the  
36 limitation on access to the treatment.

37 (3) A carrier described in subsection (2) of this section must:

38 (a) Satisfy any network adequacy standards under ORS 743B.505 related to gender-  
39 affirming treatment providers; and

40 (b)(A) Contract with a network of gender-affirming treatment providers that is sufficient  
41 in numbers and geographic locations to ensure that gender-affirming treatment services are  
42 accessible to all enrollees without unreasonable delay; or

43 (B) Ensure that all enrollees have geographical access without unreasonable delay to  
44 out-of-network gender-affirming treatment services with cost-sharing or other out-of-pocket  
45 costs for the services no greater than the cost-sharing or other out-of-pocket costs for the

1 services when furnished by an in-network provider.

2 (4) The Department of Consumer and Business Services shall:

3 (a) Evaluate compliance with this section in each examination or analysis of the market  
4 conduct of a carrier under ORS 731.300; and

5 (b) Adopt rules to implement the provisions of this section.

6 (5) This section is exempt from ORS 743A.001.

7 **SECTION 21.** The Department of Consumer and Business Services shall conduct a tar-  
8 geted market conduct examination of all carriers that are subject to the requirements of  
9 section 20 of this 2023 Act to ensure compliance with section 20 of this 2023 Act. The exam-  
10 inations must be completed no later than January 2, 2027.

11 **SECTION 22.** No later than December 31, 2026, the Department of Consumer and Busi-  
12 ness Services shall report to the interim committees of the Legislative Assembly related to  
13 health, in the manner provided in ORS 192.245, on the implementation of section 20 of this  
14 2023 Act.

15 **SECTION 23.** Section 24 of this 2023 Act is added to and made a part of ORS chapter 414.

16 **SECTION 24.** (1) As used in this section, “gender-affirming treatment” means a proce-  
17 dure, service, drug, device or product that a physical or behavioral health care provider  
18 prescribes to treat an individual for incongruence between the individual’s gender identity  
19 and the individual’s sex assignment at birth.

20 (2) Notwithstanding ORS 414.065 and 414.690, medical assistance provided to a member  
21 of a coordinated care organization or a medical assistance recipient who is not enrolled in a  
22 coordinated care organization shall include gender-affirming treatment.

23 (3) The Oregon Health Authority or a coordinated care organization may not:

24 (a) Deny or limit gender-affirming treatment that is:

25 (A) Medically necessary as determined by the physical or behavioral health care provider  
26 who prescribes the treatment; and

27 (B) Prescribed in accordance with accepted standards of care.

28 (b) Deny as a cosmetic service a medically necessary procedure prescribed by a physical  
29 or behavioral health care provider as gender-affirming treatment, including but not limited  
30 to:

31 (A) Tracheal shave;

32 (B) Hair electrolysis;

33 (C) Facial feminization surgery or other facial gender-affirming treatment;

34 (D) Revisions to prior forms of gender-affirming treatment; and

35 (E) Any combination of gender-affirming treatment procedures.

36 (c) Deny or limit gender-affirming treatment unless a physical or behavioral health care  
37 provider with experience prescribing or delivering gender-affirming treatment has first re-  
38 viewed and approved the denial of or the limitation on the treatment.

39 (4) A coordinated care organization must:

40 (a) Contract with a network of gender-affirming treatment providers that is sufficient in  
41 numbers and geographic locations to meet the network adequacy standards prescribed by  
42 ORS 414.609 (1); and

43 (b)(A) Ensure that gender-affirming treatment services are accessible to all of the coor-  
44 dinated care organization’s members without unreasonable delay; or

45 (B) Ensure that all members have geographical access to non-contracting providers of

1 **gender-affirming treatment services without unreasonable delay.**

2 **(5) The authority shall monitor coordinated care organization compliance with the re-**  
3 **quirements of this section and may adopt rules necessary to carry out the provisions of this**  
4 **section.**

33  
34 **SECTION 27.** Section 28 of this 2023 Act is added to and made a part of ORS chapter 414.

35 **SECTION 28.** (1) As used in this section, "prescription contraceptive" means a drug or  
36 device that requires a prescription and is approved by the United States Food and Drug Ad-  
37 ministration to prevent pregnancy.

38 **(2) In determining the extent of prescription drugs to be provided in medical assistance,**  
39 **in accordance with ORS 414.065, the Oregon Health Authority shall ensure payment for a**  
40 **dispensing of prescription contraceptives, to an individual enrolled in the medical assistance**  
41 **program, that is sufficient to last for a period of 12 calendar months.**

42  
43 **(Federal Qualified Health Center Expansion Pilot Project)**

44  
45 **SECTION 29.** (1) The Office of Rural Health shall administer a program to provide grants

1 to two federally qualified health centers located in rural and medically underserved areas of  
2 this state to each operate a pilot project providing expanded reproductive health services to  
3 individuals living in a geographical area of this state where there is limited access to repro-  
4 ductive health care.

5 (2) The grants must include funding for technical assistance in the design and adminis-  
6 tration of each pilot project and be flexible enough to permit the federally qualified health  
7 centers to use mobile health units or other temporary or transitional structures. Grantees

18 **SECTION 30.** Section 10, chapter 45, Oregon Laws 2022, is amended to read:

32 **PROTECTIONS FOR PROVIDERS AND INDIVIDUALS**

33 (Malpractice insurance and licensing)

34  
35 **SECTION 31.** An insurer that provides malpractice insurance for a health care provider  
36 for care provided in this state may not take any adverse action, including but not limited to  
37 sanctions, fines, penalties, rate increases or denial or revocation of coverage, against a  
38 health care provider authorized to provide care in this state if the adverse action is:

39 (1) Based solely on the health care provider's providing, authorizing, recommending,  
40 aiding, assisting, referring for or otherwise participating in a reproductive or gender-  
41 affirming health care service that is lawful in this state but unlawful in the jurisdiction in  
42 which the health care provider provided the service, so long as the service provided was  
43 performed in accordance with the standard of care applicable to the service; or

44 (2) A result of an adverse action taken against the health care provider's license issued  
45 by another state that resulted solely from the health care provider's providing, authorizing,

1 **recommending, aiding, assisting, referring for or otherwise participating in a reproductive**  
2 **or gender-affirming health care service that is lawful in this state but provided to a resident**  
3 **of a jurisdiction in which the service is unlawful or is unlawful in the jurisdiction in which**  
4 **the health care provider provided the service, so long as the service provided was performed**  
5 **in accordance with the standard of care applicable to the service.**

6 **SECTION 31a.** ORS 675.070 is amended to read:

7 675.070. (1) If any of the grounds enumerated in subsection (2) of this section exist, the Oregon  
8 Board of Psychology may impose any of the following sanctions:

9 (a) Deny a license to an applicant;

10 (b) Refuse to renew the license of a psychologist or psychologist associate;

26 chology, including but not limited to:

27 (A) Conduct or practice contrary to recognized standard of ethics of the psychological profession  
28 or conduct or practice that constitutes a danger to the health or safety of a patient or the public,  
29 or conduct, practice or a condition that adversely affects a psychologist or psychologist associate's  
30 ability to practice psychology safely and skillfully.

31 (B) Willful ordering or performing of unnecessary tests or studies, administration of unnecessary  
32 treatment, failure to obtain consultations or perform referrals when failing to do so is not consistent  
33 with the standard of care, or otherwise ordering or performing a psychological service or treatment  
34 that is contrary to recognized standards of practice of the psychological profession;

35 (e) Has practiced or attempted to practice medicine without being licensed to do so;

36 (f) Has obtained or attempted to obtain a license under ORS 675.010 to 675.150 by fraud or ma-  
37 terial misrepresentation;

38 (g) Has impersonated a licensed psychologist or psychologist associate or has allowed another  
39 person to use the license of the psychologist;

40 (h) Has violated a provision of ORS 675.010 to 675.150 or 675.850 or a provision of the code of

42 (i) Has obtained a fee or payment from a patient or third party payer through fraud or inten-  
43 tional misrepresentation; or

44 (j) Notwithstanding ORS 670.280, has been convicted of a sex crime as defined in ORS 163A.005  
45 or has been convicted in another state or jurisdiction of a crime that is substantially equivalent to

1 a sex crime as defined in ORS 163A.005.

2 (3) The board may impose a civil penalty under subsection (1) of this section:

3 (a) In an amount not to exceed \$5,000; or

4 (b) In an amount not to exceed \$10,000, if any of the following conditions exist:

5 (A) The conduct giving rise to the penalty had a serious detrimental effect on the health or  
6 safety of another person;

7 (B) The person subject to the penalty has a history of discipline for the same or similar conduct;

8 (C) The conduct giving rise to the penalty involves a willful or reckless disregard of the law;

9 (D) The conduct giving rise to the penalty was perpetrated against a minor, an elderly person  
10 or a person with a disability; or

11 (E) The person subject to the penalty violated ORS 675.020 by practicing psychology or repre-  
12 senting that the person is a psychologist without having a license.

13 (4) **Except as provided in subsection (7) of this section**, if a conviction described in sub-  
14 section (2) of this section is used as grounds for denial, refusal, suspension, revocation, reprimand,  
15 probation or imposition of a civil penalty, a certified copy of the record of the conviction shall be

14 (5) Subject to the provisions of ORS chapter 183 relating to a contested case, the board may

18 (b) Represented that the person is a regulated social worker.

26 impose a civil penalty of up to \$5,000 upon proof that a person who is not a clinical social worker  
27 licensed under ORS 675.530 or a clinical social work associate certified under ORS 675.537 has:

28 (a) Engaged in the practice of clinical social work, unless the person is permitted to practice  
29 clinical social work under ORS 675.523; or

30 (b) Represented that the person is a clinical social worker or clinical social work associate.

31 **(8)(a) As used in this section, "social work services" means clinical social work, the**  
32 **practice of baccalaureate social work, the practice of master's social work or the practice**  
33 **of social work.**

34 **(b) The board may not suspend or revoke a person's authorization to practice regulated**  
35 **social work, or refuse to grant a person an authorization to practice regulated social work,**  
36 **because of a conviction or license suspension or revocation resulting solely from the person's**  
37 **provision of social work services relating to reproductive or gender-affirming health care**  
38 **that are otherwise lawful in this state but unlawful in the jurisdiction in which the person**  
39 **provided the services, so long as the services provided were performed in accordance with**  
40 **the standard of care applicable to the services.**

41 **SECTION 31c.** ORS 675.745 is amended to read:

42 675.745. (1) The Oregon Board of Licensed Professional Counselors and Therapists may deny,

25 **(c) Actions against any person who provides aid, assistance, resources or support to a**  
26 **person in providing or receiving reproductive health care or gender-affirming treatment in**  
27 **this state.**

44 677.320. (1) Upon the complaint of any [citizen] resident of this state, or upon its own initiative,  
45 the Oregon Medical Board may investigate any alleged violation of this chapter. If, after the inves-

1 tigation, the board has reason to believe that any person is subject to **criminal** prosecution  
2 [*criminally*] **in this state** for the violation of this chapter, [*it*] **the board** shall lay the facts before  
3 the proper district attorney.

4 (2) In the conduct of investigations, the board or its designated representative may:

5 (a) Take evidence;

6 (b) Take the depositions of witnesses, including the person charged;

7 (c) Compel the appearance of witnesses, including the person charged;

23 other information that reasonably may be used to identify the complainant may be withheld from the  
24 licensee.

25 (6) A licensee who is the subject of an investigation and any person authorized to act on behalf  
26 of the licensee shall not knowingly contact the complainant until the licensee has requested a con-  
27 tested case hearing and the board has authorized the taking of the complainant's deposition pursu-  
28 ant to ORS 183.425.

29 (7) Except in an investigation or proceeding conducted by the board or another public entity,  
30 or in an action, suit or proceeding where a public entity is a party, a licensee shall not be ques-  
31 tioned or examined regarding any communication with the board made in an appearance before the

45 **SECTION 54. In addition to and not in lieu of any other appropriation, there is appro-**

1 priated to the Higher Education Coordinating Commission for allocation to the Office of  
2 Rural Health, for the biennium beginning July 1, 2023, out of the General Fund, the amount  
3 of \$2,320,221, to award grants in accordance with the provisions of section 29 of this 2023 Act.

4 **SECTION 55.** In addition to and not in lieu of any other appropriation, there is appro-  
5 priated to the Oregon Health Authority, for the biennium beginning July 1, 2023, out of the  
6 General Fund, the amount of \$1,600,000, for deposit into the Student Health Center Repro-  
7 ductive Health Grant Fund established in section 16 of this 2023 Act.

8 **SECTION 56.** Notwithstanding any other law limiting expenditures, the amount of
