SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Establishes ranked choice voting as voting method for selecting winner of nomination for and election to offices of President of United States, United States Senator, Representative in Congress, Governor, Secretary of State, State Treasurer and Attorney General.

Authorizes cities, counties, metropolitan service districts and local government and local service districts to elect to use ranked choice voting to nominate or elect candidates for relevant offices.

Requires Secretary of State to establish program to educate voters about how ranked choice voting will be conducted in elections held in state.

Prohibits nominating election [*Moves election*] for Commissioner of Bureau of Labor and Industries. **Requires election for commissioner to be held at primary election** [*to general election*], where election is conducted using ranked choice voting.

Requires Secretary of State and county clerks to jointly submit reports to Legislative Assembly setting forth analysis of whether existing laws are inconsistent with effective and efficient implementation of ranked choice voting and detailing, to degree practicable, each expenditure secretary and county clerks must make to successfully implement ranked choice voting.

Becomes operative on December 10, 2026.

Refers Act to people for their approval or rejection at next regular general election.

2 Relating to ranked choice voting; creating new provisions; amending ORS 244.050, 246.200, 249.088,
3 249.091, 254.065, 254.145, 254.485 and 258.280; and providing that this Act shall be referred to
4 the people for their approval or rejection.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. Sections 2 to 5 of this 2023 Act are added to and made a part of ORS chapter**
7 **254.**

8 **SECTION 2. (1) Ranked choice voting as conducted in the manner set forth in section 4**
9 **of this 2023 Act shall be used to determine the nomination by a major political party for the**
10 **following offices:**

11 (a) **President of the United States.**

12 (b) **United States Senator and Representative in Congress.**

13 (c) **Governor, Secretary of State, State Treasurer and Attorney General.**

14 (2) **Ranked choice voting as conducted in the manner set forth in section 4 of this 2023**
15 **Act shall be used at the general election to determine election to the following offices:**

16 (a) **President and Vice President of the United States.**

17 (b) **United States Senator and Representative in Congress.**

18 (c) **Governor, Secretary of State, State Treasurer and Attorney General.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 **(3) Ranked choice voting as conducted in the manner set forth in section 4 of this 2023**
2 **Act shall be used at the primary election to determine election to the office of Commissioner**
3 **of the Bureau of Labor and Industries.**

4 **SECTION 3. (1) Unless otherwise prohibited by home rule charter:**

5 **(a) A city may use ranked choice voting to determine election to city office.**

6 **(b) A county may use ranked choice voting to determine election to county office.**

7 **(c) A metropolitan service district organized under ORS chapter 268 may use ranked**
8 **choice voting to determine election to office of a metropolitan service district.**

9 **(d) A school district as defined in ORS 330.005 may use ranked choice voting to determine**
10 **election to office of the school district.**

11 **(e) Any local government or local service district, as both are defined in ORS 174.116,**
12 **may use ranked choice voting to determine election to office of the local government or local**
13 **service district.**

14 **(2) Unless otherwise prohibited by home rule charter:**

15 **(a) For any partisan city office, a city may use ranked choice voting to determine the**
16 **nomination for that office.**

17 **(b) For any partisan county office, a county may use ranked choice voting to determine**
18 **the nomination for that office.**

19 **(c) For any partisan office that is part of a metropolitan service district organized under**
20 **ORS chapter 268, the metropolitan service district may use ranked choice voting to deter-**
21 **mine the nomination for that office.**

22 **(d) For any partisan office of a school district as defined in ORS 330.005, the school dis-**
23 **trict may use ranked choice voting to determine the nomination for that office.**

24 **(e) For any partisan office of a local government or local service district, as both are**
25 **defined in ORS 174.116, the local government or local service district may use ranked choice**
26 **voting to determine the nomination for that local government or local service district office.**

27 **(3) This section does not apply to the nomination for or election to any office described**
28 **in section 2 of this 2023 Act.**

29 **(4)(a) This section may not be construed to limit, restrict or preempt the authority of**
30 **any home rule jurisdiction to provide for ranked choice voting conducted in the manner set**
31 **forth in section 4 of this 2023 Act to determine nomination for or election to any office in**
32 **that jurisdiction.**

33 **(b) This section may not be construed to limit, restrict or preempt the authority of any**
34 **home rule jurisdiction that, on or after November 8, 2016, and prior to the effective date of**
35 **this 2023 Act, adopted ranked choice voting to determine elections to office or offices of that**
36 **jurisdiction, to use ranked choice voting in any manner adopted, amended or revised by the**
37 **jurisdiction, including using ranked choice voting as locally adopted, amended or revised for**
38 **elections to office or offices of that jurisdiction in lieu of the method of ranked choice voting**
39 **set forth in section 4 of this 2023 Act and any rules adopted by the Secretary of State for the**
40 **purpose of implementing section 4 of this 2023 Act.**

41 **(5) The secretary, in consultation with county clerks and elections officers as defined in**
42 **ORS 255.005, shall:**

43 **(a) Adopt rules to implement this section; and**

44 **(b) Provide formal and informal guidance to cities, counties, metropolitan service dis-**
45 **tricts organized under ORS chapter 268, school districts as defined in ORS 330.005 and local**

1 governments and local service districts, as both are defined in ORS 174.116, regarding the
2 implementation of this section.

3 **SECTION 4. (1) When a nomination for or an election to an office is determined by**
4 **ranked choice voting, the winner or winners of the nomination or election shall be deter-**
5 **mined in the manner set forth in this section.**

6 (2)(a) The ballot shall provide electors with the option of ranking as many choices of
7 qualified candidates and qualified write-in candidates as practicable.

8 (b) Each ballot that is cast shall count as one vote for the highest-ranked active candi-
9 date on that ballot. The tallying of ballots shall proceed in rounds, with each round pro-
10 ceeding sequentially as follows:

11 (A) If an active candidate has a majority of votes in a round, the candidate with the
12 greatest number of votes is nominated or elected and the tallying of ballots is complete for
13 that office.

14 (B) If no active candidate has a majority of votes in a round:

15 (i) The active candidate with the fewest votes is defeated and is no longer an active
16 candidate;

17 (ii) Votes that had been counted for the defeated candidate are transferred to each
18 ballot's next highest-ranked active candidate; and

19 (iii) A new round of vote tallying begins with ballots retallied in the manner described in
20 this subparagraph.

21 (3) Notwithstanding subsection (2) of this section and except as otherwise expressly pro-
22 vided by law, when an election to an office is determined by ranked choice voting, and more
23 than one person is to be elected to a single office, the people elected to the office shall be
24 determined by a proportional methodology adopted by rule by the Secretary of State. Any
25 rules adopted under this subsection shall provide that candidates are elected to office by:

26 (a) Receiving more votes than a threshold determined by dividing the total votes counted
27 for active candidates in the first round of tabulation by the sum of the number of people to
28 be elected plus one, with all votes that are received by a candidate that are in excess of the
29 minimum number of votes required to be elected to office being transferred to lower-ranked
30 active candidates in the manner set forth in the proportional methodology adopted by the
31 secretary under this subsection; or

32 (b) If the number of active candidates is less than or equal to the number of seats re-
33 maining to be filled, by being one of the active candidates.

34 (4) This section may not be interpreted to limit, restrict or preempt a major political
35 party from selecting delegates for President of the United States according to party rules
36 that are not inconsistent with ORS chapter 248.

37 (5)(a) The Secretary of State, in consultation with county clerks and elections officers
38 as defined in ORS 255.005, shall adopt rules necessary for the implementation of this section,
39 including, but not limited to:

40 (A) Determining the number of qualified candidates and qualified write-in candidates that
41 are practicable to be ranked on the ballot for the purposes of subsection (2)(a) of this section;

42 (B) The tally processes for ranked choice voting; and

43 (C) Clearly defining any processes and terms needed for effectively implementing ranked
44 choice voting.

45 (b) Prior to adopting rules relating to the nomination of candidates for President of the

1 United States, the secretary shall also consult with, and receive input from, the Oregon
2 chairperson from each major political party.

3 (6) As used in this section:

4 (a) "Active candidate" means a candidate who has not, for the election at which ballots
5 are being tallied:

6 (A) Withdrawn;

7 (B) Been defeated; or

8 (C) Been nominated or elected.

9 (b) "Highest-ranked active candidate" means the active candidate assigned to a higher
10 ranking on a ballot than any other active candidate.

11 (c) "Ranking" means the number available to be assigned by an elector to a candidate to
12 express the elector's choice for that candidate, with the number 1 being the highest ranking,
13 followed by the number 2, then the number 3, with any additional rankings authorized under
14 this section following sequentially.

15 (d) "Round" means an instance of the sequence of voting tabulation:

16 (A) In the manner described in subsection (2)(b) of this section for elections in which no
17 more than one person is to be elected to a single office;

18 (B) Adopted under subsection (3) of this section for elections in which more than one
19 person is to be elected to a single office; or

20 (C) Established in conformity with subsection (4) of this section for the presidential pri-
21 mary election of a major political party.

22 **SECTION 5.** (1) The Secretary of State shall by rule establish a program to educate
23 electors about how ranked choice voting will be conducted in elections held in this state.

24 (2) The program established under this section shall:

25 (a) Involve community-based organizations;

26 (b) Be culturally appropriate; and

27 (c) Be available to electors in English and in the five most commonly spoken languages
28 in this state, other than English, that have been identified by the secretary under ORS
29 251.167.

30 **SECTION 6.** Section 7 of this 2023 Act is added to and made a part of ORS chapter 249.

31 **SECTION 7.** (1) Notwithstanding ORS 249.016 or any other provision of law:

32 (a) There may not be a nominating election for the office of Commissioner of the Bureau
33 of Labor and Industries; and

34 (b) The office of Commissioner of the Bureau of Labor and Industries shall be elected at
35 the primary election by ranked choice voting conducted in the manner set forth in section
36 4 of this 2023 Act.

37 (2) Except as otherwise expressly provided by this section or other law, the requirements
38 of ORS 249.016 to 249.205 apply to candidates for the office of Commissioner of the Bureau
39 of Labor and Industries.

40 **SECTION 8.** ORS 246.200 is amended to read:

41 246.200. (1)(a) Except as otherwise provided by law, the county clerk is the only elections officer
42 who may conduct an election in this state.

43 (b) For purposes of this section, the conduct of an election includes, but is not limited to, es-
44 tablishing precincts, preparing ballots and sample ballots, and receiving and processing votes.

45 (2) Notwithstanding subsection (1) of this section:

1 (a) The county clerk is not the only elections officer who may accept and verify a filing for
2 nomination or filing of a petition, prepare a voters' pamphlet or ballot title, or prepare or publish
3 an election notice; [and]

4 (b) The Secretary of State may receive ballots as provided in ORS 253.585[.]; and

5 **(c) The Secretary of State, in a manner determined by the secretary by rule, may tally**
6 **ballots cast for the nomination for or election to an office that is determined by ranked**
7 **choice voting as provided in section 4 of this 2023 Act.**

8 **SECTION 9.** ORS 254.065 is amended to read:

9 254.065. (1)(a) **Except as provided in paragraph (b) of this subsection**, when one person is
10 to be nominated for or elected to an office, the person receiving the highest number of votes shall
11 be nominated or elected. **Except as provided in paragraph (c) of this subsection**, when more than
12 one person is to be nominated for or elected to a single office, the persons receiving the higher
13 number of votes shall be nominated or elected. This subsection does not apply to a candidate for
14 election to an office at a general election if the election for the office must be held at a special
15 election as described in ORS 254.650.

16 **(b)(A) Except as otherwise provided in this paragraph, when a nomination for or election**
17 **to an office is determined by ranked choice voting, a determination of which person has re-**
18 **ceived the highest number of votes shall be done:**

19 **(i) In the manner set forth in section 4 of this 2023 Act; or**

20 **(ii) In the manner adopted, amended or revised by a local jurisdiction in conformity with**
21 **section 3 (4)(b) of this 2023 Act.**

22 **(B) If the National Popular Vote interstate compact set forth in section 1, chapter 356,**
23 **Oregon Laws 2019, governs the appointment of presidential electors and the election of**
24 **presidential electors in this state is determined by ranked choice voting:**

25 **(i) The determination of which candidates for the position of presidential elector shall be**
26 **declared elected in this state shall be made in accordance with the provisions of the National**
27 **Popular Vote interstate compact; and**

28 **(ii) The "final determination" of the presidential vote count reported and certified to the**
29 **member states of the compact and to the federal government shall be the votes received in**
30 **the final round of statewide tabulation by each slate of candidates for the offices of President**
31 **and Vice President of the United States that received votes in the final round of statewide**
32 **tabulation.**

33 **(c) When more than one person is to be nominated for or elected to a single office by**
34 **ranked choice voting, a determination of which persons have received the highest number**
35 **of votes shall be done in the manner established under section 4 (3) of this 2023 Act.**

36 (2) No measure shall be adopted unless it receives an affirmative majority of the total votes cast
37 on the measure. If two or more conflicting laws, or amendments to the Constitution or charter, are
38 approved at the same election, the law, or amendment, receiving the greatest number of affirmative
39 votes shall be paramount regarding each conflict, even though the law, or amendment, may not have
40 received the greatest majority of affirmative votes.

41 **SECTION 10.** ORS 254.145 is amended to read:

42 254.145. (1)(a) Except as provided in paragraph (b) of this subsection, the names of candidates
43 for nomination for or election to each office shall be arranged on the ballot in the order determined
44 under ORS 254.155.

45 (b) The names of candidates for the offices of President and Vice President of the United States

1 shall be arranged in groups.

2 (2) Except as provided in ORS 254.125 and 254.135 and this section, no information about the
3 candidate, including any title or designation, other than the candidate's name, may appear on the
4 ballot.

5 (3) Spaces shall be provided for any offices appearing on the ballot in which the elector may
6 write the name of any person not printed on the ballot. If a voting machine is used, spaces shall be
7 provided on the ballot, or on separate material delivered to the elector with the ballot, in which the
8 elector may write or enter the names of persons for any offices appearing on the ballot.

9 (4) On the left margin of the ballot, the name of each group or candidate may be numbered. The
10 blank spaces may not be numbered. A particular number may not be used to designate more than
11 one candidate at any election.

12 (5) The names of all candidates for the same office shall be listed in the same column on the
13 ballot. If more than one column is needed to list names of all candidates for that office, the names
14 may be arranged in one or more columns in block form. The block shall be set apart by rulings
15 under the title of the office. If a blank space follows the list of candidates, the space shall be in the
16 same column as the names of candidates for that office. If blocks of columns are used, blank spaces
17 shall be included within the ruled block.

18 (6) The ballot shall be clearly marked to indicate when names of candidates for the office are
19 continued on the following page.

20 (7) When a measure is submitted to the people, the number, ballot title and financial estimates
21 under ORS 250.125 of each measure shall be printed after the list of candidates. A measure referred
22 by the Legislative Assembly shall be designated "Referred to the People by the Legislative Assem-
23 bly." A state measure referred by petition shall be designated "Referendum Order by Petition of the
24 People." A state measure proposed by initiative petition shall be designated "Proposed by Initiative
25 Petition."

26 (8) The ballot shall be printed to give the elector a clear opportunity to designate the elector's
27 choice **or choices** for candidates and approval or rejection of measures submitted.

28 (9) **When an elector is allowed to make only one choice or answer and** if a voting machine
29 is not used, the elector shall indicate a preference by making a cross or check mark inside a voting
30 square corresponding to the candidate or answer for which the elector wishes to vote. A voting
31 square may be printed on the blank, write-in vote spaces. However, the elector is not required to
32 place a mark in the voting square corresponding to a name written in a blank space. Words shall
33 be printed on the ballot to aid the elector, such as "Vote for one," "Vote for three," and regarding
34 measures, "Yes" and "No."

35 (10) **When a nomination for or an election to an office is determined by ranked choice**
36 **voting as provided in section 4 of this 2023 Act, the ballot shall provide the elector with the**
37 **ability to rank, by choice, write-in candidates and candidates appearing on the ballot for the**
38 **office. The Secretary of State by rule shall establish a statement to be printed on the ballot**
39 **describing how to mark choices in an election determined by ranked choice voting consistent**
40 **with section 4 of this 2023 Act.**

41 **SECTION 11.** ORS 254.485 is amended to read:

42 254.485. (1) Ballots may be tallied by a vote tally system, [or] by a counting board **or in the**
43 **manner determined by the Secretary of State under ORS 246.200.** A counting board may tally
44 ballots at the precinct or in the office of the county clerk. [In any event,] **Except as otherwise**
45 **determined by the secretary under ORS 246.200,** the ballots shall be tallied and returned by

1 precinct.

2 (2) If a vote tally system is used, the county clerk shall repeat the public certification test de-
3 scribed under ORS 254.235 (1). The test shall be conducted immediately prior to scanning any bal-
4 lots. The test may be observed by persons described in ORS 254.235 (2). The county clerk shall
5 certify the results of the test.

6 (3) If a counting board has been appointed, the tally of ballots may begin on the date of the
7 election.

8 (4)(a) If ballots are tallied by a counting board, after the tally has begun it shall continue until
9 completed. Except as provided in paragraph (b) of this subsection, a counting board shall tally
10 without adjournment and in the presence of the clerks and persons authorized to attend.

11 (b) A counting board may be relieved by another board if the tally is not completed after 12
12 hours.

13 (5) A counting board shall audibly announce the tally as it proceeds. The board shall use only
14 pen and ink to tally.

15 (6) For ballots cast using a voting machine, the county clerk shall:

16 (a) Enter the ballots cast using the machine into the vote tally system; and

17 (b) In the event of a recount, provide the paper record copy recorded by the machine to the
18 counting board.

19 (7) A person other than the **Secretary of State**, county clerk, a member of a counting board
20 or any other elections official designated by the **secretary or** county clerk may not tally ballots
21 under this chapter.

22 (8) The Secretary of State shall by rule establish a procedure for announcing the status of the
23 tally of the ballots received after the date of the election. Rules adopted under this subsection must:

24 (a) Consider the number of ballots being released in relation to the size of the district;

25 (b) Prioritize voter anonymity; and

26 (c) After prioritizing voter anonymity under paragraph (b) of this subsection, prioritize the im-
27 portance of timely reporting election results.

28 **SECTION 12.** ORS 244.050, as amended by section 1, chapter 66, Oregon Laws 2022, is amended
29 to read:

30 244.050. (1) On or before April 15 of each year the following persons shall file with the Oregon
31 Government Ethics Commission a verified statement of economic interest as required under this
32 chapter:

33 (a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the
34 Bureau of Labor and Industries, district attorneys and members of the Legislative Assembly.

35 (b) Any judicial officer, including justices of the peace and municipal judges, except any pro tem
36 judicial officer who does not otherwise serve as a judicial officer.

14 (2) By April 15 next after the date an appointment takes effect, every appointed public official
15 on a board or commission listed in subsection (1) of this section shall file with the Oregon Govern-
16 ment Ethics Commission a statement of economic interest as required under ORS 244.060, 244.070

18 (3) By April 15 next after the filing deadline for the primary election, each candidate described
19 in subsection (1) of this section **who will appear on a primary election ballot** shall file with the
20 commission a statement of economic interest as required under ORS 244.060, 244.070 and 244.090.

21 (4) Not later than the 40th day before the date of the statewide general election, each candidate
22 described in subsection (1) of this section who will appear on the statewide general election ballot
23 and who was not required to file a statement of economic interest under subsections (1) to (3) of this

21 the Secretary of State is the filing officer, and the county clerk who conducted the election shall
22 order a full recount of the votes cast for nomination or election to any other public office if the
23 canvass of votes of the election reveals that:

24 [(a)] (A) Two or more candidates for that nomination or office have an equal and the highest
25 number of votes; or

26 [(b)] (B) The difference in the number of votes cast for a candidate apparently nominated or
27 elected to the office and the votes cast for the closest apparently defeated opponent is not more than

3 with the effective and efficient implementation of ranked choice voting elections.

36 **SECTION 20.** This 2023 Act shall be submitted to the people for their approval or re-
