

House Bill 2048

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Health Care for Representative Rob Nosse)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Health Licensing Office to issue provisional registration to applicant for behavior analysis interventionist registration.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

2 Relating to behavior analysis interventionists; creating new provisions; amending ORS 676.815; and
3 prescribing an effective date.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 676.815 is amended to read:

6 676.815. (1) The Health Licensing Office shall establish by rule criteria for the registration of
7 behavior analysis interventionists. The criteria must include, but are not limited to, the requirement
8 that the applicant:

9 [(1)] (a) Have a high school diploma, a modified diploma, a certificate for passing an approved
10 high school equivalency test such as the General Educational Development (GED) test or a degree
11 from a post-secondary institution;

12 [(2)] (b) Be at least 18 years of age;

13 [(3)] (c) Have successfully completed a state and nationwide criminal records check that re-
14 quires fingerprinting;

15 [(4)] (d) Have completed at least 40 hours of professional training in applied behavior analysis
16 approved by the office by rule; and

17 [(5)] (e) Receive ongoing training and supervision by a licensed behavior analyst, by a licensed
18 assistant behavior analyst or by another licensed health care professional.

19 **(2) The office shall adopt rules to establish a process to issue a provisional registration**
20 **to an applicant for registration under subsection (1) of this section. The provisional regis-**
21 **tration:**

22 **(a) Must be issued within five business days of the date on which the application for**
23 **registration is received by the office; and**

24 **(b) Expires on the date on which registration is issued to the applicant or, if the applicant**
25 **is denied registration, on the date on which registration is denied.**

26 **SECTION 2.** The amendments to ORS 676.815 by section 1 of this 2023 Act apply to ap-
27 plications received on and after the operative date specified in section 3 of this 2023 Act.

28 **SECTION 3.** (1) The amendments to ORS 676.815 by section 1 of this 2023 Act become
29 operative on January 1, 2024.

30 **(2) The Health Licensing Office may take any action before the operative date specified**

5 SECTION 4. This 2023 Act takes effect on the 91st day after the date on which the 2023
6 regular session of the Eighty-second Legislative Assembly adjourns sine die.
