82nd OREGON LEGISLATIVE ASSEMBLY--2023 Regular Session

House Bill 2240

Sponsored by Representative NERON (at the request of Oregon School Board Association, Coalition of School Administrators) (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Exempts from health care interpreter requirements individuals providing services as employees or contractors of school districts, public charter schools and education service districts. Declares emergency, effective on passage.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 413.550, as amended by section 8, chapter 453, Oregon Laws 2021, is amended 6 to read:

7 413.550. As used in ORS 413.550 to 413.559:

8 (1) "Certified health care interpreter" means an individual who has been approved and certified

9 by the Oregon Health Authority under ORS 413.558.

10 (2) "Coordinated care organization" has the meaning given that term in ORS 414.025.

11 (3) "Health care" means medical, surgical, oral or hospital care or any other remedial care re-12 cognized by state law, including physical and behavioral health care.

- 13 (4)(a) "Health care interpreter" means an individual who is readily able to:
- (A) Communicate in English and communicate with a person with limited English proficiency
 or who communicates in signed language;
- (B) Accurately interpret the oral statements of a person with limited English proficiency, or the
 statements of a person who communicates in signed language, into English;
- (C) Accurately interpret oral statements in English to a person with limited English proficiency
 or who communicates in signed language;
- 20 (D) Sight translate documents from a person with limited English proficiency; and
- (E) Interpret the oral statements of other persons into the language of the person with limitedEnglish proficiency or into signed language.
- (b) "Health care interpreter" also includes an individual who can provide the services described
 in paragraph (a) of this subsection using relay or indirect interpretation.
- (5) "Health care interpreter registry" means the registry described in ORS 413.558 that is ad ministered by the authority.
- (6)(a) "Health care provider" means any of the following that are reimbursed with public funds,
 in whole or in part:

23	[(d)] (D) A health care facility as defined in ORS 442.015;
24	[(e)] (E) A home health agency licensed under ORS 443.015;
25	[(f)] (F) A hospice program licensed under ORS 443.860; or
26	[(g)] (G) Any other person that provides health care or that bills for or is compensated for
27	health care provided, in the normal course of business.
28	(b) "Health care provider" does not include any individual listed in paragraph (a) of this
29	subsection when providing services as an employee of or under contract with:
30	(A) A school district, as defined in ORS 332.002;
31	(B) A public charter school, as defined in ORS 338.005; or
32	(C) An education service district, as defined in ORS 334.003.
33	(7) "Interpretation service company" means an entity, or a person acting on behalf of an entity,
34	that is in the business of arranging for health care interpreters to work with health care providers
35	in this state.
36	(8) "Person with limited English proficiency" means a person who, by reason of place of birth
37	or culture, communicates in a language other than English and does not communicate in English
38	with adequate ability to communicate effectively with a health care provider.
39	(9) "Prepaid managed care health services organization" has the meaning given that term in
40	ORS 414.025.
41	(10) "Qualified health care interpreter" means an individual who has been issued a valid letter
42	of qualification from the authority under ORS 413.558.
43	(11) "Sight translate" means to translate a written document into spoken or signed language.
44	SECTION 2. This 2023 Act being necessary for the immediate preservation of the public
45	peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
