House Bill 2411

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Dissolves Oregon Alfalfa Seed Commission. Declares emergency, effective on passage.

Section 1 of this 2023 Act is repealed on the day after the effective date of 9 this 2023 Act. **SECTION 3.** ORS 576.062 is amended to read: 10 576.062.
