

House Bill 2852

Sponsored by Representative EVANS (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Oregon Department of Emergency Management to develop and implement program to provide grants to counties to create and fill county-level position of disaster mitigation and recovery manager. Specifies duties of disaster mitigation and recovery manager.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to county disaster recovery; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Oregon Department of Emergency Management shall develop and**
5 **implement a program to provide grants to counties to enable each county to create and fill**
6 **a county-level position of disaster mitigation and recovery manager to prepare for and co-**
7 **ordinate recovery after a disaster in a county.**

8 **(2) The department shall execute grant agreements with counties specifying the duties**
9 **that a disaster mitigation and recovery manager funded by grant moneys must perform. The**
10 **duties must include:**

11 **(a) Building relationships and networks with potential disaster recovery partners, in-**
12 **cluding the department, the Federal Emergency Management Agency, city governments,**
13 **community organizations active in disaster and other business and community partners;**

14 **(b) Creating and maintaining plans for mitigating natural hazards, in consultation with**
15 **the Department of Land Conservation and Development and community partners and in**
16 **collaboration with the emergency management agency of a county;**

17 **(c) Creating and maintaining plans for community wildfire protection, including pro-**
18 **tection from related issues such as smoke, in consultation with the Department of Land**
19 **Conservation and Development and community partners and in collaboration with the**
20 **emergency management agency of a county;**

21 **(d) During and after a disaster that affects a county, managing recovery operations**
22 **within the county, including:**

23 **(A) Putting existing contracts or purchase orders into operation;**

24 **(B) Working with cities, unincorporated communities and special districts to assess**
25 **needs and provide resources and other support; and**

26 **(C) Working with community organizations active in disaster, long-term recovery groups**
27 **and other groups active in disaster recovery to assess local needs and direct resources to-**
28 **ward such groups; and**

29 **(e) Providing mutual aid to support other counties affected by disaster.**

30 **(3) A county is not required to apply for or accept a grant under this section. Nothing**

1 **in this section limits or supplants any rights or powers that a county may exercise.**

2 **(4) The Oregon Department of Emergency Management may adopt rules necessary for**
3 **the administration of this section.**

4 **SECTION 2. This 2023 Act being necessary for the immediate preservation of the public**
5 **peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect**
6 **on its passage.**
