

House Bill 2874

Sponsored by Representative EVANS (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Defines "undetectable firearm." Punishes manufacturing, importing, offering for sale or transferring undetectable firearm by maximum of 10 years' imprisonment, \$250,000 fine, or both. Punishes possession of undetectable firearm by maximum of 364 days' imprisonment, \$6,250 fine, or both.

Defines "untraceable firearm." Punishes possessing, manufacturing, importing, offering for sale or transferring untraceable firearm by maximum of \$1,000 fine upon first conviction, 364 days' imprisonment, \$6,250 fine, or both, upon second conviction, and 10 years' imprisonment, \$250,000 fine, or both, upon third and subsequent convictions.

Defines "unfinished frame or receiver." Punishes importing, offering for sale or transferring unfinished frame or receiver by maximum of \$1,000 fine, or \$2,000 fine if offense involves 10 or more unfinished frames or receivers, upon first conviction. Upon second conviction, punishes by maximum of 364 days' imprisonment, \$6,250 fine, or both, or five years' imprisonment, \$125,000 fine, or both, if offense involves 10 or more unfinished frames or receivers. Upon third and subsequent convictions, punishes by maximum of 10 years' imprisonment, \$250,000 fine, or both, or 20 years' imprisonment, \$375,000 fine, or both, if offense involves 10 or more unfinished frames or receivers. Specifies exceptions.

Punishes possession of unserialized unfinished frame or receiver by maximum of \$1,000 fine, or \$2,000 fine if offense involves 10 or more unfinished frames or receivers, upon first conviction. Upon second conviction, Punishes by maximum of 364 days' imprisonment, \$6,250 fine, or both, or five years' imprisonment, \$125,000 fine, or both, if offense involves 10 or more unfinished frames or receivers. Upon third and subsequent convictions, punishes by maximum of five years' imprisonment, \$125,000 fine, or both, or 10 years' imprisonment, \$250,000 fine, or both, if offense involves 10 or more unfinished frames or receivers. Specifies exceptions.

Creates crime of domestic terrorism. Punishes by maximum penalty of 10 years' imprisonment, \$250,000 fine, or both. Prohibits court from sentencing person to probation if person is in possession of 10 or more unfinished frames or receivers at time of offense.

Provides that person commits crime if person possesses unfinished frame or receiver and is prohibited from possessing firearms. Punishes by maximum of 364 days' imprisonment, \$6,250 fine, or both.

Requires gun dealer to conduct criminal background check before transferring unfinished frame or receiver.

2 Relating to public safety; creating new provisions; and amending ORS 166.210, 166.250 and 166.412.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 166.210 is amended to read:

5 166.210. As used in ORS 166.250 to 166.270, 166.291 to 166.295 and 166.410 to 166.470:

6 (1) "Antique firearm" means:

7 (a) Any firearm, including any firearm with a matchlock, flintlock, percussion cap or similar type
8 of ignition system, manufactured in or before 1898; and

9 (b) Any replica of any firearm described in paragraph (a) of this subsection if the replica:

10 (A) Is not designed or redesigned for using rimfire or conventional centerfire fixed ammunition;
11 or

12 (B) Uses rimfire or conventional centerfire fixed ammunition that is no longer manufactured in
13 the United States and that is not readily available in the ordinary channels of commercial trade.

14 (2) "Corrections officer" has the meaning given that term in ORS 181A.355.

15 (3) "Firearm" means a weapon, by whatever name known, which is designed to expel a projectile

1 by the action of powder.

2 (4) "Firearms silencer" means any device for silencing, muffling or diminishing the report of a
3 firearm.

4 (5) "Frame or receiver" means a part of a firearm that, when the complete weapon is
5 assembled, is visible from the exterior and provides housing or a structure designed to hold
6 or integrate one or more firearm control components, even if pins or other attachments are
7 required to connect those components to the housing or structure. For firearm models in
8 which multiple parts provide housing or structure for fire control components, the frame or
9 receiver consists of the part or parts designated as the frame or receiver by the Bureau of
10 Alcohol, Tobacco, Firearms and Explosives.

11 [(5)] (6) "Handgun" means any pistol or revolver using a fixed cartridge containing a propellant
12 charge, primer and projectile, and designed to be aimed or fired otherwise than from the shoulder.

13 [(6)] (7) "Machine gun" means a weapon of any description by whatever name known, loaded
14 or unloaded, which is designed or modified to allow two or more shots to be fired by a single pres-
15 sure on the trigger device.

16 (8) "Major component" has the meaning given that term in 18 U.S.C. 922.

17 [(7)] (9) "Minor" means a person under 18 years of age.

18 [(8)] (10) "Offense" has the meaning given that term in ORS 161.505.

19 [(9)] (11) "Parole and probation officer" has the meaning given that term in ORS 181A.355.

20 [(10)] (12) "Peace officer" has the meaning given that term in ORS 133.005.

21 (13) "Security exemplar" has the meaning given that term in 18 U.S.C. 922.

22 [(11)] (14) "Short-barreled rifle" means a rifle having one or more barrels less than 16 inches in
23 length and any weapon made from a rifle if the weapon has an overall length of less than 26 inches.

24 [(12)] (15) "Short-barreled shotgun" means a shotgun having one or more barrels less than 18
25 inches in length and any weapon made from a shotgun if the weapon has an overall length of less
26 than 26 inches.

27 (16) "Undetectable firearm" means a firearm:

28 (a) Constructed or produced, including through a three-dimensional printing process,
29 entirely of nonmetal substances;

30 (b) That is not as detectable as 3.7 ounces of 17-4 PH stainless steel, or as the security
31 exemplar, by a walk-through metal detector or magnetometer after all parts other than
32 major components have been removed; or

33 (c) That includes a major component that, if the firearm were subjected to inspection by
34 the types of X-ray machines or detection devices commonly used at airports for security
35 screening, would not generate an image that accurately depicts the shape of the component.

36 (17)(a) "Unfinished frame or receiver" means a forging, casting, printing, extrusion, ma-
37 chined body or similar item that:

38 (A) Has reached a stage in manufacture in which it may readily be completed, assembled
39 or converted to become a functional frame or receiver when combined with other parts; or

40 (B) Is marketed or sold to the public to become a functional frame or receiver.

41 (b) "Unfinished frame or receiver" does not include a component designed and intended
42 for use in an antique firearm.

43 (18) "Untraceable firearm" means a firearm, other than an antique firearm or a firearm
44 manufactured prior to October 22, 1968, that cannot be traced by a law enforcement agency
45 by means of a serial number affixed to the firearm.

1 **SECTION 2.** Sections 3, 4 and 5 of this 2023 Act are added to and made a part of ORS
2 166.250 to 166.270.

3 **SECTION 3.** (1)(a) A person may not knowingly manufacture or cause to be manufac-
4 tured within this state, import into this state, or offer for sale, sell or transfer, an unde-
5 tectable firearm.

6 (b) A violation of paragraph (a) of this subsection is a Class B felony.

7 (2)(a) A person may not knowingly possess an undetectable firearm.

8 (b) A violation of paragraph (a) of this subsection is a Class A misdemeanor.

9 (3) A person convicted under this section shall forfeit the undetectable firearm.

10 **SECTION 4.** (1) A person may not knowingly possess, manufacture, assemble, cause to
11 be manufactured or assembled, import into this state, offer for sale, sell or transfer an
12 untraceable firearm.

13 (2)(a) A violation of subsection (1) of this section constitutes a Class B violation.

14 (b) Notwithstanding paragraph (a) of this subsection, a violation of subsection (1) of this
15 section is a Class A misdemeanor if, at the time of the offense, the person has a prior con-
16 viction under this section or section 5 of this 2023 Act.

17 (c) Notwithstanding paragraphs (a) and (b) of this subsection, a violation of subsection
18 (1) of this section is a Class B felony if, at the time of the offense, the person has two or
19 more prior convictions under this section or section 5 of this 2023 Act.

20 (3) A person convicted of any offense under this section shall forfeit the untraceable
21 firearm.

22 (4) As used in this section, “prior conviction” includes a conviction for a violation of
23 fense.

24 **SECTION 5.** (1)(a) A person may not knowingly import into this state, offer for sale, sell
25 or transfer an unfinished frame or receiver unless:

26 (A) The person is a federally licensed gun dealer;

27 (B) The name of the manufacturer and an individual serial number is conspicuously
28 placed on the unfinished frame or receiver in accordance with the procedures for the se-
29 rialization of a firearm in 18 U.S.C. 923(i) and all regulations under the authority of 18 U.S.C.
30 923(i), including but not limited to 27 C.F.R. 478.92; and

31 (C) The person maintains records relating to the unfinished frame or receiver in ac-
32 cordance with the procedures for record keeping related to firearms in 18 U.S.C. 923(g) and
33 all regulations issued under the authority of 18 U.S.C. 923(g), including but not limited to 27
34 C.F.R. 478.121 to 478.134.

35 (b) Except as otherwise provided in this paragraph, a violation of paragraph (a) of this
36 subsection is:

37 (A) A Class B violation.

38 (B) A Class A violation if the person imports, offers for sale, sells or transfers 10 or more
39 unfinished frames or receivers.

40 (C) A Class A misdemeanor if, at the time of the offense, the person has a prior con-
41 viction under this section or section 4 of this 2023 Act.

42 (D) A Class C felony if, at the time of the offense, the person has a prior conviction under
43 this section or section 4 of this 2023 Act and the person imports, offers for sale, sells or
44 transfers 10 or more unfinished frames or receivers.

45 (E) A Class B felony if, at the time of the offense, the person has two or more prior

1 convictions under this section or section 4 of this 2023 Act.

2 (F) A Class A felony if, at the time of the offense, the person has two or more prior
3 convictions under this section or section 4 of this 2023 Act and the person imports, offers for
4 sale, sells or transfers 10 or more unfinished frames or receivers.

5 (2)(a) A person may not knowingly possess an unfinished frame or receiver that is not
6 serialized as provided in subsection (1)(a)(B) of this section, unless:

7 (A) The person is a federally licensed gun manufacturer; and

8 (B) The unfinished frame or receiver is an unfinished part within a manufacturing pro-
9 cess that includes serialization.

10 (b) Except as otherwise provided in this paragraph, a violation of paragraph (a) of this
11 subsection is:

12 (A) A Class B violation.

13 (B) A Class A violation if the person possesses 10 or more unfinished frames or receivers.

14 (C) A Class A misdemeanor if, at the time of the offense, the person has a prior con-
15 viction under this section or section 4 of this 2023 Act.

16 (D) A Class C felony if, at the time of the offense, the person has a prior conviction under
17 this section or section 4 of this 2023 Act and the person possesses 10 or more unfinished
18 frames or receivers.

19 (E) A Class C felony if, at the time of the offense, the person has two or more prior
20 convictions under this section or section 4 of this 2023 Act.

21 (F) A Class B felony if, at the time of the offense, the person has two or more prior
22 convictions under this section or section 4 of this 2023 Act and the person possesses 10 or
23 more unfinished frames or receivers.

24 (3) A person convicted of any offense under this section shall forfeit the unfinished frame
25 or receiver.

26 (4) As used in this section, "prior conviction" includes a conviction for a violation of
27 fense.

28 **SECTION 6.** (1) A person commits the crime of domestic terrorism if the person inten-
29 tionally attempts to cause catastrophic harm.

30 (2) Domestic terrorism is a Class B felony.

31 (3)(a) The Oregon Criminal Justice Commission shall classify domestic terrorism as
32 crime category 8 of the sentencing guidelines grid of the commission.

33 (b) The court may not sentence a person convicted under this section to probation and
34 shall sentence the person to the presumptive term of imprisonment specified in the rules of
35 the commission if, at the time of the offense, the person is in possession of 10 or more un-
36 finished frames or receivers that are not serialized as required by section 5 of this 2023 Act.

37 (4) As used in this section:

38 (a) "Catastrophic harm" means harm that:

39 (A) Results in extraordinary levels of death, injury, property damage or disruption of
40 daily life; and

41 (B) Severely affects the population, infrastructure, environment, economy or government
42 functioning of this state.

43 (b) "Unfinished frame or receiver" has the meaning given that term in ORS 166.210.

44 **SECTION 7.** ORS 166.250 is amended to read:

45 166.250. (1) Except as otherwise provided in this section or ORS 166.260, 166.270, 166.273,

1 166.274, 166.291, 166.292 or 166.410 to 166.470, a person commits the crime of unlawful possession
 2 of a firearm if the person knowingly:

3 (a) Carries any firearm concealed upon the person;

4 (b) Possesses a handgun that is concealed and readily accessible to the person within any vehi-
 5 cle; [or]

6 (c) Possesses a firearm and:

7 (A) Is under 18 years of age;

8 (B)(i) While a minor, was found to be within the jurisdiction of the juvenile court for having
 9 committed an act which, if committed by an adult, would constitute a felony or a misdemeanor in-
 10 volving violence, as defined in ORS 166.470; and

11 (ii) Was discharged from the jurisdiction of the juvenile court within four years prior to being
 12 charged under this section;

13 (C) Has been convicted of a felony;

14 (D) Was committed to the Oregon Health Authority under ORS 426.130;

15 (E) Was found to be a person with mental illness and subject to an order under ORS 426.130 that
 16 the person be prohibited from purchasing or possessing a firearm as a result of that mental illness;

17 (F) Is presently subject to an order under ORS 426.133 prohibiting the person from purchasing
 18 or possessing a firearm;

19 (G) Has been found guilty except for insanity under ORS 161.295 of a felony; or

20 (H) The possession of the firearm by the person is prohibited under ORS 166.255[.]; **or**

21 **(d) Possesses an unfinished frame or receiver and is prohibited from possessing firearms**
 22 **under paragraph (c) of this subsection.**

23 (2) This section does not prohibit:

24 (a) A minor, who is not otherwise prohibited under subsection (1)(c) of this section, from pos-
 25 sessed a firearm:

26 (A) Other than a handgun, if the firearm was transferred to the minor by the minor's parent or
 27 guardian or by another person with the consent of the minor's parent or guardian; or

28 (B) Temporarily for hunting, target practice or any other lawful purpose; or

29 (b) Any citizen of the United States over the age of 18 years who resides in or is temporarily
 30 sojourning within this state, and who is not within the excepted classes prescribed by ORS 166.270
 31 and subsection (1) of this section, from owning, possessing or keeping within the person's place of
 32 residence or place of business any handgun, and no permit or license to purchase, own, possess or
 33 keep any such firearm at the person's place of residence or place of business is required of any such
 34 citizen. As used in this subsection, "residence" includes a recreational vessel or recreational vehicle
 35 while used, for whatever period of time, as residential quarters.

36 (3) Firearms carried openly in belt holsters are not concealed within the meaning of this section.

37 (4)(a) Except as provided in paragraphs (b) and (c) of this subsection, a handgun is readily ac-
 38 cessible within the meaning of this section if the handgun is within the passenger compartment of
 39 the vehicle.

40 (b) If a vehicle, other than a vehicle described in paragraph (c) of this subsection, has no storage
 41 location that is outside the passenger compartment of the vehicle, a handgun is not readily acces-
 42 sible within the meaning of this section if:

43 (A) The handgun is stored in a closed and locked glove compartment, center console or other
 44 container; and

45 (B) The key is not inserted into the lock, if the glove compartment, center console or other

1 container unlocks with a key.

2 (c) If the vehicle is a motorcycle, an all-terrain vehicle or a snowmobile, a handgun is not
3 readily accessible within the meaning of this section if:

4 (A) The handgun is in a locked container within or affixed to the vehicle; or

5 (B) The handgun is equipped with a trigger lock or other locking mechanism that prevents the
6 discharge of the firearm.

7 (5) Unlawful possession of a firearm is a Class A misdemeanor.

8 **SECTION 8.** ORS 166.412, as amended by section 6, chapter 1, Oregon Laws 2023, is amended
9 to read:

10 166.412. (1) As used in this section:

11 (a) "Antique firearm" has the meaning given that term in 18 U.S.C. 921;

12 (b) "Department" means the Department of State Police;

13 (c) "Firearm" has the meaning given that term in ORS 166.210, except that it does not include
14 an antique firearm;

15 (d) "Firearms transaction record" means the firearms transaction record required by 18 U.S.C.
16 921 to 929;

17 (e) "Firearms transaction thumbprint form" means a form provided by the department under
18 subsection (11) of this section;

19 (f) "Gun dealer" means a person engaged in the business, as defined in 18 U.S.C. 921, of selling,
20 leasing or otherwise transferring a firearm, whether the person is a retail dealer, pawnbroker or
21 otherwise; [and]

22 (g) "Purchaser" means a person who buys, leases or otherwise receives a firearm **or unfinished**
23 **frame or receiver** from a gun dealer[.]; **and**

24 **(h) "Unfinished frame or receiver" has the meaning given that term in ORS 166.210.**

25 (2) Except as provided in subsection (12) of this section, a gun dealer shall comply with the
26 following before a firearm **or unfinished frame or receiver** is delivered to a purchaser:

27 (a) The purchaser shall present to the gun dealer current identification meeting the require-
28 ments of subsection (4) of this section and a valid permit issued under section 4, chapter 1, Oregon
29 Laws 2023.

30 (b) The gun dealer shall complete the firearms transaction record and obtain the signature of
31 the purchaser on the record.

32 (c) The gun dealer shall obtain the thumbprints of the purchaser on the firearms transaction
33 thumbprint form and attach the form to the gun dealer's copy of the firearms transaction record to
34 be filed with that copy.

35 (d) The gun dealer shall, by telephone or computer, verify that the purchaser has a valid
36 permit-to-purchase a firearm issued under section 4, chapter 1, Oregon Laws 2023, and request that
37 the department conduct a criminal history record check on the purchaser and shall provide the
38 following information to the department:

39 (A) The federal firearms license number of the gun dealer;

40 (B) The business name of the gun dealer;

41 (C) The place of transfer;

42 (D) The name of the person making the transfer;

43 (E) The make, model, caliber and manufacturer's number of the firearm being transferred **or a**
44 **description of the unfinished frame or receiver being transferred;**

45 (F) The name and date of birth of the purchaser;

1 (G) The Social Security number of the purchaser if the purchaser voluntarily provides this
 2 number to the gun dealer; and

3 (H) The type, issuer and identification number of the identification presented by the purchaser.

4 (e) The gun dealer shall receive a unique approval number for the transfer from the department
 5 and record the approval number on the firearms transaction record and on the firearms transaction
 6 thumbprint form.

7 (f) The gun dealer may destroy the firearms transaction thumbprint form five years after the
 8 completion of the firearms transaction thumbprint form.

9 (3)(a) Upon receipt of a request of the gun dealer for a criminal history record check, the de-
 10 partment shall immediately, during the gun dealer's telephone call or by return call:

11 (A) Determine, from criminal records and other information available to it, whether the pur-
 12 chaser is disqualified under ORS 166.470 from completing the purchase; and

13 (B) Notify the gun dealer when a purchaser is disqualified from completing the transfer or pro-
 14 vide the gun dealer with a unique approval number indicating that the purchaser is qualified to
 15 complete the transfer.

16 (b) If the department is unable to determine if the purchaser is qualified or disqualified from
 17 completing the transfer within 30 minutes, the department shall notify the gun dealer and provide
 18 the gun dealer with an estimate of the time when the department will provide the requested infor-
 19 mation.

20 (c) The dealer may not transfer the firearm **or unfinished frame or receiver** unless the dealer
 21 receives a unique approval number from the department and, within 48 hours of completing the
 22 transfer, the dealer shall notify the state that the transfer to the permit holder was completed.

23 (4)(a) Identification required of the purchaser under subsection (2) of this section shall include
 24 one piece of current identification bearing a photograph and the date of birth of the purchaser that:

25 (A) Is issued under the authority of the United States Government, a state, a political subdivi-
 26 sion of a state, a foreign government, a political subdivision of a foreign government, an interna-
 27 tional governmental organization or an international quasi-governmental organization; and

28 (B) Is intended to be used for identification of an individual or is commonly accepted for the
 29 purpose of identification of an individual.

30 (b) If the identification presented by the purchaser under paragraph (a) of this subsection does
 31 not include the current address of the purchaser, the purchaser shall present a second piece of
 32 current identification that contains the current address of the purchaser. The Superintendent of
 33 State Police may specify by rule the type of identification that may be presented under this para-
 34 graph.

35 (c) The department may require that the gun dealer verify the identification of the purchaser if
 36 that identity is in question by sending the thumbprints of the purchaser to the department.

37 (5) The department shall establish a telephone number that shall be operational seven days a
 38 week between the hours of 8 a.m. and 10 p.m. for the purpose of responding to inquiries from gun
 39 dealers for a criminal history record check under this section.

40 (6) No public employee, official or agency shall be held criminally or civilly liable for performing
 41 the investigations required by this section provided the employee, official or agency acts in good
 42 faith and without malice.

43 (7)(a) The department may retain a record of the information obtained during a request for a
 44 criminal history record check for no more than five years, except for the information provided to
 45 the dealer under subsection (2)(d) of this section, sufficient to reflect each firearm **or unfinished**

1 **frame or receiver** purchased by a permit holder, which must be attached to the electronic record
 2 of the permit stored by the department. The department may develop a system for removal of the
 3 information in subsection (2)(d)(E) of this section, upon proof of sale or transfer of the firearm **or**
 4 **unfinished frame or receiver** to another permit holder and for recording of the information to re-
 5 flect the transfer of ownership to the permit of the new owner.

6 (b) The record of the information obtained during a request for a criminal history record check
 7 by a gun dealer is exempt from disclosure under public records law.

8 (c) If the department determines that a purchaser is prohibited from possessing a firearm under
 9 ORS 166.250 (1)(c), the department shall report the attempted transfer, the purchaser's name and any
 10 other personally identifiable information to all federal, state and local law enforcement agencies and
 11 district attorneys that have jurisdiction over the location or locations where the attempted transfer
 12 was made and where the purchaser resides.

13 (d) If the department determines that, based on the judgment of conviction, the purchaser is
 14 prohibited from possessing a firearm as a condition of probation or that the purchaser is currently
 15 on post-prison supervision or parole, the department shall report the attempted transfer to the
 16 purchaser's supervising officer and the district attorney of the county in which the conviction oc-
 17 curred.

18 (e) If the department determines that the purchaser is prohibited from possessing a firearm due
 19 to a court order described in ORS 166.255 (1)(a), the department shall report the attempted transfer
 20 to the court that issued the order.

21 (f) If the department determines that the purchaser is under the jurisdiction of the Psychiatric
 22 Security Review Board, the department shall report the attempted transfer to the board.

23 (g) Reports required by paragraphs (c) to (f) of this subsection shall be made within 24 hours
 24 after the determination is made, unless a report would compromise an ongoing investigation, in
 25 which case the report may be delayed as long as necessary to avoid compromising the investigation.

26 (h) On or before January 31 of each year, a law enforcement agency or a prosecuting attorney's
 27 office that received a report pursuant to paragraph (c) of this subsection during the previous cal-
 28 endar year shall inform the department of any action that was taken concerning the report and the
 29 outcome of the action.

30 (i) The department shall annually publish a written report, based on any information received
 31 under paragraph (h) of this subsection, detailing the following information for the previous year:

32 (A) The number of purchasers whom the department determined were prohibited from possessing
 33 a firearm under ORS 166.250 (1)(c), arranged by category of prohibition;

34 (B) The number of reports made pursuant to paragraph (c) of this subsection;

35 (C) The number of investigations arising from the reports made pursuant to paragraph (c) of this
 36 subsection, the number of investigations concluded and the number of investigations referred for
 37 prosecution, all arranged by category of prohibition; and

38 (D) The number of criminal charges arising from the reports made pursuant to paragraph (c) of
 39 this subsection and the disposition of the charges, both arranged by category of prohibition.

40 (8) A law enforcement agency may inspect the records of a gun dealer relating to transfers of
 41 firearms **and unfinished frames or receivers** with the consent of a gun dealer in the course of a
 42 reasonable inquiry during a criminal investigation or under the authority of a properly authorized
 43 subpoena or search warrant.

44 (9) When a firearm is delivered, it shall be unloaded.

45 (10) In accordance with applicable provisions of ORS chapter 183, the Superintendent of State

1 Police may adopt rules necessary for:

2 (a) The design of the firearms transaction thumbprint form;

3 (b) The maintenance of a procedure to correct errors in the criminal records of the department;

4 (c) The provision of a security system to identify gun dealers that request a criminal history
5 record check under subsection (2) of this section; and

6 (d) The creation and maintenance of a database of the business hours of gun dealers.

7 (11) The department shall publish the firearms transaction thumbprint form and shall furnish the
8 form to gun dealers on application at cost.

9 (12) This section does not apply to transactions between persons licensed as dealers under 18
10 U.S.C. 923.

11 (13)(a) If requested by a transferor who is not a gun dealer, a gun dealer may request a criminal
12 background check pursuant to ORS 166.435 or 166.438 and may charge a reasonable fee for providing
13 the service.

14 (b) A gun dealer that requests a criminal background check under this subsection is immune
15 from civil liability for any use of the firearm **or unfinished frame or receiver** by the recipient or
16 transferee, provided that the gun dealer requests the criminal background check as described in this
17 section and also provided that the dealer verifies that the recipient has a valid permit-to-purchase
18 the firearm **or unfinished frame or receiver** and the dealer has received a unique approval number
19 from the department indicating successful completion of the background check.

20 (14) Knowingly selling or delivering a firearm **or unfinished frame or receiver** to a purchaser
21 or transferee who does not have a valid permit-to-purchase a firearm in violation of subsection (2)(d)
22 of this section, or prior to receiving a unique approval number from the department based on the
23 criminal background check in violation of subsection (3)(c) of this section, is a Class A misdemeanor.
