(b) Provide grants or forgivable loans to local governments to create, improve or extend 8 9 infrastructure, utilities or public services to support the development of moderate income 10 housing. 11 "(2) Forgiveable loans made under this section must have a term not exceeding 40 years. 12"(3) Proceeds from forgiveable loans and other moneys recovered under this section shall 13 be paid to the Oregon Business Development Department and deposited in the State Treasury 14 to the credit of the General Fund and are available for general governmental expenses. "(4) As used in this section, 'moderate income housing' means housing subject to an 15affordability restriction as established by rule of the Oregon Business Development Depart-16 17 ment for a household with income less than or equal to 120 percent, and greater than 60 18 percent, of the area median income. "SECTION 2. Sections 3 and 4 of this 2023 Act are added to and made a part of ORS 19 20 chapter 458.". 21In line 18, delete "2" and insert "3". In line 27, delete "3" and insert "4". 25On page 2, line 4, delete "3" and insert "4" and delete "Oregon". 2627In line 5, delete "Business Development" and insert "Housing and Community Services". 28In line 8, after "housing" insert ", as defined in section 1 of this 2023 Act". Delete lines 12 through 37 and insert: 29"SECTION 5. Sunset. Sections 1, 3 and 4 of this 2023 Act are repealed on January 2, 2026. 30 31 "SECTION 6. Appropriations. In addition to and not in lieu of any other appropriation, 32there is appropriated, for the biennium beginning July 1, 2023, out of the General Fund: "(1) To the Oregon Business Development Department, the amount of \$20,000,000 to make 33 34 grants and forgiveable loans to support moderate income housing infrastructure under sec-35 tion 1 of this 2023 Act.

1 "(2) To the Housing and Community Services Department, the amount of:

2 "(a) \$20,000,000 to provide grants to support land and predevelopment costs for moderate 3 income housing under section 3 of this 2023 Act.

4 "(b) \$20,000,000 to provide grants for moderate income housing guarantee funds under 5 section 4 of this 2023 Act.".
