

## HOUSE AMENDMENTS TO HOUSE BILL 3086

By COMMITTEE ON RULES

June 23

1 On page 1 of the printed bill, delete lines 4 through 30 and delete page 2 and insert:

2 “**SECTION 1.** ORS 496.090 is amended to read:

3 “496.090. (1) There is established a State Fish and Wildlife Commission that shall consist of  
4 seven members appointed by the Governor.

5 “(2) The term of office of each member is four years, but a member serves at the pleasure of the  
6 Governor. Before the expiration of the term of a member, the Governor shall appoint a successor.  
7 A member is eligible for reappointment. If there is a vacancy for any cause, the Governor shall make  
8 an appointment to become immediately effective for the unexpired term.

9 “(3) All appointments of members of the commission by the Governor are subject to confirmation  
10 by the Senate [*pursuant to section 4, Article III, Oregon Constitution*] **in the manner prescribed in**  
11 **ORS 171.562 and 171.565.**

12 “[*(4) One member of the commission shall be appointed from each of the congressional districts of*  
13 *this state, one member from that portion of the state lying west of the Cascade Mountains and one*  
14 *member from that portion of the state lying east of the Cascade Mountains.*]

15 “(4) **The Governor shall appoint:**

16 “(a) **Two members of the commission from the regional river basin management area set**  
17 **forth in ORS 536.022 (3)(a);**

18 “(b) **One member of the commission from the regional river basin management area set**  
19 **forth in ORS 536.022 (3)(b);**

20 “(c) **Two members of the commission from the regional river basin management area set**  
21 **forth in ORS 536.022 (3)(c);**

22 “(d) **One member of the commission from the regional river basin management area set**  
23 **forth in ORS 536.022 (3)(d); and**

24 “(e) **One member of the commission from the regional river basin management area set**  
25 **forth in ORS 536.022 (3)(e).**

26 “(5) Members appointed to the commission shall be residents of this state, as defined in ORS  
27 497.002.

28 “(6) All members of the commission shall represent the public interest of the state and make  
29 decisions affecting the wildlife resources of the state for the benefit of those resources. Consistent  
30 with the requirements of this subsection, the commission shall provide for the productive and  
31 sustainable utilization of wildlife resources for all groups of users.

32 “(7) All members of the commission shall have a general knowledge of fish and wildlife issues,  
33 **an understanding of the roles of federally recognized Indian tribes in Oregon and of the re-**  
34 **lationships federally recognized Indian tribes in Oregon have with lands, water and the na-**  
35 **tural resources that the commission governs,** and an understanding of the operation and

1 functions of public policy boards and commissions. In making appointments to the commission, the  
2 Governor shall:

3       “(a) Consider appointing members who possess [*natural resource backgrounds such as back-*  
4 *grounds in commercial fishing, recreational fishing, hunting, agriculture, forestry and conservation.*]  
5 **knowledge or experience relevant to implementing the wildlife policy set forth in ORS 496.012.**

6       “(b) **Take into consideration racial, ethnic, gender and geographic diversity.**

7       “(8) Failure of a member to maintain compliance with the eligibility requirements of subsections  
8 (4) and (5) of this section shall vacate membership. Members of the commission may otherwise be  
9 removed only by the Governor.

10       “(9) A member of the commission is entitled to compensation and expenses as provided in ORS  
11 292.495.”.
