3	On <u>page 3</u> , delete lines 1 through 27 and insert:
4	" <u>SECTION 2.</u> (1) As used in this section:
5	"(a) 'Eligible implementation coordination costs':
6	"(A) Means costs associated with actions taken to coordinate the implementation of a
7	state-recognized place-based integrated water resources plan.
8	"(B) Does not include the costs of implementing a project.
9	"(b) 'Environmental justice community' has the meaning given that term in ORS 182.535.
10	"(c) 'Indian tribe' means a federally recognized Indian tribe in Oregon that has members
11	residing on a reservation or tribal trust lands in Oregon.
12	"(d) 'Person' has the meaning given that term in ORS 536.007.
13	"(e) 'Place-based integrated water resources plan' means a plan that:
14	"(A) Is developed for a planning area associated with waters from sources within a
15	shared hydrologic boundary;
16	"(B) Is developed in collaboration with a balanced representation of interests;
17	"(C) Addresses current and future in-stream and out-of-stream needs;
18	"(D) Includes the development of actions that are consistent with the state water re-
19	sources policy and other state laws concerning the water resources of this state;
20	"(E) Is developed using an open, equitable and transparent process that fosters public
21	participation and meaningful engagement with environmental justice communities, consist-
22	ent with the requirements of ORS 182.545;
23	"(F) Is developed in consultation with the Water Resources Department and other rele-
24	vant state agencies;
25	"(G) Facilitates implementation of local water resources solutions and supports the
26	knowledge and relationships needed to implement the solutions;
27	"(H) Assesses actions that are compatible with local comprehensive plans;
28	"(I) Strives to integrate solutions to cost-effectively achieve multiple benefits;
29	"(J) Is consistent with the guiding principles of the integrated state water resources
30	strategy; and
31	"(K) Complies with the rules of the Water Resources Commission, including any rules
32	regarding the development of place-based integrated water resources plans.
33	"(f) 'Place-based integrated water resources planning' means a collaborative and inclusive
34	process that is designed to:
35	"(A) Gather information to develop a shared understanding of water resources and iden-

1 tify critical issues and knowledge gaps;

2 "(B) Examine the existing and future in-stream and out-of-stream water needs for peo-3 ple, the economy and the environment;

- 4 "(C) Identify and prioritize strategic, integrated solutions to understand and meet in-5 stream and out-of-stream water needs; and
 - "(D) Develop, implement and update a place-based integrated water resources plan.

"(g) 'Public body' has the meaning given that term in ORS 174.109.

8 "(h) 'Situation assessment' means an assessment conducted for the purpose of under-9 standing the status of an issue, stakeholder perspectives and the needs and conditions that 10 potentially affect the feasibility and design of a collaborative process to develop and imple-11 ment a place-based integrated water resources plan.

12 "(i) "State-recognized place-based integrated water resources plan' means a place-based 13 integrated water resources plan that has been reviewed by the Water Resources Commission 14 and recognized by a commission resolution stating that the completed place-based integrated 15 water resources plan adheres to applicable requirements.

"(2) The Water Resources Director may award grants with moneys from the Place-Based
 Water Planning Fund established in section 1 of this 2023 Act to fund the costs of actions
 supporting place-based integrated water resources planning, including costs of:

"(a) Filling gaps in state, tribal and local capacity, knowledge and skill sets.

20 "(b) Developing data and associated analyses tailored to the area of a place-based inte-21 grated water resources plan.

22 "(c) Assessing critical issues within the planning area.

23 "(d) Building knowledge and relationships among state agencies, organizations with ties
24 to or an interest in the planning area and people who live in, work in or are interested in the
25 planning area.

"(e) Assisting groups with preparing and assessing readiness to engage in relevant plan ning.

28 "(f) Assisting with building the capacity of a community to engage in relevant planning.

29 "(g) Facilitating and managing a collaborative process to support relevant planning.

"(h) Developing, or supporting development of, a place-based integrated water resources
 plan.

"(i) Facilitating associated public participation, including participation by members of
 environmental justice communities, through education, outreach, financial support and other
 activities.

35 "(j) Updating a state-recognized place-based integrated water resources plan.

36 "(k) Eligible implementation coordination costs.

37 "(3) In awarding grants, the department may require cost matching by applicants.

38 "(4) The grants may be awarded to persons, public bodies, Indian tribes and nonprofit 39 organizations.

40 "(5) The grants may be awarded as cost sharing with other programs that support 41 place-based integrated water resources planning.

42 "(6) In addition to disbursing moneys in the fund as described in subsection (2) of this 43 section, the Water Resources Director may use moneys in the fund to further place-based 44 integrated water resources planning by entering into agreements or contracting for the fol-45 lowing:

- 1 "(a) Efforts related to interagency coordination.
- 2 "(b) Situation assessments.
- 3 "(c) The collection or development of data, data inventories or other technical informa-
- 4 tion necessary for planning.
- 5 "(d) Technical assistance.
- 6 "(e) The development of guidelines and best practices.
- 7 "(f) Providing opportunities for public participation.
- 8 "(g) The development or provision of training and learning opportunities.
- 9 "(h) Holding events and gatherings.
- 10 "(i) Evaluations to identify lessons learned and areas for improvement.
- 11 "(j) Consultation with Indian tribes.
- "(k) Other actions in support of place-based integrated water resources planning that
 benefit a specific area in this state or the state as a whole.
- "(7) Before issuing funding under subsection (2) or (6) of this section, the Water Resources Director shall consult with the Department of Environmental Quality, Department of Land Conservation and Development, Oregon Health Authority, Oregon Watershed Enhancement Board, State Department of Agriculture and State Department of Fish and Wildlife to understand agency capacity to:
- 19 "(a) Participate in place-based integrated water resources planning.
- 20 "(b) Provide information and assistance described in subsection (9) of this section.
- "(8) Before issuing funding under subsection (2) of this section, the Water Resources
 Director shall notify county and tribal governments within the proposed planning boundary
 of an application.
- "(9) The Water Resources Department, Department of Environmental Quality, Department of Land Conservation and Development, Oregon Health Authority, Oregon Watershed Enhancement Board, State Department of Agriculture and State Department of Fish and Wildlife may provide technical information and assistance to, and enter into contracts or agreements with, a person, public body, Indian tribe or nonprofit organization to facilitate implementation of this section.
- "(10) The Water Resources Commission shall consider state-recognized place-based inte grated water resources plans when updating the integrated state water resources strategy.

"(11) The commission may adopt rules to implement this section, including rules that:

- "(a) Further clarify the expenditures that may be funded by the grants.
- 34 "(b) Prioritize the issuance of funding for purposes described in this section and establish 35 a system for scoring and ranking projects that includes consideration of groups' readiness 36 for planning and projects' alignment with strategic priorities determined by state water laws 37 and relevant state agencies.
- 38 "(c) Establish requirements for promoting public participation and engaging environ-39 mental justice communities.
- 40 "(d) Establish criteria and a process for state recognition of a place-based integrated
 41 water resources plan.
- 42 "(e) Describe how the implementation of actions outlined in a state-recognized place43 based integrated water resources plan may be considered and supported.
- 44 "(f) Establish reporting and other requirements necessary to maintain the status of a 45 state-recognized place-based integrated water resources plan, including requirements con-

1 cerning:

2 "(A) Progress on implementing a place-based integrated water resources plan.

"(B) How strategies and actions outlined in a place-based integrated water resources plan
must continue to represent a balance of in-stream and out-of-stream water interests.

5 "(C) How the planning process continues to demonstrate a commitment to collaboration

and adherence to principles of place-based integrated water resources planning and the in tegrated state water resources strategy described in ORS 536.220.

8 "(12) In developing rules described in subsection (11) of this section, the commission shall 9 consult with the agencies described in subsection (7) of this section and other affected 10 agencies.".
