

HOUSE AMENDMENTS TO HOUSE BILL 3488

1 On page 1 of the printed bill, line 2, after “homeownership” delete the rest of the line and line
2 3 and insert “; and declaring an emergency.”.

3 Delete lines 5 through 26 and delete pages 2 through 5 and insert:

4 **“SECTION 1. In addition to and not in lieu of any other appropriation, there is appro-**
5 **propriated to the Housing and Community Services Department, for the biennium beginning July**
6 **1, 2023, out of the General Fund:**

7 **“(1) The amount of \$10,000,000, for deposit into the Housing and Community Services**
8 **Department Revolving Account to provide grants to culturally responsive, culturally specific**
9 **or tribal organizations to provide down payment assistance.**

10 **“(2) The amount of \$25,000,000, for deposit into the Housing Finance Fund to provide**
11 **flexible loans to home purchasers.**

12 **“SECTION 2. In addition to and not in lieu of any other appropriation, there is appro-**
13 **propriated to the Housing and Community Services Department, for the biennium beginning July**
14 **1, 2023, out of the General Fund, the amount of \$4,000,000, to provide grants to each of the**
15 **nine federally recognized tribes in Oregon, to be used to support low-income individuals’**
16 **homeownership needs, including through down payment assistance, home purchasers’ edu-**
17 **cation and home repair programs.**

18 **“SECTION 3. In addition to and not in lieu of any other appropriation, there is appro-**
19 **propriated to the Housing and Community Services Department, for the biennium beginning July**
20 **1, 2023, out of the General Fund, the amount of \$4,800,000, to provide grants to up to 24**
21 **culturally responsive or culturally specific organizations to expand homeownership services.**

22 **“SECTION 4. In addition to and not in lieu of any other appropriation, there is appro-**
23 **propriated to the Bureau of Labor and Industries, for the biennium beginning July 1, 2023, out**
24 **of the General Fund:**

25 **“(1) The amount of \$2,400,000, to provide a grant to the Fair Housing Council of Oregon**
26 **to support fair housing in this state.**

27 **“(2) The amount of \$2,300,000, to support the bureau’s housing discrimination investi-**
28 **gations and fair housing education and outreach.**

29 **“SECTION 5. In addition to and not in lieu of any other appropriation, there is appro-**
30 **propriated to the Department of Justice, for the biennium beginning July 1, 2023, out of the**
31 **General Fund, the amount of \$500,000, to enforce fair housing laws.**

32 **“SECTION 6. This 2023 Act being necessary for the immediate preservation of the public**
33 **peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect**
34 **on July 1, 2023.”.**
