House Bill 5010

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Department of Consumer and Business Services.

Limits biennial expenditures by department from federal funds. Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2023.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> Notwithstanding any other law limiting expenditures, the following amounts 6 are established for the biennium beginning July 1, 2023, as the maximum limits for payment 7 of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but ex-8 cluding lottery funds and federal funds, collected or received by the Department of Consumer
