

A-Engrossed House Bill 5013

Ordered by the House June 2
Including House Amendments dated June 2

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Department of Early Learning and Care for certain biennial expenses.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department.

Limits biennial expenditures by department from federal funds.

Limits biennial expenditures by department for payment of operations, grants-in-aid, program costs and purchased services from certain fees, moneys or other revenues collected or received by department.

Declares emergency, effective July 1, 2023.

A BILL FOR AN ACT

Relating to the financial administration of the Department of Early Learning and Care; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There are appropriated to the Department of Early Learning and Care, for the biennium beginning July 1, 2023, out of the General Fund, the following amounts, for the following purposes:

(1) Operations..... \$ 53,847,979

(2) Early Learning Programs \$ 420,322,923

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds, corporate activity tax funds transferred from the Early Learning Account by the Department of Education and federal funds, collected or received by the Department of Early Learning and Care, for the following purposes:

(1) Operations..... \$ 7,109,409

(2) Early Learning Programs \$ 12,274,036

SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2023, as the maximum limits for payment of expenses from federal funds collected or received by the Department of Early Learning and Care, for the following purposes:

(1) Operations..... \$ 45,890,643

(2) Operations

5 **SECTION 4.** Notwithstanding any other law limiting expenditures, the following amounts
6 are established for the biennium beginning July 1, 2023, as the maximum limits for payment
7 of expenses for operations, grants-in-aid, program costs and purchased services by the De-
8 partment of Early Learning and Care from corporate activity tax funds transferred from the
9 Early Learning Account by the Department of Education, for the following purposes:

- 10 (1) Operations..... \$ 5,490,964
- 11 (2) Early learning programs..... \$432,122,205

12 **SECTION 5.** This 2023 Act being necessary for the immediate preservation of the public
13 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
