

A-Engrossed House Bill 5016

Ordered by the House May 15

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to State Department of Energy for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department.

Limits biennial expenditures by department from lottery moneys.

Limits biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2023.

A BILL FOR AN ACT

2 Relating to the financial administration of the State Department of Energy; and declaring an emer-
3 gency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There is appropriated to the State Department of Energy, for the biennium**
6 **beginning July 1, 2023, out of the General Fund, the following amounts, for the following**
7 **purposes:**

8 (1) **Energy development services.... \$ 8,635,678**

9 (2) **Nuclear safety and emergency**
10 **response \$ 82,333**

11 (3) **Small Scale Local Energy**
12 **Project Administration**
13 **and Bond Sinking Fund..... \$ 1,500,000**

14 **SECTION 2. Notwithstanding any other law limiting expenditures, the amount of**
15 **\$75,998,614 is established for the biennium beginning July 1, 2023, as the maximum limit for**
16 **payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts,**
17 **but excluding lottery funds and federal funds, collected or received by the State Department**
18 **of Energy.**

19 **SECTION 3. Notwithstanding any other law limiting expenditures, the amount of**
20 **\$1,439,160 is established for the biennium beginning July 1, 2023, as the maximum limit for**
21 **payment of expenses from lottery moneys allocated from the Administrative Services Eco-**
22 **nomic Development Fund to the State Department of Energy for debt service for the energy**
23 **efficiency and sustainable technology loan program, and for the public schools grant pro-**
24 **gram.**

1 **SECTION 4.** Notwithstanding any other law limiting expenditures, the amount of
2 \$4,191,188 is established for the biennium beginning July 1, 2023, as the maximum limit for
3 payment of expenses from federal funds collected or received by the State Department of
4 Energy.

5 **SECTION 5.** For the biennium beginning July 1, 2023, the following expenditures by the
6 State Department of Energy are not limited:

- 7 (1) Expenditures for loans for small scale local energy projects; and
8 (2) Expenditures for debt service.

9 **SECTION 6.** This 2023 Act being necessary for the immediate preservation of the public
10 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
11 July 1, 2023.
