House Bill 5016

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Appropriates moneys from General Fund to State Department of Energy for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department.

Limits biennial expenditures by department from lottery moneys.

Limits biennial expenditures by department from federal funds.

Authorizes specified nonlimited expenditures.

Declares emergency, effective July 1, 2023.

Be It Enacted by the People of the State of Oregon: 4

 $\mathbf{5}$ SECTION 1. There is appropriated to the State Department of Energy, for the biennium

6 beginning July 1, 2023, out of the General Fund, the following amounts, for the following 7 purposes:

- 8 (1) Energy development services.... \$ 5,869,582
- 9 **(2)** Nuclear safety and emergency

response \$ 82,333 10

11 (3) Small Scale Local Energy

12 **Project Administration**

13 and Bond Sinking Fund...... \$ 1,500,000

(4) Administrative services \$ 14 373.315

15 SECTION 2. Notwithstanding any other law limiting expenditures, the amount of \$75,875,894 is established for the biennium beginning July 1, 2023, as the maximum limit for 16 17 payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, 18 but excluding lottery funds and federal funds, collected or received by the State Department 19 of Energy.

20 SECTION 3. Notwithstanding any other law limiting expenditures, the amount of 21\$1,439,160 is established for the biennium beginning July 1, 2023, as the maximum limit for 22 payment of expenses from lottery moneys allocated from the Administrative Services Eco-23nomic Development Fund to the State Department of Energy for debt service for the energy 24efficiency and sustainable technology loan program, and for the public schools grant pro-25gram.

26 SECTION 4. Notwithstanding any other law limiting expenditures, the amount of 27 \$3,587,769 is established for the biennium beginning July 1, 2023, as the maximum limit for
