Senate Bill 699

Sponsored by Senator MANNING JR (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Expands definition of "public safety officer" to include certain regulatory specialists as persons who may be eligible for benefit awards from Public Safety Memorial Fund.

- 2 Relating to eligibility for benefits from the Public Safety Memorial Fund; amending ORS 243.954.
- 3 Be It Enacted by the People of the State of Oregon:
- 4 **SECTION 1.** ORS 243.954 is amended to read:
- 5 243.954. As used in ORS 243.954 to 243.974:
- 6 (1) "Child" means a person who is a natural child, adopted child or stepchild of a public safety
 7 officer and who is:
- 8 (a) 18 years of age or younger;

- (b) 18 through 22 years of age and enrolled as a full-time undergraduate student; or
- (c) 18 years of age or older and incapable of self-support due to a physical or mental disability.
- 11 (2) "Designee" means a person designated under ORS 243.974 (1).
- 12 (3) "Family member" means:
- 13 (a) The spouse of a public safety officer.
- 14 (b) A child of a public safety officer.
- 15 (c) A person who qualifies as a dependent of a public safety officer for state income tax pur-16 poses.
- 17 (4) "Permanent total disability" has the meaning given that term in ORS 656.206.
- 18 (5) "Public safety officer" means:
- 19 (a) Corrections officers, as defined in ORS 181A.355.
- 20 (b) Fire service professionals, as defined in ORS 181A.355, and includes volunteer firefighters 21 as defined in ORS 652.050.
 - (c) Parole and probation officers, as defined in ORS 181A.355.
- 23 (d) Police officers, as defined in ORS 181A.355, and includes reserve officers, as defined in ORS 181A.355.
 - (e) Regulatory specialists as defined in ORS 471.001.
 - [(e)] (f) Youth correction officers, as defined in ORS 181A.355.
- 27 (6) "Qualifying death or disability" means death or permanent total disability suffered by a 28 public safety officer while on or off duty that is:
- 29 (a) The result of an injury or occupational disease that is compensable under ORS chapter 656 30 or a disability program provided by a city having a population of more than 200,000 that provides 31 comparable benefits by ordinance or charter; or

(b) The direct or proximate result of:

- (A) An enforcement action, an emergency response or public safety training for an enforcement action or emergency response that the public safety officer is authorized or obligated to perform by law, rule, regulation or condition of employment or service; or
- (B) An act committed against the public safety officer because of the public safety officer's position as a public safety officer.
