2 "(6)(a) If a child is taken into protective custody by the department or a law enforcement offi-3 cial, the department or law enforcement official shall, if possible, make reasonable efforts to advise 4 the parents or guardian immediately, regardless of the time of day, that the child has been taken 5 into custody, the reasons the child has been taken into custody and general information about the 6 child's placement, and the telephone number of the local office of the department and any after-hours 7 telephone numbers.

8 "(b) Notice may be given by any means reasonably certain of notifying the parents or guardian, 9 including but not limited to written, telephonic or in-person oral notification. If the initial notifica-10 tion is not in writing, the information required by paragraph (a) of this subsection also shall be 11 provided to the parents or guardian in writing as soon as possible.

"(c) The department also shall make a reasonable effort to notify the noncustodial parent of the information required by paragraph (a) of this subsection in a timely manner.

"(d) If a child is taken into custody while under the care and supervision of a person or organization other than the parent, the department, if possible, shall immediately notify the person or organization that the child has been taken into protective custody.

"(7) If a law enforcement officer or the department, when taking a child into protective custody, has reasonable cause to believe that the child has been affected by sexual abuse and rape of a child as defined in ORS 419B.005 (1)(a)(C) and that physical evidence of the abuse exists and is likely to disappear, the court may authorize a physical examination for the purposes of preserving evidence if the court finds that it is in the best interest of the child to have such an examination. Nothing in this section affects the authority of the department to consent to physical examinations of the child at other times.

"(8) A minor child of 12 years of age or older may refuse to consent to the examination described in subsection (7) of this section. The examination shall be conducted by or under the supervision of a physician licensed under ORS chapter 677, a physician assistant licensed under ORS 677.505 to 677.525 or a nurse practitioner licensed under ORS chapter 678 and, whenever practicable, trained in conducting such examinations.

29 "(9) When the department completes an investigation under this section, if the person who made 30 the report of child abuse provided contact information to the department, the department shall no-31 tify the person about whether contact with the child was made, whether the department determined 32 that child abuse occurred and whether services will be provided. The department is not required to 33 disclose information under this subsection if the department determines that disclosure is not per-34 mitted under ORS 419B.035.

35 "(10) When the Department of Education receives a notification under subsection (1) of this 36 section or a report on the outcomes of an investigation under subsection (3) of this section, the de-37 partment shall act under, and is subject to, ORS 339.389.

38 "<u>SECTION 7.</u> (1) Section 1 of this 2023 Act and the amendments to ORS 329A.030 by 39 sections 2 and 3 of this 2023 Act apply to background checks completed on or after the ef-40 fective date of this 2023 Act.
