SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Requires Bureau of Labor and Industries to study issues relating to different leave laws under which individuals may take time off of work for qualifying reasons. Directs bureau to submit findings to interim committees of Legislative Assembly related to labor and business not later than September 15, 2024.]

Clarifies meaning of "one-year period" for purposes of determining amount of unpaid family leave that eligible employee is entitled to take within any given one-year period.

Requires Employment Department to adopt rules establishing factors for determining whether significant personal bond exists to determine individual's status as family member by reason of affinity for purposes of paid family and medical leave. For purposes of unpaid family leave, requires Commissioner of Bureau of Labor and Industries to adopt rules relating to affinity that are consistent with rules adopted by Employment Department. Expands definition of "family member" for purposes of provisions related to unpaid fam-

Expands definition of "family member" for purposes of provisions related to unpaid family leave.

Clarifies employer obligations with respect to continuation of benefits during and after period of paid family and medical leave.

Clarifies employer obligations regarding job protection after period of protected paid family and medical leave or unpaid family leave.

Clarifies provisions related to coordination of leave taken under provisions related to paid family and medical leave program and provisions related to unpaid family leave.

Declares emergency, effective on passage.

6	OREGON FAMILY LEAVE ACT

8	SECTION 1. Sections 2 and 3 are added to and made a part of ORS 659A.150 to 659A.186.
9	SECTION 2. (1) For purposes of determining the amount of family leave that an eligible
10	employee is entitled to take within a given one-year period, "one-year period" means a period
11	of 52 consecutive weeks beginning on the Sunday immediately preceding the date on which
12	family leave commences.
13	(2) The Commissioner of the Bureau of Labor and Industries may adopt any rules nec-
14	essary to implement and administer this section.
15	SECTION 3. (1) In order to determine whether an individual qualifies as a family member
16	by reason of affinity, as that term is used in ORS 659A.150, consideration shall be given to
17	whether there exists a significant personal bond attributable to factors, established by the

1	Commissioner of the Bureau of Labor and Industries by rule, that when examined in total,
2	resemble a family relationship.
3	(2) The Commissioner of the Bureau of Labor and Industries shall adopt rules necessary
4	to implement and administer subsection (1) of this section. The rules may include rules for
5	developing and using an attestation form by which an employee may attest to the affinity
6	factors described in subsection (1) of this section. Any rules adopted under this subsection
7	relating to the factors described under subsection (1) of this section shall be consistent with
8	the rules established by the Employment Department under section 8 of this 2023 Act.
9	SECTION 4. ORS 659A.150 is amended to read:
10	659A.150. As used in ORS 659A.150 to 659A.186:
11	(1) "Covered employer" means an employer described in ORS 659A.153.
12	(2) "Eligible employee" means any employee of a covered employer other than those employees
13	exempted under the provisions of ORS 659A.156.
14	(3) "Family leave" means a leave of absence described in ORS 659A.159, except that "family
15	leave" does not include leave taken by an eligible employee who is unable to work because of a
16	disabling compensable injury, as defined in ORS 656.005, under ORS chapter 656.
17	(4) "Family member" means [the spouse of an employee, the biological, adoptive or foster parent
18	or child of the employee, the grandparent or grandchild of the employee, a parent-in-law of the employee
19	or a person with whom the employee was or is in a relationship of in loco parentis.]:
20	(a) The spouse of a covered individual;
21	(b) A child of a covered individual or the child's spouse or domestic partner;
22	(c) A parent of a covered individual or the parent's spouse or domestic partner;
23	(d) A sibling or stepsibling of a covered individual or the sibling's or stepsibling's spouse
24	or domestic partner;
25	(e) A grandparent of a covered individual or the grandparent's spouse or domestic part-

31	(5) "Health care provider" means:
32	(a) A person who is primarily responsible for providing health care to an eligible employee or
33	a family member of an eligible employee, who is performing within the scope of the person's pro-
34	fessional license or certificate and who is:
35	(A) A physician licensed under ORS chapter 677;
36	(B) A physician assistant licensed under ORS 677.505 to 677.525;
37	(C) A dentist licensed under ORS 679.090;
38	(D) A psychologist licensed under ORS 675.030;
39	(E) An optometrist licensed under ORS 683.070;
40	(F) A naturopath licensed under ORS 685.080;
41	(G) A registered nurse licensed under ORS 678.050;
42	(H) A nurse practitioner licensed under ORS 678.375;
43	(I) A direct entry midwife licensed under ORS 687.420;

(b) A person who is primarily responsible for the treatment of an eligible employee or a family 6 member of an eligible employee solely through spiritual means, including but not limited to a 7 8 Christian Science practitioner.

9 (6) "Public health emergency" means:

(a) A public health emergency declared under ORS 433.441. 10

(b) An emergency declared under ORS 401.165 if related to a public health emergency as defined 11 12 in ORS 433.442.

13 (7) "Serious health condition" means:

(a) An illness, injury, impairment or physical or mental condition that requires inpatient care 14 15 in a hospital, hospice or residential medical care facility;

16 (b) An illness, disease or condition that in the medical judgment of the treating health care provider poses an imminent danger of death, is terminal in prognosis with a reasonable possibility 17 18 of death in the near future, or requires constant care;

(c) Any period of disability due to pregnancy, or period of absence for prenatal care; or

20(d) Any period of absence for the donation of a body part, organ or tissue, including preoperative 21or diagnostic services, surgery, post-operative treatment and recovery.

SECTION 5. ORS 659A.171 is amended to read:

23659A.171. (1) After returning to work after taking family leave under the provisions of ORS 659A.150 to 659A.186, an eligible employee is entitled to be restored to the position of employment 2425held by the employee when the leave commenced if that position still exists, without regard to whether the employer filled the position with a replacement worker during the period of family 2627leave. If the position held by the employee at the time family leave commenced no longer exists, the employee is entitled to be restored to any available equivalent position with equivalent employment 28benefits, pay and other terms and conditions of employment. If an equivalent position is not avail-2930 able at the job site of the employee's former position, the [employee may be offered] employer shall 31 offer the employee an equivalent position at a job site located within [20] 50 miles of the job site of the employee's former position, if such a position is available. If equivalent positions are 32available at multiple job sites, the employer shall first offer the employee the position at the 33 34 job site that is nearest to the job site of the employee's former position.

(2) Except for employee benefits used during the period of leave, the taking of family leave under 35 ORS 659A.150 to 659A.186 shall not result in the loss of any employment benefit accrued before the 36 37 date on which the leave commenced.

(3) This section does not entitle any employee to:

(a) Any accrual of seniority or employment benefits during a period of family leave; or 39

40 (b) Any right, benefit or position of employment other than the rights, benefits and position that the employee would have been entitled to had the employee not taken the family leave. 41

42(4)(a) Before restoring an employee to a position under subsection (1) of this section, an employer may require that the employee receive certification from the employee's health care provider 43 that the employee is able to resume work. Certification under this subsection may only be required 44 pursuant to a uniformly applied practice or policy of the employer. 45

1 (b) This subsection does not affect the ability of an employer to require an employee during a 2 period of family leave to report periodically to the employer on the employee's status and on the 3 employee's intention to return to work.

4 (5)(a) Except as provided in paragraph (b) of this subsection, benefits are not required to con-5 tinue to accrue during a period of family leave unless continuation or accrual is required under an 6 agreement of the employer and the employee, a collective bargaining agreement or an employer 7 policy.

8 (b) If the employee is provided group health insurance, the employee is entitled to the contin-9 uation of group health insurance coverage during the period of family leave on the same terms as 10 if the employee had continued to work. If family member coverage is provided to the employee, 11 family member coverage must be maintained during the period of family leave. The employee must 12 continue to make any regular contributions to the cost of the health insurance premiums.

(c) Notwithstanding ORS 652.610 (3) and except as provided in paragraph (b) of this subsection, if the employer is required or elects to pay any part of the costs of providing disability, life or other insurance coverage for an employee during the period of family leave that should have been paid by the employee, the employer may deduct from the employee's pay such amounts upon the employee's return to work until the amount the employer advanced toward the payments is paid. In no event may the total amount deducted for insurance under the provisions of this subsection exceed 10 percent of the employee's gross pay each pay period.

(6) Notwithstanding ORS 652.610 (3), if the employer pays any part of the costs of health, disability, life or other insurance coverage for an employee under the provisions of subsection (5) of this section, and the employee does not return to employment with the employer after taking family leave, the employer may deduct amounts paid by the employer from any amounts owed by the employer to the employee, or may seek to recover those amounts by any other legal means, unless the employee fails to return to work because of:

(a) A continuation, reoccurrence or onset of a serious health condition that would entitle the
employee to leave for one of the purposes specified by ORS 659A.159 (1)(b) or (c); or

28 (b) Other circumstances beyond the control of the employee.

29 **SECTION 6.** ORS 659A.186 is amended to read:

659A.186. (1) ORS 659A.150 to 659A.186 do not limit any right of an employee to any leave that is similar to the leave described in ORS 659A.159 (1) and to which the employee may be entitled under any agreement between the employer and the employee, collective bargaining agreement or employer policy.

34 (2) ORS 659A.150 to 659A.186 shall be construed to the extent possible in a manner that is consistent with any similar provisions of the federal Family and Medical Leave Act of 1993. [Family 35 leave] If family leave taken under ORS 659A.150 to 659A.186 qualifies as protected leave pursu-36 37 ant to the federal Family and Medical Leave Act of 1993 (P.L. 103-3) or qualifies as family 38 leave or medical leave taken pursuant to ORS chapter 657B, family leave taken under ORS 659A.150 to 659A.186 must be taken concurrently with, and not in addition to, any leave taken 39 under the federal Family and Medical Leave Act of 1993 (P.L. 103-3) and under ORS chapter 40 41 657B.

SECTION 7. Section 8 of this 2023 Act is added to and made a part of ORS chapter 657B.

1 <u>SECTION 8.</u> (1) In order to determine whether an individual qualifies as a family member 2 by reason of affinity, as that term is used in ORS 657B.010, consideration shall be given to 3 whether there exists a significant personal bond attributed to factors, established by the 4 Director of the Employment Department by rule, that when examined in total, resemble a 5 family relationship.

6 (2) Rules adopted by the director under this section may include rules for developing and 7 using an attestation form by which an employee may attest to the affinity factors described 8 in subsection (1) of this section.

SECTION 9. ORS 657B.060 is amended to read:

657B.060. (1)(a) Except as provided in paragraph (b) of this subsection, after returning to work 10 after a period of family leave, medical leave or safe leave, an eligible employee is entitled to be re-11 12 stored to the position of employment held by the employee when the leave commenced, if that posi-13 tion still exists, without regard to whether the employer filled the position with a replacement worker during the period of leave. If the position held by the employee at the time leave commenced 14 15 no longer exists, the employee is entitled to be restored to any available equivalent position with 16 equivalent employment benefits, pay and other terms and conditions of employment. If an equivalent position is not available at the job site of the employee's former position, the employer 17 18 shall offer the employee an equivalent position at a job site located within 50 miles of the job 19 site of the employee's former position, if such a position is available. If equivalent positions 20are available at multiple job sites, the employer shall first offer the employee the position at the job site that is nearest to the job site of the employee's former position. 21

(b) For employers that employ fewer than 25 employees, if the position held by an eligible employee when the employee's leave commenced no longer exists, an employer may, at the employer's discretion based on business necessity, restore the eligible employee to a different position with similar job duties and with the same employment benefits and pay.

(2)(a) During a period in which an eligible employee takes leave described under subsection (1) of this section, the employer shall maintain any health care benefits the employee had prior to taking such leave for the duration of the leave, as if the employee had continued in employment continuously during the period of leave. The employee must continue to make any regular contributions to the cost of the health insurance premiums.

31 (b) Notwithstanding ORS 652.610 (3) and except as provided in paragraph (a) of this subsection, if the employer is required or elects to pay any part of the costs of providing disa-32bility, life or other insurance coverage for an eligible employee during the period of family 33 34 leave that should have been paid by the employee, the employer may deduct from the 35 employee's pay such amounts upon the employee's return to work until the amount the employer advanced toward the payments is paid.
