Senate Bill 1028

Sponsored by COMMITTEE ON JUDICIARY (at the request of Senator Tim Knopp, Jenn Woodward)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies definition of "abuse" for purposes of child abuse to include verbal abuse. Defines "verbal abuse."
