SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Requires Department of Human Services to study disposition rates of child abuse investigations. Directs department to submit findings to interim committees of Legislative Assembly related to human services not later than September 15, 2024.]

Exempts employee of youth correction facility or juvenile detention facility from specified prohibitions on use of restraint or seclusion on students in public education programs.

Modifies provisions regarding use of restraint or seclusion on children in care. Modifies definition of "abuse" for purposes of child abuse reporting and investigation. Permits Department of Human Services to disclose child abuse investigation reports and records to designated national nonprofit organization that provides assistance locating, recovering or providing services to missing children. Modifies definition of "board" for purposes of professional misconduct oversight to in-

clude Behavior Analysis Regulatory Board.

Takes effect on 91st day following adjournment sine die.

5 (c) That the report is inconclusive. A report is inconclusive when there is some indication that 6 the abuse occurred but there is insufficient evidence to conclude that there is reasonable cause to 7 believe that the abuse occurred.

(3)(a) The department may interview the child in care who is the subject of suspected abuse and any witnesses, including other children, without the presence of employees of the child-caring agency, proctor foster home or developmental disabilities residential facility, the provider of services at a certified foster home or department personnel. The department shall inform the child in care that the child may have the child's parent or guardian, if the child has not been committed to the custody of the department or the Oregon Youth Authority, or attorney present when participating in an interview conducted in the course of an abuse investigation.

(b) When investigating an allegation of inappropriate use of restraint or involuntary seclusion,the department shall:

(A) Conduct the interviews described in paragraph (a) of this subsection;

(B) Review all relevant incident reports related to the child in care and other reports relatedto the restraint or involuntary seclusion of the child in care;

(C) Review any audio, video or photographic recordings of the restraint or involuntary seclusion,
 including the circumstances immediately before and following the incident;

(D) During an interview with the child in care who is the subject of the suspected abuse, ask
the child about whether they experienced any reportable injury or pain as a result of the restraint
or involuntary seclusion;

31 (E) Review the training records related to all of the individuals who were involved in the use 32 of restraint or involuntary seclusion; and

(F) Make all reasonable efforts to conduct trauma-informed interviews of each child witness, including the child in care who is the subject of suspected abuse unless the investigator makes a specific determination that the interview may significantly traumatize the child and is not in the best interests of the child.

(4) The department shall notify the following when a report of abuse is substantiated:(a) The Director of Human Services.

(b) Personnel in the department responsible for the licensing, certificate or authorization ofchild-caring agencies.

The reporting licensee shall report the conduct without undue delay, but in no event later than 10 working days after the reporting licensee learns of the conduct.

(3) A licensee who is convicted of a misdemeanor or felony or who is arrested for a felony crime
shall report the conviction or arrest to the licensee's board within 10 days after the conviction or
arrest.

(4) The board responsible for a licensee who is reported to have engaged in prohibited or unprofessional conduct shall investigate in accordance with the board's rules. If the board has reasonable cause to believe that the licensee has engaged in prohibited conduct, the board shall present the facts to an appropriate law enforcement agency without undue delay, but in no event later than 10 working days after the board finds reasonable cause to believe that the licensee engaged in prohibited conduct.

(5) A licensee who fails to report prohibited or unprofessional conduct as required by subsection
(2) of this section or the licensee's conviction or arrest as required by subsection (3) of this section
is subject to discipline by the board responsible for the licensee.

(6) A licensee who fails to report prohibited conduct as required by subsection (2) of this section
