SUMMARY

Extends sunset provisions for various tax credits.

Be It Enacted by the People of the State of Oregon:

6 **SECTION 1.** Section 19, chapter 954, Oregon Laws 2001, as amended by section 35, chapter 913,
7 Oregon Laws 2009, section 8, chapter 750, Oregon Laws 2013, and section 18, chapter 579, Oregon
8 Laws 2019, is amended to read:

10 **Sec. 19.** ORS 315.675 applies to tax years beginning on or after January 1, 2002, and before
11 January 1, [2026] **2028**.
