SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates and modernizes statutes that regulate practice of architecture in this state to conform with actual current practice of architecture.

Takes effect on 91st day following adjournment sine die.

2 Relating to the regulation of the practice of architecture in this state; creating new provisions;
3 amending ORS 455.062, 455.628, 671.010, 671.020, 671.025, 671.030, 671.041, 671.045, 671.047,
4 671.050, 671.065, 671.080, 671.085, 671.090, 671.100, 671.120, 671.125, 671.220 and 671.990; repealing
5 ORS 671.060 and 671.105; and prescribing an effective date.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 671.010 is amended to read:

8 671.010. As used in ORS 671.010 to 671.220[*unless the context requires otherwise*]:

9 [(1) "*Architect*" means an individual qualified and registered to practice architecture under ORS
10 671.010 to 671.220, a consulting architect or a foreign architect.]

11 [(2) "*Board*" means the State Board of Architect Examiners.]

12 [(3) "*Building*" means any structure consisting of foundations, floors, walls and roof, having
13 footings, columns, posts, girders, beams, joists, rafters, bearing partitions, or a combination of any
14 number of these parts, with or without other parts or appurtenances thereto.]

15 [(4) "*Consulting architect*" means a person who is licensed or registered by a jurisdiction in the
16 United States or Canada to use the title of "Architect" and engage in the unlimited practice of archi-
17 tecture and who is not subject to practice restrictions as the result of disciplinary action by any ar-
18 chitect licensing or registration board.]

19 [(5) "*Firm*" means a corporation, limited liability company or partnership operating under a cor-
20 porate or assumed business name and engaging in the provision of architectural services.]

21 [(6) "*Foreign architect*" means a person who is licensed or registered by a country other than the
22 United States or Canada to use the title of "Architect" and engage in the unlimited practice of archi-
23 tecture and who is not subject to practice restrictions as a result of disciplinary action by the architect
24 licensing or registration board issuing the license or registration.]

25 [(7) "*Practice of architecture*" means the planning, designing or observing of the erection, enlarge-
26 ment or alteration of any building or of any appurtenance thereto other than exempted buildings.]

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 [(8) "Registered professional engineer" has the meaning given that term in ORS 672.002.]

2 (1) "Architect" means a registered architect or a foreign architect.

3 (2) "Architectural firm" means a business entity that, for compensation, provides the
4 services of an architect or engages in the practice of architecture.

5 (3) "Building" means a structure that has the purpose of supporting or sheltering any
6 use or occupancy.

7 (4) "Business entity" means a partnership, limited partnership, corporation, professional
8 corporation, limited liability company, business trust, joint venture or other form of business
9 organization the constituent parts of which share a common economic interest.

10 (5) "Construction phase services" means services an architect provides for the purpose
11 of determining that construction work on a building is proceeding generally in accordance
12 with requirements set forth in a technical submission.

13 (6) "Foreign architect" means a person that has a valid license or registration from a
14 jurisdiction other than this state that authorizes the person to engage in the practice of
15 architecture within the jurisdiction that issued the license or registration.

16 (7) "Foreign architectural firm" means a business entity that has a valid license or reg-
17 istration from a jurisdiction other than this state that authorizes the business entity to en-
18 gage in the practice of architecture within the jurisdiction that issued the license or
19 registration.

20 (8) "Practice of architecture" means engaging in the art and science of designing, in
21 whole or in part, buildings and the space within and appurtenant to buildings and providing
22 related services that include, but are not limited to, planning, developing design concepts,
23 preparing technical submissions and other documents that define a building's form and
24 function, coordinating construction work and the work of other consultants and providing
25 construction phase services.

26 (9) "Registered architect" means an individual who has a valid certificate of registration
27 issued by the State Board of Architect Examiners under ORS 671.010 to 671.220 that author-
28 izes the individual to engage in the practice of architecture within this state.

29 (10) "Registered architectural firm" means a business entity that has a valid certificate
30 of registration issued by the State Board of Architect Examiners under ORS 671.010 to
31 671.220 that authorizes the business entity to engage in the practice of architecture within
32 this state.

33 (11) "Responsible control" means a degree of control over an operation that is consistent
34 with the scope of a registered architect's professional knowledge and the application of a
35 registered architect's professional standard of care.

36 [(9)] (12) "State building code" has the meaning given that term in ORS 455.010.

37 (13) "Technical submission" means a plan, design, drawing, blueprint or other document
38 that an architect prepares in connection with the practice of architecture and submits to a
39 regulatory authority to comply with the state building code, a municipal building code or
40 related rules, ordinances, resolutions or other regulatory requirements.

41 **SECTION 2.** ORS 671.020 is amended to read:

42 671.020. [(1) *In order to safeguard health, safety and welfare and to eliminate unnecessary loss and*
43 *waste in this state, a person may not engage in the practice of architecture or assume or use the title*
44 *of "Architect" or any title, sign, cards or device indicating, or tending to indicate, that the person is*
45 *practicing architecture or is an architect or represent in any manner that the person is an architect,*

1 *without first qualifying before the State Board of Architect Examiners and obtaining a certificate of*
2 *registration as provided by ORS 671.010 to 671.220.]*

3 *[(2) Notwithstanding subsection (1) of this section, a consulting architect may engage in the practice*
4 *of architecture if the consulting architect:]*

5 *[(a) Is affiliated with an Oregon-registered architect who is in responsible charge of all aspects of*
6 *the architectural services provided; and]*

7 *[(b) Uses the designation of "Consulting Architect, in consultation with," followed by the name of*
8 *the Oregon-registered architect described in paragraph (a) of this subsection and the name of the ar-*
9 *chitectural firm.]*

10 *[(3) Notwithstanding subsection (1) of this section, a foreign architect may engage in the practice*
11 *of architecture if:]*

12 *[(a) The foreign architect is affiliated with an Oregon-registered architect who is in responsible*
13 *charge of all aspects of the architectural services provided;]*

14 *[(b) The foreign architect uses the designation of "Foreign Architect, in consultation with," followed*
15 *by the name of the Oregon-registered architect described in paragraph (a) of this subsection and the*
16 *name of the architectural firm; and]*

17 *[(c) The board determines that the jurisdiction in which the foreign architect is licensed or regis-*
18 *tered has adequate education and training standards. The board, by rule, may recognize agreements*
19 *between a national certification organization and the foreign jurisdiction as proof of education and*
20 *training standards.]*

21 *[(4) A person may not practice or attempt to practice the profession of architecture, or assume the*
22 *title of "Architect," "Consulting Architect" or "Foreign Architect," or use in connection with the busi-*
23 *ness of the person any words, letters or figures indicating the title of "Architect," "Consulting*
24 *Architect" or "Foreign Architect" without first complying with ORS 671.010 to 671.220.]*

25 *[(5) Every registered architect shall, upon registration, obtain a stamp of the design authorized by*
26 *the board. All drawings and the title page of all specifications intended for use as construction docu-*
27 *ments in the practice of architecture must bear the stamp of a registered architect and be signed by the*
28 *architect. The stamp and signature constitute certification that the architect has exercised the requisite*
29 *professional judgment about and made the decisions upon all matters embodied within those con-*
30 *struction documents, that the documents were prepared either by the architect or under the direct con-*
31 *trol and supervision of the architect and that the architect accepts responsibility for the documents.]*

32 *[(6) Except as provided in ORS 671.041, an architect registered under ORS 671.010 to 671.220 may*
33 *pursue the practice of architecture only under the architect's own name as that name appears in the*
34 *certificate of registration.]*

35 **(1) Except as provided in subsection (2) of this section, an individual or business entity**
36 **that does not have a valid certificate of registration from the State Board of Architect Ex-**
37 **aminers may not:**

38 **(a) Engage in the practice of architecture within this state;**

39 **(b) Assume or use a title, form of address or other designation within this state that**
40 **indicates or reasonably could be understood to indicate that the individual is an architect or**
41 **that the individual or business entity engages in the practice of architecture; or**

42 **(c) State, declare, represent or otherwise purport in any title, sign, card, device, adver-**
43 **tisement or other indication of the individual's or the business entity's business or occupa-**
44 **tion that the individual is an architect or that the individual or business entity engages in**
45 **the practice of architecture within this state.**

1 **(2) An individual who does not have the certificate of registration under subsection (1)**
2 **of this section may engage in the practice of architecture within this state and use a desig-**
3 **nation that indicates that the individual is an architect or engages in the practice of archi-**
4 **ture if the individual:**

5 **(a) Is a foreign architect;**

6 **(b) Has a written agreement of affiliation with a registered architect or registered ar-**
7 **chitectural firm under which the registered architect or registered architectural firm has**
8 **responsible control over all aspects of the architectural services the individual provides; and**

9 **(c) Uses the designation “foreign architect, in consultation with” followed by the name**
10 **of a registered architect and the registered architect’s registered architectural firm, if any,**
11 **on all technical submissions, advertisements or other communications that purport to iden-**
12 **tify the foreign architect’s profession, occupation or business within this state.**

13 **(3) Upon receiving a certificate of registration from the board, a registered architect**
14 **shall obtain a stamp that conforms with a design that the board specifies by rule. The stamp,**
15 **when accompanied by the registered architect’s signature on any technical submission, con-**
16 **stitutes the registered architect’s attestation that the registered architect has responsible**
17 **control over the content of the technical submission. The registered architect is responsible**
18 **for controlling the custody and use of the stamp.**

19 **(4) A registered architect may engage in the practice of architecture only under the**
20 **registered architect’s own name, as that name appears on the certificate of registration,**
21 **except that the registered architect may practice under the name or assumed business name**
22 **of a registered architectural firm, as provided in ORS 671.041.**

23 **SECTION 3.** ORS 671.025 is amended to read:

24 671.025. (1) Any person applying for a license or permit required under the laws of this state
25 or **under** the ordinances of any jurisdiction in **this state within** which the person proposes to erect,
26 construct, enlarge, alter, repair, move, improve, remove or convert a building shall submit an ori-
27 ginal or reproduction of the [*drawings and specifications*] **technical submissions** for the work pro-
28 posed. The [*drawings and specifications*] **technical submissions** must:

29 (a) Bear the stamp **and signature** of a registered architect [*or registered professional engineer*]
30 if the services of a registered architect [*or registered professional engineer*] are required under ORS
31 671.010 to 671.220; and

32 (b) Be [*drawn to scale with sufficient clarity*] **sufficiently clear** to indicate the nature and extent
33 of the work proposed and that the work proposed conforms with the requirements of ORS 671.010
34 to 671.220, the state building code and any other applicable laws and ordinances.

35 (2) The [*drawings and specifications*] **technical submissions** must bear identification that in-
36 cludes, but is not limited to:

37 (a) The project name and location;

38 (b) The name, address and telephone number of the person responsible for [*the preparation of the*
39 *documents*] **preparing the technical submissions, including technical submissions the person**
40 **prepared on behalf of another person;**

41 (c) The name, address and telephone number of the owner; and

42 (d) The date the documents were issued.

43 (3) Each jurisdiction that requires the issuance of a permit as a condition precedent to the
44 construction, alteration, improvement or repair of any building or structure shall require the sig-
45 nature and [*registration*] **an impression of the stamp described in ORS 671.020 (3)** on the

1 [drawings and specifications] **technical submissions** from a person authorized to prepare the
2 [drawings and specifications] **technical submissions.**

3 (4) The [registration] **registered architect's** stamp and signature on the [drawings and specifi-
4 cations] **technical submissions** [of the architect or engineer preparing the drawings and
5 specifications] constitute compliance with this section.

6 [(5) This section does not apply to the issuance of permits if the preparation of the drawings and
7 specifications for the construction, alteration, improvement or repair of a building or structure is ex-
8 empt from the provisions of this section, except that the person preparing the drawings and specifica-
9 tions for others shall be so identified.]

10 (5) **An architect shall retain, for a period of not less than 10 years following the com-
11 pletion of the project for which the architect submitted technical submissions, records and
12 documentation that demonstrate the architect's responsible control over the preparation of
13 the technical submissions.**

14 **SECTION 4.** ORS 671.030 is amended to read:

15 671.030. (1) ORS 671.010 to 671.220 do not apply to the practice of **marine**, naval or landscape
16 architecture [or of engineering by a registered professional engineer or a person engaged in architec-
17 ture or engineering work as an employee of an architect or registered professional engineer].

18 (2) ORS 671.010 to 671.220 do not prohibit:

19 [(a) Draftsmen, clerks of the work, superintendents and other Employees of registered architects
20 and registered professional engineers from acting under the instructions, control or supervision of their
21 employers. A draftsman, clerk, superintendent or other employee may not use the designation
22 "architect," "architectural" or "architecture" unless registered under the provisions of ORS 671.010 to
23 671.220, or unless a title containing the designation is provided by rule of the State Board of Architect
24 Examiners.]

25 [(b) A person from making drawings or specifications for, or observing the erection, enlargement
26 or alteration of, a building, or an appurtenance to a building, if the building:]

27 (a) **An employee of a registered architect from acting under the registered architect's
28 instruction, control or supervision. An employee who is not a registered architect may not
29 use the designation "architect," "registered architect" or "foreign architect" or the words
30 "architecture" or "architectural" to describe the employee's work unless a rule of the State
31 Board of Architect Examiners provides otherwise.**

32 (b) **A person that is not an architect from preparing technical submissions or providing
33 construction phase services related to erecting, enlarging or altering a building or an
34 appurtenance to a building if the building or the appurtenance:**

35 (A) Is [to be used for] a single family residential dwelling or farm building; [or]

36 (B) Is a structure used in connection with or auxiliary to a single family residential dwelling
37 or farm building, including but not limited to a three-car garage, barn or shed or a shelter used for
38 the housing of domestic animals or livestock[.]; **or**

39 [(c)] (C) [A person from making drawings or specifications for, or observing the erection, enlarge-
40 ment or alteration of, a building, or an appurtenance to a building, if the building] Has a ground area
41 of 4,000 square feet or less and is not more than 20 feet in height from the top surface of lowest
42 flooring to the highest interior overhead finish [of the structure].

43 [(d)] (c) A person from planning, designing, specifying or observing the alterations or repairs to
44 a building if:

45 (A) The structural part of the building, including but not limited to the foundation walls, floors,

1 roof, footings, bearing partitions, beams, columns and joists, is not involved;

2 (B) The building code classification by use or occupancy of the building is not changed; and

3 (C) The building code classification by type of construction of the building is not changed.

4 [(e)] (d) A contractor [*or duly appointed superintendent or foreman*] from directing the work of
5 erecting, enlarging or altering a building, or an appurtenance to a building, under the observation
6 of a registered architect [*or under the supervision of a registered professional engineer*].

7 [(f)] (e) A person practicing marine, naval or landscape architecture from purporting to be a
8 marine, naval or landscape architect if the work is confined and limited to those classifications.

9 [(g)] (f) A construction contractor licensed under ORS chapter 701 from offering services con-
10 stituting the practice of architecture if:

11 (A) **The construction contractor's offer discloses in writing that the construction con-**
12 **tractor is not an architect and identifies the registered architect or registered architectural**
13 **firm that will provide the architectural services;**

14 [(A)] (B) The services are [*appurtenant*] **ancillary** to construction services [*to be provided by*
15 *the*] **the construction contractor will provide; and**

16 [(B)] (C) **A registered architect or registered architectural firm provides** the services con-
17 stituting the practice of architecture. [*are performed by an architect registered under ORS 671.010*
18 *to 671.220 or provided by a firm registered under ORS 671.010 to 671.220; and*]

19 [(C)] *The offer by the construction contractor discloses in writing that the contractor is not an ar-*
20 *chitect and identifies the registered architect who will perform the services constituting the practice of*
21 *architecture or the firm that will provide the architectural services.]*

22 **SECTION 5.** ORS 671.041 is amended to read:

23 671.041. [(1) *As used in this section, "corporate firm" includes a domestic private corporation, for-*
24 *oreign private corporation, domestic cooperative corporation, foreign cooperative corporation, domestic*
25 *professional corporation and foreign professional corporation.]*

26 [(2) *A firm may engage in the provision of architectural services in this state under a corporate*
27 *or assumed business name if:]*

28 [(a) *At least two-thirds of the board of directors of a corporate firm, or owners having at least a*
29 *two-thirds ownership interest in a noncorporate firm, are registered or licensed as architects or as en-*
30 *gineers in any jurisdiction recognized by rule of the State Board of Architect Examiners or the State*
31 *Board of Examiners for Engineering and Land Surveying;]*

32 [(b) *At least one-third of the board of directors of a corporate firm or owners having at least a*
33 *one-third ownership interest in a noncorporate firm are architects registered or licensed in any juris-*
34 *isdiction recognized by rule of the State Board of Architect Examiners;]*

35 [(c) *All persons in charge of the practice of architecture in this state for the firm are:]*

36 [(A) *Members of the board of directors or owners of the firm;]*

37 [(B) *Regularly employed in the office of the firm that directs and has supervisory control of the*
38 *practice of architecture in this state; and]*

39 [(C) *Registered as architects under ORS 671.010 to 671.220;]*

40 [(d) *The corporate or assumed business name does not include the surname of an individual who*
41 *is not presently or was not previously associated in the practice of architecture or engineering in this*
42 *state or in any jurisdiction recognized by rule of the State Board of Architect Examiners or the State*
43 *Board of Examiners for Engineering and Land Surveying with the named entity or with the members*
44 *or predecessors of the named entity; and]*

45 [(e) *The corporate or assumed business name identifies the firm as being engaged in the provision*

1 *of architectural services.]*

2 *[(3) A firm must register with the State Board of Architect Examiners before the firm may provide*
3 *architectural services. A firm must file a renewal of the registration as provided by rule of the*
4 *board.]*

5 *[(4) All professional documents issued by the firm that are required by ORS 671.010 to 671.220 to*
6 *bear the stamp of an architect must bear the stamp of the architect responsible for the preparation of*
7 *the documents and bear the corporate or assumed business name of the firm.]*

8 *[(5) Notwithstanding subsections (2) and (3) of this section, a professional corporation that existed*
9 *on September 29, 1991, may engage in the provision of architectural services if the stockholders owning*
10 *a majority of the stock of the corporation are registered as architects under ORS 671.010 to 671.220*
11 *or professional engineers under ORS 672.002 to 672.325.]*

12 *[(6) In adopting rules required by this section, the State Board of Architect Examiners or the State*
13 *Board of Examiners for Engineering and Land Surveying shall recognize jurisdictions that enforce*
14 *requirements for registration or licensing of architects or engineers that are substantially equal to the*
15 *requirements for registration of architects or engineers in this state.]*

16 **(1) A business entity may apply to the State Board of Architect Examiners for a certifi-**
17 **cate of registration that authorizes the business entity to engage in the practice of archi-**
18 **ture within this state as a registered architectural firm.**

19 **(2) The board by rule shall specify:**

20 **(a) The manner in which and the procedures under which a business entity may apply for**
21 **a certificate of registration under subsection (1) of this section;**

22 **(b) The form and content of all application materials;**

23 **(c) The period during which a registration remains valid;**

24 **(d) Fees to apply for registration and to renew registration;**

25 **(e) Conditions or qualifications under which the board grants or denies registration; and**

26 **(f) Any other matter related to the registration of a business entity that the board deems**
27 **necessary to specify.**

28 **(3) If an applicant under subsection (1) of this section meets the qualifications and con-**
29 **ditions the board establishes for registration, the board shall issue a certificate of registra-**
30 **tion to the applicant. A registered architectural firm shall display a copy of the certificate**
31 **of registration at each of the registered architectural firm's places of business within this**
32 **state.**

33 **(4)(a) A foreign architectural firm may offer to provide in this state services that con-**
34 **stitute the practice of architecture, and may assume or use a name, form of address or other**
35 **designation within this state that indicates or reasonably could be understood to indicate**
36 **that the foreign architectural firm is an architectural firm or engages in the practice of ar-**
37 **chitecture, if the foreign architectural firm provides a notice in writing to each person that**
38 **responds to or accepts the offer that states that the foreign architectural firm is not a reg-**
39 **istered architectural firm.**

40 **(b) Notwithstanding the permission given under paragraph (a) of this subsection, a for-**
41 **ign architectural firm may not engage in the practice of architecture in this state without**
42 **a certificate of registration.**

43 **(5) A business entity that provides services in this state that constitute the practice of**
44 **architecture may provide the services only through, or under the responsible control of, an**
45 **owner or employee of the business entity who is a registered architect.**

1 **(6) Any technical submission that a registered architectural firm submits to comply with**
 2 **a requirement under the laws of this state, or an ordinance or other law of a jurisdiction in**
 3 **this state, must bear the stamp of a registered architect who has responsible control of the**
 4 **technical submission and must display the name of the registered architectural firm.**

5 **(7) A registered architectural firm may not have, use, display or communicate a name**
 6 **or assumed business name that includes the name of an individual who was not previously**
 7 **or is not currently an owner, employee or otherwise in a contractual relationship with the**
 8 **registered architectural firm under which the individual previously engaged in or currently**
 9 **engages in the practice of architecture in this state.**

10 **SECTION 6.** ORS 671.045 is amended to read:

11 671.045. ORS 671.041 to 671.047 do not affect the law applicable to the professional relationship
 12 and liabilities between [*a person*] **an architect or architectural firm** rendering professional service
 13 **in the practice of architecture** and a person receiving the **architect's or architectural firm's**
 14 service, and ORS 671.041 to 671.047 do not affect the standards of professional conduct [*of a pro-*
 15 *fession*] **that apply to architects or architectural firms.** A shareholder, director, **member,** officer,
 16 employee or agent of [*a professional corporation*] **an architectural firm** may be held personally li-
 17 able for negligent or wrongful acts or misconduct committed by [*that person*] **the shareholder, di-**
 18 **rector, member, officer, employee or agent,** or by a person under the direct supervision and
 19 control of [*that person*] **the shareholder, director, member, officer, employee or agent,** while
 20 rendering professional service on behalf of the [*corporation*] **architectural firm** to a person receiv-
 21 ing the service the same as though the service [*was*] **were** being rendered by an individual. A
 22 shareholder, director, **member** or officer may also be held liable for negligent or wrongful acts or
 23 misconduct in participation with such acts or misconduct of another shareholder, director, **member**
 24 or officer of the [*corporation*] **architectural firm.** The [*corporation*] **architectural firm** is jointly
 25 and severally liable up to the full value of [*its*] **the architectural firm's** assets for [*such*] **the ar-**
 26 **chitectural firm's** acts or misconduct[. *However*], **but** the shareholders, directors, **members,** offi-
 27 cers, employees and agents of the [*corporation*] **architectural firm** are not personally liable for the
 28 debts or other contractual obligations of the [*corporation*] **architectural firm.**

29 **SECTION 7.** ORS 671.047 is amended to read:

30 671.047. [*The Oregon Business Corporation Act is applicable to professional corporations and they*
 31 *enjoy the powers and privileges and are subject to the duties, restrictions and liabilities of corporations*
 32 *organized under the Oregon Business Corporation Act, except when inconsistent with ORS 671.041 to*
 33 *671.047. ORS 671.041 to 671.047 take precedence in the event of any conflict with provisions of the*
 34 *Oregon Business Corporation Act or other law.*]

35 **Unless inconsistent with ORS 671.041 to 671.047, ORS chapters 58, 60, 62, 63, 65, 67 and**
 36 **70 apply as appropriate to the form of business entity in which an architectural firm is or-**
 37 **ganized. The provisions of ORS 671.041 to 671.047 take precedence in governing the powers,**
 38 **privileges, duties, restrictions and liabilities of an architectural firm over conflicting pro-**
 39 **visions of ORS chapter 58, 60, 62, 63, 65, 67 or 70.**

40 **SECTION 8.** ORS 671.050 is amended to read:

41 671.050. (1) Any [*person*] **individual** desiring the right to **engage in the practice of architecture**
 42 in [*the State of Oregon*] **this state** shall apply to the State Board of Architect Examiners [*upon such*
 43 *forms and in such manner as may be provided by the board. In addition to possessing the qualifica-*
 44 *tions required by ORS 671.010 to 671.220, each applicant must be at least 18 years of age.*] **for a**

1 (a) Complete an application with documentation that, in the board's judgment, shows
2 that the applicant successfully completed an education program, an experience program and
3 an examination that meet standards the board specifies by rule; and

4 (b) Pay an application fee in an amount the board specifies by rule.

5 (2) The board by rule shall specify:

6 (a) The manner in which and the procedures under which an individual may apply for a
7 certificate of registration under subsection (1) of this section;

8 (b) The form and content of all application materials;

9 (c) The period during which a registration remains valid;

10 (d) Fees to apply for registration and to renew registration;

11 (e) Conditions or qualifications under which the board grants or denies registration; and

12 (f) Any other matter related to the registration of an individual that the board deems

18 of 60 days, forfeits the right to practice architecture in this state. The person may be reinstated as an
19 architect only upon passing examinations required by the board, by complying with any continuing
20 education requirements adopted by the board under ORS 671.125 and by paying any required fees and
21 penalties.]

22 [(4) The board may grant inactive status to any registered architect who gives up the practice and
23 while in good standing makes a request in writing to the board. The architect may resume practice by
