## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Increases salaries of state court judges. Declares emergency, effective on passage.

## A BILL FOR AN ACT

- Relating to compensation of judges; amending ORS 292.406, 292.411, 292.416 and 292.426; and declaring an emergency.
- 4 Be It Enacted by the People of the State of Oregon:
- 5 **SECTION 1.** ORS 292.406 is amended to read:
- 6 292.406. (1)(a) The annual salary of the Chief Judge of the Court of Appeals shall be [\$154,040]
- \$176,724 for the period beginning on [January 1, 2019] December 1, 2022, and ending on June 30,
  [2020] 2023.
- 9 (b) On July 1, [2020] **2023**, the annual salary of the Chief Judge of the Court of Appeals[, as adjusted under ORS 292.428,] shall be [increased by \$5,000] **\$194,400**.
  - (c) On January 1, 2024, the annual salary of the Chief Judge of the Court of Appeals, as adjusted under ORS 292.428, shall be increased by 10 percent.
  - (2)(a) The annual salary of each other judge of the Court of Appeals shall be [\$150,980] \$173,316 for the period beginning on [January 1, 2019] **December 1, 2022**, and ending on June 30, [2020] 2023.
  - (b) On July 1, [2020] **2023**, the annual salary of each other judge of the Court of Appeals[, as adjusted under ORS 292.428,] shall be [increased by \$5,000] **\$190,656**.
    - (c) On January 1, 2024, the annual salary of each other judge of the Court of Appeals, as adjusted under ORS 292.428, shall be increased by 10 percent.
      - **SECTION 2.** ORS 292.411 is amended to read:
  - 292.411. (1)(a) The annual salary of the Chief Justice of the Supreme Court shall be [\$157,076] \$180,084 for the period beginning on [January 1, 2019] **December 1, 2022**, and ending on June 30, [2020] 2023.
  - (b) On July 1, [2020] **2023**, the annual salary of the Chief Justice of the Supreme Court[, as adjusted under ORS 292.428,] shall be [increased by \$5,000] **\$198,096**.
  - (c) On January 1, 2024, the annual salary of the Chief Justice of the Supreme Court, as adjusted under ORS 292.428, shall be increased by 10 percent.
- 28 (2)(a) The annual salary of each other judge of the Supreme Court shall be [\$154,040] \$176,724 29 for the period beginning on [January 1, 2019] **December 1, 2022**, and ending on June 30, [2020] 30 **2023**.

- (b) On July 1, [2020] **2023**, the annual salary of each other judge of the Supreme Court[, as adjusted under ORS 292.428,] shall be [increased by \$5,000] **\$194,400**.
- (c) On January 1, 2024, the annual salary of each other judge of the Supreme Court, as adjusted under ORS 292.428, shall be increased by 10 percent.
  - **SECTION 3.** ORS 292.416 is amended to read:
  - 292.416. (1) The annual salary of each judge of a circuit court shall be [\$142,136] \$163,476 for the period beginning on [January 1, 2019] December 1, 2022, and ending on June 30, [2020] 2023.
- (2) On July 1, [2020] **2023**, the annual salary of each judge of a circuit court[, as adjusted under ORS 292.428,] shall be [increased by \$5,000] **\$179,832**.
  - (3) On January 1, 2024, the annual salary of each judge of a circuit court, as adjusted under ORS 292.428, shall be increased by 10 percent.
    - SECTION 4. ORS 292.426 is amended to read:
  - 292.426. (1) The annual salary of the judge of the Oregon Tax Court shall be [\$146,048] \$167,832 for the period beginning on [January 1, 2019] **December 1, 2022**, and ending on June 30, [2020] 2023.
  - (2) On July 1, [2020] **2023**, the annual salary of the judge of the Oregon Tax Court[, as adjusted under ORS 292.428,] shall be [increased by \$5,000] **\$184,620**.
  - (3) On January 1, 2024, the annual salary of the judge of the Oregon Tax Court, as adjusted under ORS 292.428, shall be increased by 10 percent.
  - <u>SECTION 5.</u> This 2023 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect on its passage.
