Senate Bill 249

Sponsored by Senator ROBINSON (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Provides that, when interview is element of process of selecting candidate for civil service po-sition from eligibility list, public employer must interview each veteran applicant who meets quali-fications for position and shows transferable skills if duties of position are performed by only one person within public employer's organization.

Requires public employer to provide written notice to veteran who is eliminated from consideration for vacant civil service position.

Provides right to jury trial and permits awards of noneconomic damages in civil suits for vio-lation of veterans' employment preference statutes. Modifies period for notice of tort claim against public body for violation of veterans' employment preference statutes. Directs Department of Veterans' Affairs to establish program for investigation and nonbinding arbitration of alleged violation of veterans' employment preference statutes. Requires public employers to conduct annual training related to veterans' employment prefer-

ences. Provides that conducting approved annual training is affirmative defense to claim for vio-lation of veterans' employment preference statutes.

5	SECTION 1. ORS 408.237 is amended to read:
6	408.237. (1) As used in this section:
7	(a) "Eligibility list" means a list of ranked eligible candidates for a civil service position who
8	have become eligible for the position through a test or series of tests and who will be considered
9	for the civil service position in ranked order.
10	(b) "Transferable skill" means a skill that a veteran has obtained through military education or
11	experience that substantially relates, directly or indirectly, to the civil service position for which
12	the veteran is applying.
13	(2) When an interview is a component of the selection process for a civil service position or for
14	an eligibility list for a civil service position, a public employer shall interview each veteran:
15	(a) Whom the public employer determines meets the minimum qualifications and special quali-
16	fications for the civil service position or eligibility list; and
17	(b) Who submits application materials that the public employer determines show sufficient evi-
18	dence that the veteran has the transferable skills required and requested by the public employer for
19	the civil service position or eligibility list.
20	(3)(a) Except as provided in paragraph (b) of this subsection, a public employer is not re-
21	quired to comply with subsection (2) of this section if the employer conducts interviews only as part
22	of the process of selecting a candidate for a civil service position from an eligibility list.
23	(b) The exemption in paragraph (a) of this subsection does not apply to a civil service
24	position if the duties of that position are performed by only one person within the public

employer's organization.
 (4) A public employer may consult with the Oregon Military Department and the Department

of Veterans' Affairs to determine whether certain military education or experience produces a
transferable skill.

5 (5) The Department of Veterans' Affairs shall provide training to veterans on how to show evi-6 dence of transferable skills in an application for a civil service position or eligibility list.

7 (6) Violation of subsection (2) of this section is an unlawful employment practice under ORS
8 chapter 659A.

9 (7) A veteran claiming to be aggrieved by a violation of subsection (2) of this section may file 10 a complaint under ORS 659A.820.

SECTION 2. ORS 408.230 is amended to read:

12 408.230. (1) A public employer shall grant a preference to a veteran or disabled veteran who 13 applies for a vacant civil service position or seeks promotion to a civil service position with a 14 higher maximum salary rate and who:

(a)(A) Successfully completes an initial application screening or an application examination for
 the position; or

(B) Successfully completes a civil service test the employer administers to establish eligibilityfor the position; and

19 (b) Meets the minimum qualifications and any special qualifications for the position.

20 (2) The employer shall grant the preference in the following manner:

(a) For an initial application screening used to develop a list of persons for interviews, the employer shall add five percentage points to a veteran's score and 10 percentage points to a disabled
 veteran's score.

(b) For an application examination, given after the initial application screening, that results in a score, the employer shall add the preference to the total combined examination score without allocating the preference to any single feature or part of the examination. The employer shall add five percentage points to a veteran's score and 10 percentage points to a disabled veteran's score.

(c) For an application examination that consists of an interview, an evaluation of the veteran's performance, experience or training, a supervisor's rating or any other method of ranking an applicant that does not result in a score, the employer shall give a preference to the veteran or disabled veteran. An employer that uses an application examination of the type described in this paragraph shall devise and apply methods by which the employer gives special consideration in the employer's hiring decision to veterans and disabled veterans.

(3) Preferences of the type described in subsection (1) of this section are not a requirement that
 the public employer appoint a veteran or disabled veteran to a civil service position.

36 (4) A public employer shall appoint an otherwise qualified veteran or disabled veteran to a va-37 cant civil service position if the results of a veteran's or disabled veteran's application examination, 38 when combined with the veteran's or disabled veteran's preference, are equal to or higher than the 39 results of an application examination for an applicant who is not a veteran or disabled veteran.

(5) If a public employer eliminates a veteran or disabled veteran from consideration for
a vacant civil service position, the public employer shall within three business days of the
elimination, provide written notice to the veteran or disabled veteran.

43 [(5)] (6) If a public employer does not appoint a veteran or disabled veteran to a vacant civil
44 service position, upon written request of the veteran or disabled veteran, the employer, in writing,
45 shall provide the employer's reasons for the decision not to appoint the veteran or disabled veteran

to the position. The employer may base a decision not to appoint the veteran or disabled veteran 1 2 solely on the veteran's or disabled veteran's merits or qualifications with respect to the vacant civil service position. 3 [(6)] (7) Violation of this section is an unlawful employment practice. 4 5 [(7)] (8) A veteran or disabled veteran claiming to be aggrieved by a violation of this section may file a verified written complaint with the Commissioner of the Bureau of Labor and Industries 6 in accordance with ORS 659A.820. 7 [(8)] (9) For purposes of this section, "disabled veteran" includes a person who is receiving 8 9 service-connected compensation from the United States Department of Veterans Affairs under 38 U.S.C. 1110 or 1131. 10 SECTION 3. claims on behalf of the public body acquires actual knowledge of the time, place and circumstances 1 giving rise to the claim, where the communication is such that a reasonable person would conclude 2 that a particular person intends to assert a claim against the public body or an officer, employee 3 or agent of the public body. A person responsible for administering tort claims on behalf of a public 4 body is a person who, acting within the scope of the person's responsibility, as an officer, employee 5 or agent of a public body or as an employee or agent of an insurance carrier insuring the public 6 body for risks within the scope of ORS 30.260 to 30.300, engages in investigation, negotiation, ad-7 justment or defense of claims within the scope of ORS 30.260 to 30.300, or in furnishing or accepting 8 9 forms for claimants to provide claim information, or in supervising any of those activities.

(7) In an action arising from any act or omission of a public body or an officer, employee or 10 agent of a public body within the scope of ORS 30.260 to 30.300, the plaintiff has the burden of 11 12 proving that notice of claim was given as required by this section.

13 (8) The requirement that a notice of claim be given under subsections (1) to (7) of this section does not apply if: 14

15 (a)(A) The claimant was under the age of 18 years when the acts or omissions giving rise to a 16 claim occurred;

(B) The claim is against the Department of Human Services or the Oregon Youth Authority; and 18 (C) The claimant was in the custody of the Department of Human Services pursuant to an order of a juvenile court under ORS 419B.150, 419B.185, 419B.337 or 419B.527, or was in the custody of 19 20the Oregon Youth Authority under the provisions of ORS 419C.478, 420.011 or 420A.040, when the acts or omissions giving rise to a claim occurred. 21

22(b) The claim is against a private, nonprofit organization that provides public transportation 23services described under ORS 30.260 (4)(d).

(9) Except as provided in ORS 12.120, 12.135 and 659A.875, but notwithstanding any other pro-24 vision of ORS chapter 12 or other statute providing a limitation on the commencement of an action, 25an action arising from any act or omission of a public body or an officer, employee or agent of a 2627public body within the scope of ORS 30.260 to 30.300 shall be commenced within two years after the alleged loss or injury. 28

SECTION 5. ORS 652.230 is amended to read:

30 652.230. (1) Any employee whose compensation is at a rate that is in violation of ORS 652.220 31 shall have a right of action against the employer for the recovery of:

(a) The amount of the unpaid wages to which the employee is entitled for the one year period 32preceding the commencement of the action; and 33

34 (b) An additional amount as liquidated damages equal to the amount referred to in paragraph 35(a) of this subsection.

(2) The court shall award reasonable attorney fees to the prevailing plaintiff in an action under 36 37 this section. The court may award reasonable attorney fees and expert witness fees incurred by a 38 defendant who prevails in the action if the court determines that the plaintiff had no objectively reasonable basis for asserting a claim or no objectively reasonable basis for appealing an adverse 39 decision of a trial court. 40

(3) The action for the unpaid wages and liquidated damages may be maintained by one or more 41 employees on behalf of themselves or other employees similarly situated. 42

(4) No agreement for compensation at a rate less than the rate to which such employee is enti-43 tled under ORS 652.210 to 652.235 is a defense to any action under ORS 652.210 to 652.235. 44

(5) For the purpose of time limitations, a compensation practice that is unlawful under ORS 45

1 652.220 occurs each time compensation is paid pursuant to a discriminatory compensation decision

2 or other practice.

3 (6) An action under this section alleging a violation of ORS 652.220 must be commenced within
4 one year after the occurrence of the unlawful practice.

5 (7) Notwithstanding ORS 30.275 [(2)(b)] (2)(c), notice of claim against a public body under ORS
6 652.220 must be given within 300 days of discovery of the alleged loss or injury.

7 **SECTION 6.** ORS 659A.875 is amended to read:

8 659A.875. (1) Except as provided in subsection (2) of this section:

9 (a) A civil action under ORS 659A.885 alleging an unlawful employment practice other than a 10 violation of ORS 243.323, 659A.030, 659A.082, 659A.112 or 659A.370 must be commenced within one 11 year after the occurrence of the unlawful employment practice unless a complaint has been timely 12 filed under ORS 659A.820.

(b) A civil action under ORS 659A.885 alleging a violation of ORS 243.323, 659A.030, 659A.082,
659A.112 or 659A.370 must be commenced not later than five years after the occurrence of the alleged violation.

(2) A person who has filed a complaint under ORS 659A.820 must commence a civil action under
ORS 659A.885 within 90 days after a 90-day notice is mailed to the complainant under ORS 659A.880.
This subsection does not apply to a complainant alleging an unlawful practice under ORS 659A.145
or 659A.421 or discrimination under federal housing law.

(3) A civil action alleging a violation of ORS 659A.145 or 659A.421 must be commenced not later
than two years after the occurrence or the termination of the unlawful practice, or within two years
after the breach of any settlement agreement entered into under ORS 659A.840, whichever occurs
last. The two-year period shall not include any time during which an administrative proceeding was
pending with respect to the unlawful practice.

(4) A civil action under ORS 659A.885 alleging an unlawful practice in violation of ORS
659A.403 or 659A.406 must be commenced within one year of the occurrence of the unlawful practice.

(5) The notice of claim required under ORS 30.275 must be given in any civil action under ORS
659A.885 against a public body, as defined in ORS 30.260, or any officer, employee or agent of a
public body as defined in ORS 30.260.

31 (6) Notwithstanding ORS 30.275 (9):

(a) A civil action under ORS 659A.885 against a public body, as defined in ORS 30.260, or any
officer, employee or agent of a public body as defined in ORS 30.260, based on an unlawful employment practice other than a violation of ORS 243.323, 659A.030, 659A.082, 659A.112 or 659A.370 must
be commenced within one year after the occurrence of the unlawful employment practice unless a
complaint has been timely filed under ORS 659A.820.

(b) A civil action under ORS 659A.885 alleging a violation of ORS 659A.030, 659A.082, 659A.112
or 659A.370 must be commenced not later than five years after the occurrence of the alleged violation unless a complaint has been timely filed under ORS 659A.820.
