

# Senate Bill 256

Sponsored by Senator GORSEK (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Prohibits person from knowingly or intentionally manufacturing, importing, distributing, offering for sale, selling or leasing or otherwise transferring, or installing or reinstalling counterfeit automobile supplemental restraint system component, nonfunctional airbag or object that does not comply with federal standard for make, model and year of motor vehicle.

Punishes violation of Act as unlawful practice under Unlawful Trade Practices Act.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. (1) As used in this section:**

6 (a) **“Airbag” means an inflatable restraint device for occupants of motor vehicles that is**  
7 **part of an automobile supplemental restraint system.**

8 (b) **“Automobile supplemental restraint system” means a passive inflatable crash pro-**  
9 **tection system that a vehicle manufacturer designs to protect automobile occupants in con-**  
10 **junction with a seat belt assembly, as defined in 49 C.F.R. 571.209, and that has one or more**  
11 **airbags and all components required to ensure that each airbag:**

12 (A) **Operates as designed in a crash; and**

13 (B) **Meets federal motor vehicle safety standards for the specific make, model and year**  
14 **of manufacture of the vehicle in which the airbag is installed.**

15 (c) **“Counterfeit automobile supplemental restraint system component” means a re-**  
16 **placement component, including an airbag, that without the authorization of a manufacturer,**  
17 **or a person that supplies parts to the manufacturer, displays a trademark that is identical**  
18 **or substantially similar to the manufacturer’s or supplier’s genuine trademark.**

19 (d) **“Nonfunctional airbag” means an airbag that:**

20 (A) **Was previously deployed or damaged;**

21 (B) **Has a fault that a motor vehicle’s diagnostic systems detect once the airbag is in-**  
22 **stalled;**

23 (C) **May not be sold or leased under 49 U.S.C. 30120(j); or**

24 (D) **Includes a counterfeit automobile supplemental restraint system component or other**  
25 **part or object that is installed for the purpose of misleading a motor vehicle owner or oper-**  
26 **ator into believing that a functional airbag is installed.**

27 (2)(a) **A person may not knowingly or intentionally:**

28 (A) **Manufacture, import, distribute, offer for sale, sell or lease or otherwise transfer,**  
29 **or install or reinstall into a motor vehicle, a counterfeit automobile supplemental restraint**  
30 **system component, a nonfunctional airbag or an object that replaces an automobile supple-**

1 **mental restraint system component and does not comply with Standard No. 208, 49 C.F.R**  
 2 **571.208, for the make, model and year of the motor vehicle;**

3 **(B) Install or reinstall as part of an automobile supplemental restraint system any object,**  
 4 **component, part or device that causes a motor vehicle’s diagnostic system to fail to warn**  
 5 **the motor vehicle operator that an airbag is not installed, or that a counterfeit automobile**  
 6 **supplemental restraint system component or nonfunctional airbag is installed in the motor**  
 7 **vehicle; or**

8 **(C) Sell, lease, trade or transfer a motor vehicle in which a counterfeit automobile sup-**  
 9 **plemental restraint system component, a nonfunctional airbag or an object that does not**  
 10 **comply with Standard No. 208, 49 C.F.R. 571.208, for the make, model and year of the motor**  
 11 **vehicle is installed as part of the motor vehicle’s automobile supplemental restraint system.**

12 **(b) For the purposes of paragraph (a) of this subsection, an installation of a counterfeit**  
 13 **automobile supplemental restraint system component, a nonfunctional airbag or an object**  
 14 **that replaces an automobile supplemental restraint system component and does not comply**  
 15 **with Standard No. 208, 49 C.F.R 571.208, for the make, model and year of the motor vehicle**  
 16 **does not occur until the installation work is complete and the earlier of these two conditions**  
 17 **occurs:**

18 **(A) The motor vehicle is returned to the operator; or**

19 **(B) Title to the motor vehicle is transferred.**

20 **(3) A person that violates subsection (2) of this section engages in an unlawful practice**  
 21 **under ORS 646.608.**

22 **SECTION 2.** ORS 646.608 is amended to read:

23 646.608. (1) A person engages in an unlawful practice if in the course of the person’s business,  
 24 vocation or occupation the person does any of the following:

25 (a) Passes off real estate, goods or services as the real estate, goods or services of another.

26 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-  
 27 proval, or certification of real estate, goods or services.

28 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-  
 29 ciation with, or certification by, another.

30 (d) Uses deceptive representations or designations of geographic origin in connection with real  
 31 estate, goods or services.

32 (e) Represents that real estate, goods or services have sponsorship, approval, characteristics,  
 33 ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have  
 34 or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the  
 35 person does not have.

36 (f) Represents that real estate or goods are original or new if the real estate or goods are de-  
 37 teriorated, altered, reconditioned, reclaimed, used or secondhand.

38 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,  
 39 or that real estate or goods are of a particular style or model, if the real estate, goods or services  
 40 are of another.

41 (h) Disparages the real estate, goods, services, property or business of a customer or another  
 42 by false or misleading representations of fact.

43 (i) Advertises real estate, goods or services with intent not to provide the real estate, goods or  
 44 services as advertised, or with intent not to supply reasonably expectable public demand, unless the  
 45 advertisement discloses a limitation of quantity.

1 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,  
2 or amounts of price reductions.

3 (k) Makes false or misleading representations concerning credit availability or the nature of the  
4 transaction or obligation incurred.

5 (L) Makes false or misleading representations relating to commissions or other compensation to  
6 be paid in exchange for permitting real estate, goods or services to be used for model or demon-  
7 stration purposes or in exchange for submitting names of potential customers.

8 (m) Performs service on or dismantles any goods or real estate if the owner or apparent owner  
9 of the goods or real estate does not authorize the service or dismantling.

10 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-  
11 vides the information required under ORS 646.611.

12 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give  
13 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of  
14 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or  
15 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,  
16 discount or other value is contingent upon an event occurring after the time the customer enters  
17 into the transaction.

18 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-  
19 cize a product, business or service.

20 (q) Promises to deliver real estate, goods or services within a certain period of time with intent  
21 not to deliver the real estate, goods or services as promised.

22 (r) Organizes or induces or attempts to induce membership in a pyramid club.

23 (s) Makes false or misleading representations of fact concerning the offering price of, or the  
24 person's cost for real estate, goods or services.

25 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any  
26 known material defect or material nonconformity.

27 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

28 (v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers,  
29 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situ-  
30 ation.

31 (w) Manufactures mercury fever thermometers.

32 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal  
33 law, or is:

34 (A) Prescribed by a person licensed under ORS chapter 677; and

35 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and  
36 on the proper cleanup of mercury should breakage occur.

37 (y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to  
38 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be  
39 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the  
40 mercury does not become part of the solid waste stream or wastewater. For purposes of this para-  
41 graph, "thermostat" means a device commonly used to sense and, through electrical communication  
42 with heating, cooling or ventilation equipment, control room temperature.

43 (z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains  
44 mercury light switches.

45 (aa) Violates the provisions of ORS 803.375, 803.385 or 815.410 to 815.430.

40 (LLL) Violates the consumer protection provisions of the Servicemembers Civil Relief Act, 50  
41 U.S.C. 3901 et seq., as in effect on January 1, 2010.  
42 (mmm) Violates a provision of ORS 646A.480 to 646A.495.  
43 (nnn) Violates ORS 646A.082.

10 (xxx) Violates ORS 646A.806.

11 (yyy) Violates ORS 646A.810 (2).

12 (zzz) Violates ORS 443.376.

13 (aaaa) Violates a provision of ORS 646A.770 to 646A.787.

14 **(bbbb) Violates section 1 of this 2023 Act.**

15 (2) A representation under subsection (1) of this section or ORS 646.607 may be any manifesta-  
16 tion of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.

17 (3) In order to prevail in an action or suit under ORS 336.184 and 646.605 to 646.652, a prose-  
18 cuting attorney need not prove competition between the parties or actual confusion or misunder-  
19 standing.

20 (4) An action or suit may not be brought under subsection (1)(u) of this section unless the At-  
21 torney General has first established a rule in accordance with the provisions of ORS chapter 183  
22 declaring the conduct to be unfair or deceptive in trade or commerce.

23 (5) Notwithstanding any other provision of ORS 336.184 and 646.605 to 646.652, if an action or  
24 suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attor-  
25 ney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney  
26 fees.
