SENATE AMENDMENTS TO SENATE BILL 275

In line 2 of the printed bill, after "education" insert "; creating new provisions; amending ORS 1 $\mathbf{2}$ 342.940; and declaring an emergency". 3 Delete lines 4 through 10 and insert: "SECTION 1. ORS 342.940 is amended to read: 4 $\mathbf{5}$ "342.940. (1) As used in this section and ORS 342.943, 'educator' means a teacher, administrator or other school professional who is licensed, registered or certified by the Teacher Standards and 6 Practices Commission. 7 (2) The Educator Advancement Council shall be established and function under an intergov-8 9 ernmental agreement, pursuant to ORS 190.003 to 190.130, between state agencies and one or 10 more school districts and education service districts. The purposes of the council are to provide 11 resources related to educator professional learning and to provide other educator supports. 12"[(3) Parties to the intergovernmental agreement establishing the council must include:] 13 "[(a) The Department of Education;] 14 "[(b) The Early Learning Division:] 15 "[(c) The Teacher Standards and Practices Commission;] "[(d) The Higher Education Coordinating Commission;] 16 17 "[(e) A school district; and] 18 "[(f) An education service district.] 19 "[(4)] (3) The intergovernmental agreement establishing the council shall outline the governance 20 framework and the administrative details necessary for the efficient and effective implementation 21of the duties of the council[, including:]. 22"[(a) Designating the maximum number of members of the council.] "[(b) Identifying the process for the council to select the chairperson of the council. The chairperson 2324must be one of the members of the council and shall be responsible for overseeing official council 25business.] 26"[(c) Identifying the process for the council to appoint the executive director of the council. Ap-27pointment of the executive director must be by written order, filed with the Secretary of State, and the 28executive director shall serve at the pleasure of the council. The executive director shall be responsible 29for the daily operations of the council, including the appointment of all subordinate officers and employees of the council. Officers and employees of the council shall be considered persons in state service 30 31 for purposes of ORS chapter 240, and, subject to ORS chapter 240, the executive director shall pre-32scribe their duties and fix their compensation.]

33 "[(5)(a)] (4)(a) The council shall consist of:

34 "(A) Members who are representatives of the parties to the intergovernmental agreement es-35 tablishing the council[, as identified in subsection (3) of this section]. 1 "(B) No more than 10 members who are practicing educators, early learning providers and pro-2 fessionals and school district board members.

"(C) No more than 10 members who are representatives of educator preparation providers, education-focused nonprofit organizations, education-focused philanthropic organizations, professional education associations, community-based education organizations that represent families and students, post-secondary institutions of education and federally recognized Indian tribes of this state.

6 "(b) Subject to any limits designated as provided by the intergovernmental agreement estab-8 lishing the council, the majority of the members of the council identified under paragraph (a) of this 9 subsection may propose additional members of the council. The inclusion of additional members on 10 the council shall be subject to the procedures established by the council under the intergovern-11 mental agreement.

12 "[(6)] (5) The council shall:

"(a) Establish a system of educator networks, as described in ORS 342.943, by which every ed ucator in this state has access to professional learning opportunities;

15 "(b) Coordinate the distribution of moneys to educator networks from the Educator Advance-16 ment Fund based on the needs of the educators identified by the networks;

"(c) Connect educator networks and facilitate communications within and among the networks to improve teaching and learning; and

"(d) Continuously assess the needs of educators in this state and coordinate priorities based on the moneys available for distribution from the Educator Advancement Fund.

21 "[(7)] (6) The Department of Education shall provide support to the strategic direction of the 22 council by:

23 "(a) Conducting and coordinating research to monitor:

24 "(A) Teaching and learning conditions;

25 "(B) Educator workforce supply and demand; and

26 "(C) Common outcomes and measures anticipated to promote improvement in teaching and 27 learning.

28 "(b) Assisting the council in coordinating and connecting educator networks, supporting profes-29 sional learning priorities, enabling access to professional learning and supports, leveraging funding 30 sources and managing innovation funds.

31 "(c) Recommending statutory and agency rule changes needed to support the purposes of the 32 council.

33 "(d) Supporting programs that help to achieve the purposes of the Educators Equity Act.

34 "(e) Supporting a statewide plan for increasing:

35 "(A) The supply of culturally diverse teacher candidates; and

36 "(B) The successful recruitment of effective educators to work in high-need schools and in 37 practice areas with a shortage of educators.

38 "(f) Identifying high-leverage educator practices to be developed by educators throughout their 39 careers.

40 "(g) Providing accountability of the council by ensuring that the council:

41 "(A) Gives preference, when making recommendations about funding distributions, to entities
42 that have demonstrated success in improving student indicators.

43 "(B) Considers the delivery of services for the benefit of all regions of this state when estab-44 lishing the system of educator networks.

45 "(C) Works toward improving student progress indicators identified by the Department of Edu-

cation or set forth in ORS 350.014. 1 2 "(D) Includes and connects education providers and leaders from prekindergarten through postsecondary education. 3 4 "(h) Providing staff support for the administrative functions of the council. "(i) Developing a system that allows for the statewide dissemination of emerging practices and 5 evidence-based models. 6 7 (j) Providing technical assistance to the council, including online systems for sharing profes-8 sional learning resources and supporting educator networks. 9 "(k) Administering the distribution of grant and contract funds for programs described in this section. 10 11 "(L) Providing administrative support to the educator networks, including: "(A) Making recommendations to the council about the selection of the sponsors of educator 12 networks; 13"(B) Providing technical assistance to educator networks; and 14 "(C) Entering into grant agreements or contracts for the distribution of funds to educator net-1516 works. "[(8)(a)] (7)(a) The State Board of Education and the Teacher Standards and Practices Commis-1718 sion may adopt any rules necessary at the request of the council to support the council or to per-19 form any duties assigned to the board or commission under this section. 20 (b) The council may adopt rules pursuant to ORS chapter 183 for the purpose of ORS 342.943. 21"[(9)] (8) The council shall be considered a board for purposes of ORS chapter 180. 22"SECTION 2. (1) The Department of Education and the Teacher Standards and Practices 23Commission shall consult with the Educator Advancement Council and examine whether to 24merge the commission into the department. The department and commission, in consultation 25with the council, shall: "(a) Identify the roles of the department, commission and council in relation to sup-26 27porting and overseeing the public education workforce of this state; 28 (b) Identify methods for improving the alignment and coordination of the duties, functions and powers of the department, commission and council; 29 "(c) Identify structures to decrease, or to prevent additional increases, in the fees 30 charged for educator licensure; 31"(d) Identify benefits and drawbacks of merging the commission into the department; and 32"(e) Identify the steps necessary to implement the merge of the commission into the 33 department. 34"(2) The department and commission shall jointly present findings made under subsection 35 (1) of this section to the interim committees of the Legislative Assembly related to education 36 no later than December 31, 2024. 37 "SECTION 3. Section 2 of this 2023 Act is repealed on January 2, 2025. 38 39 "SECTION 4. This 2023 Act being necessary for the immediate preservation of the public 40 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect 41 on its passage.". 42
