

Senate Bill 276

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Senate Interim Committee on Education for Senator Michael Dembrow)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Increases amount person may be reimbursed for provision of vision screening to student.
Declares emergency, effective July 1, 2023.

A BILL FOR AN ACT

2 Relating to reimbursements for vision screenings of students; creating new provisions; amending
3 ORS 336.211; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 336.211 is amended to read:

6 336.211. (1) As used in this section:

7 (a) "Education provider" means:

8 (A) An entity that offers a program that is recognized as an Oregon prekindergarten program
9 under ORS 329.170 to 329.200.

10 (B) A school district board.

11 (b) "Eye examination" means an eye examination that:

12 (A) Is conducted by a person licensed by the Oregon Board of Optometry under ORS 683.010 to
13 683.340 or a person licensed by the Oregon Medical Board under ORS chapter 677 and trained in
14 eye surgery and eye disease; and

15 (B) Involves any diagnosis of the eye and any measurement or assistance of the powers or range
16 of vision of the eye.

17 (c) "Vision screening" means an eye screening test to identify potential vision health problems
18 that is conducted by a person who is:

19 (A) Licensed by the Oregon Board of Optometry under ORS 683.010 to 683.340;

20 (B) Licensed by the Oregon Medical Board under ORS chapter 677 and trained in eye surgery
21 and eye disease;

22 (C) A health care practitioner acting in accordance with rules adopted by the State Board of
23 Education; or

24 (D) A school nurse, an employee of an education provider or a person or nonprofit entity des-
25 ignated by the Department of Education to provide vision screening to students who is acting in
26 accordance with rules adopted by the State Board of Education.

27 (2)(a) Except as provided in subsection (3) of this section, each education provider shall require
28 a student who is seven years of age or younger and who is beginning an educational program with
29 the education provider for the first time to submit certification that the student received:

30 (A) A vision screening or an eye examination; and

1 (B) Any further examinations or necessary treatments of the eye or assistance of the powers or
 2 range of vision of the eye.

3 (b) The certification required by this subsection must be provided no later than 120 days after
 4 the student begins the educational program.

5 (3) A student is not required to submit certification as required under subsection (2) of this
 6 section if the student provides a statement from the parent or guardian of the student that:

7 (a) The student submitted certification to a prior education provider; or

8 (b) The vision screening or eye examination is contrary to the religious beliefs of the student
 9 or the parent or guardian of the student.

10 (4) Each education provider shall:

11 (a) Ensure that the requirements of this section are met. Failure by a student to meet the re-
 12 quirements of this section may not result in a program's or school's prohibiting the student from
 13 attending the program or school, but may result in withholding report cards or similar actions.

14 (b) File in the student's vision health record any certifications and any results of a vision
 15 screening or an eye examination known by the education provider.

16 (c) Provide the parent or guardian of each student with information about the vision screenings
 17 and eye examinations, and information about further examinations or necessary treatments.

18 (5)(a) Upon application of a person that provides students with vision screenings, the Depart-
 19 ment of Education shall reimburse the person for any necessary expenses incurred by the person in
 20 the provision of the vision screenings.

21 (b) A person may receive reimbursement under this subsection for the provision of a vision
 22 screening to any student of an education provider, regardless of whether the student has complied
 23 with subsection (2) or (3) of this section. Nothing in this paragraph removes the requirement that
 24 a student must comply with subsection (2) or (3) of this section.

25 (c) Reimbursements made under this subsection:

26 (A) May not exceed [~~\$3.20~~] \$4 per vision screening per student per school year.

27 (B) Must be paid from the Vision Health Account established under ORS 336.212.

28 (C) May not exceed amounts available in the Vision Health Account.

29 (6)(a) The State Board of Education, in consultation with the Oregon Health Policy Board, shall
 30 adopt by rule any standards for the implementation of this section.

31 (b) The State Board of Education shall adopt rules that:

32 (A) Prescribe the process by which a person or nonprofit entity is designated by the Department
 33 of Education to provide vision screenings; and

34 (B) Establish the process for providing reimbursements under subsection (5) of this section, in-
 35 cluding the prioritization of persons to receive a reimbursement if the total amount available for
 36 reimbursements exceeds the total amount requested for reimbursements.

37 **SECTION 2. The amendments to ORS 336.211 by section 1 of this 2023 Act apply to vision**
 38 **screenings provided on or after the effective date of this 2023 Act.**

39 **SECTION 3. In addition to and not in lieu of any other appropriation, there is appropri-**
 40 **ated to the Department of Education, for the biennium beginning July 1, 2023, out of the**
 41 **General Fund, the amount of \$2,000,000, to be deposited in the Vision Health Account estab-**
 42 **lished under ORS 336.212.**

43 **SECTION 4. This 2023 Act being necessary for the immediate preservation of the public**
 44 **peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect**
 45 **July 1, 2023.**
