8	" <u>SECTION 1.</u> (1) As used in this section:
9	"(a) 'Education workforce' means licensed and classified staff employed by a public edu-
10	cation provider.
11	"(b) 'Public education provider' means:
12	"(A) A school district;
13	"(B) A public charter school;
14	"(C) An education service district;
15	"(D) A long term care or treatment facility, as described in ORS 343.961;
16	"(E) The Youth Corrections Education Program;
17	"(F) The Juvenile Detention Education Program; or
18	"(G) The Oregon School for the Deaf.
19	"(2) The Department of Education shall establish and maintain a statewide data system
20	on the education workforce in this state. The State Board of Education may adopt by rule

24	to each individual who is a member of the education workforce. The identifier may not use

27	cation so that data sets can be matched based on the personally identifiable information
28	when the identifier is included.

surveys administered as provided by section 2 of this 2023 Act; 1 2 "(f) Evaluate pay in relation to local economic data from the most recent American Community Survey from the United States Census Bureau; and 3 4 "(g) Study education workforce trends and needs in this state in a manner that: "(A) Includes a review of: 5 6 "(i) The satisfaction of persons who complete educator preparation programs in this 7 state; "(ii) Employer satisfaction with the availability and skills of the education workforce in 8 9 this state; and "(iii) Hiring and retention trends of the education workforce in this state; and 10 11 "(B) Is sortable by school district, geographic location, school, grade level, teacher characteristics and educator preparation program of this state. 12"(5) To the greatest extent practicable, the department shall: 13"(a) Ensure that the collection of data under this section aligns with the collection of 14 15data under ORS 342.443; and "(b) Reduces redundancies by incorporating any other relevant data processes or proce-16 dures. 17 (6) The department shall make the information described in subsection (4) of this sec-18 19 tion available to the public through a visually appealing interactive data visualization tool that is accessible on the department's website home page. 2021"(7) For the purpose of this section, each public education provider, the Teacher Stan-22dards and Practices Commission, the Educator Advancement Council, the Higher Education Coordinating Commission and the public universities listed in ORS 352.002 shall collect in-23formation as required for the statewide data system. 24 25"(8) For the purpose of ensuring the data collection requirements of this section are met 26 and the purpose of studying the education workforce, as described in subsection (4)(g) of this 27section, the department shall convene a steering committee. 26	"(a) 'Classified school employee' includes all employees of a school district except those
27	for whom a teaching or administrative license is required as a basis for employment in a
28	school district.
29	"(b) 'Individualized education program' has the meaning given that term in ORS 343.035.
30	"(c) 'Licensed educator' means a teacher, administrator or other school professional who
31	is licensed, registered or certified by the Teacher Standards and Practices Commission.
32	"(d) 'Salary' has the meaning given that term in ORS 653.010.
33	"(e) 'School district' means:
34	"(A) A common school district or a union high school district.
35	"(B) An education service district.
36	"(2) For each licensed educator or classified school employee who provides significant
37	special education support, as determined under subsection (3) of this section, the school
38	district shall pay:
39	"(a) For a licensed educator or a classified school employee who receives a salary, an
40	additional 20 percent of the salary, rounded to the nearest dollar; or
41	"(b) For a licensed educator or a classified school employee who is paid an hourly wage,
42	an additional 20 percent of the hourly wage rounded to the nearest dollar.
43	"(3) For purposes of this section, a licensed educator or a classified school employee
44	provides significant special education support if 75 percent or more of the licensed educator's

1 to directly teach or support students who have an individualized education program.

"(4) All salary and wage increases specified in subsection (2) of this section are exclusive
of health benefits and other benefits the school district provides to licensed educators or
classified school employees or that are otherwise required under the laws of this state.

<sup>5</sup> "<u>SECTION 4.</u> Section 3 of this 2023 Act applies to contracts of employment into which a <sup>6</sup> school district enters, or that the school district renews, with a licensed educator or a clas-<sup>7</sup> sified school employee on or after the effective date of this 2023 Act and to contracts of <sup>8</sup> employment between a school district and a licensed educator or a classified school employee <sup>9</sup> that are in effect on or after the effective date of this 2023 Act.

to fewer than five hours per work day, if the reduction in hours is at the written request
of the employee.

6	"342.610. (1)(a) [Teachers employed as substitute teachers shall not] A teacher employed as a
7	substitute teacher may not be paid less per day than 85 percent of 1/190th of the statewide av-
8	erage salary of a beginning teacher who holds a bachelor's degree. [The salary of the substitute
9	teacher shall be computed as required in this subsection based on the statewide average salary for be-
10	ginning teachers who hold bachelor's degrees.]
11	"(b) The Department of Education shall compute the statewide average salary of a beginning
12	teacher who holds a bachelor's degree to be used for purposes of this subsection[,] by:
13	"(A) Using the latest data available to the department[, but not]; and
14	"(B) Not using data from earlier than the preceding school year.
15	"(2) [The] A school district shall set the working hours for a substitute teacher[,] and, when

"<u>SECTION 11.</u> Section 12 of this 2023 Act is added to and made a part of ORS chapter 342. "SECTION 12. (1) As used in this section:

"(a) 'Substitute teacher' has the meaning given that term in ORS 342.815.

"(b) 'Third-party employment service provider' means a program or entity that facilities
the employment by an employer or employee by providing services that may include
recruitment, payroll, employee relations or other human resources services.

15 "(2) A teacher may provide the services of a substitute teacher only under a written 16 contract for employment entered into with a school district, an education service district or 17 a public charter school. A teacher who provides services as a substitute teacher shall be 18 considered an employee of the school district, education service district or public charter 19 school with which the teacher is under contract. Nothing in this subsection prohibits a 20 teacher under contract with an education service district from providing the services of a 21 substitute teacher to the component school districts of the education service district.

"(3) A school district, an education service district or a public charter school may not
enter into a contract with a third-party employment service provider to employ a teacher

"(4) A substitute teacher who is employed by a school district, an education service district or a public charter school in a qualifying position, as defined in ORS 238.005 or 238A.005, shall be eligible for retirement benefits for purposes of public employees' retirement laws.

"(5) The Public Employees' Benefit Board and the Oregon Educators Benefit Board shall provide, by rule, for payment of insurance premiums for health benefit plans for persons employed as a substitute teacher on more than a half-time basis, in total, by multiple employers that may be any combination of school districts, education service districts and public charter schools.

38 "(b) The office may enroll an individual in the registry subject to limitations identified in rules 39 adopted by the council.

40 "(7) An enrollment in the Central Background Registry may be renewed upon application to the 41 office, payment of the fee established pursuant to ORS 329A.275 and compliance with rules adopted 42 by the Early Learning Council pursuant to this section. However, an individual who is determined 43 to be ineligible for enrollment in the registry after the date of initial enrollment shall be removed 44 or suspended from the registry by the office.

45 "(8)(a) A child care facility, preschool recorded program or school-age recorded program may

not hire or employ an individual if the individual is not enrolled in the Central Background Registry. 1 2 (b) Notwithstanding paragraph (a) of this subsection, a child care facility, preschool recorded program or school-age recorded program may employ on a probationary basis an individual who is 3 4 conditionally enrolled in the Central Background Registry. "(9) The Early Learning Council may adopt any rules necessary to carry out the purposes of this 5 section, including but not limited to rules regarding expiration and renewal periods and limitations 6 7 related to the subject individual's enrollment in the Central Background Registry. 8 "(10) As used in this section, 'subject individual' means: 9 "(a) A subject individual as defined by the Early Learning Council by rule; "(b) An individual subject to subsection (2)(b) of this section; 10 11 "(c) A person who applies to be: "(A) The operator or an employee of a child care or treatment program; 12"(B) The operator or an employee of an Oregon prekindergarten program under ORS 329.170 to 13329.200; 14 "(C) The operator or an employee of a federal Head Start program regulated by the United 1516 States Department of Health and Human Services; "(D) An individual in a child care facility, preschool recorded program or school-age recorded 1718 program who may have unsupervised contact with children, as determined by the council by rule; 19 "(E) A contractor or an employee of the contractor who: "(i) Provides early childhood special education or early intervention services pursuant to ORS 2021343.455 to 343.534; and 22"(ii) Is not subject to the criminal records check requirements of ORS 326.603 or 342.223; 23"(F) A child care provider who is required to be enrolled in the Central Background Registry by any state agency; 2425"(G) A contractor, employee or volunteer of a metropolitan service district organized under ORS 26chapter 268 who may have unsupervised contact with children and who is required to be enrolled 27in the Central Background Registry by the metropolitan service district; 28 "(H) A provider of respite services, as defined in ORS 418.205, for parents pursuant to a properly 29executed power of attorney under ORS 109.056 who is providing respite services as a volunteer with 30 a private agency or organization that facilitates the provision of such respite services; "(I) The operator or an employee of an early learning program as defined in rules adopted by 3132the council; or 33 "(J) The operator or an employee of a preschool recorded program or a school-age recorded 34program; or 35 "(d)(A) An individual who operates a subsidized care facility; "(B) An individual who has attained 18 years of age and resides in a subsidized care facility; 36 37 or 38 "(C) An individual in a subsidized care facility who has attained 18 years of age and who may 39 have unsupervised contact with children, as determined by the council by rule. 40 "(11)(a) Information provided to a metropolitan service district organized under ORS chapter 268 41 about the enrollment status of the persons described in subsection (10)(c)(G) of this section shall be 42subject to a reciprocal agreement with the metropolitan service district. The agreement must pro-43 vide for the recovery of administrative, including direct and indirect, costs incurred by the office 44 from participation in the agreement. Any moneys collected under this paragraph shall be deposited 45 in the Child Care Fund established under ORS 329A.010.

"(b) Information provided to a private agency or organization facilitating the provision of respite services, as defined in ORS 418.205, for parents pursuant to a properly executed power of attorney under ORS 109.056 about the enrollment status of the persons described in subsection (10)(c)(H) of this section shall be subject to an agreement with the private agency or organization. The agreement must provide for the recovery of administrative, including direct and indirect, costs incurred by the office from participation in the agreement. Any moneys collected under this paragraph shall be deposited in the Child Care Fund established under ORS 329A.010.

8 "(c) Information provided to a private agency or organization about the enrollment status of the 9 persons described in subsection (10)(c)(I) of this section shall be subject to an agreement with the 10 private agency or organization. The agreement must provide for the recovery of administrative, in-11 cluding direct and indirect, costs incurred by the office from participation in the agreement. Any 12 moneys collected under this paragraph shall be deposited in the Child Care Fund established under 13 ORS 329A.010.
