12 **PUBLIC DEFENSE COMMISSION**
13 **“(Appointment and Duties)”**

15 **“SECTION 1.** ORS 151.211 is amended to read:

16 “151.211. For purposes of ORS 151.211 to 151.221:

17 “[*(1) ‘Bar member’ means an individual who is an active member of the Oregon State Bar.*]

18 “[*(2) (1) ‘Chief Justice’ means the Chief Justice of the Supreme Court.*]

19 “[*(3) (2) ‘Commission’ means the [Public Defense Services Commission] Oregon Public Defense*
20 **Commission.**]

21 “[*(4) ‘Director’ means the public defense services executive director appointed under ORS*
22 *151.216.*]

23 “[*(5) ‘Office of public defense services’ means the office established by the commission under the*
24 *director to handle the cases assigned and to carry out the administrative policies and procedures for*
25 *the public defense system.*]

26 **“SECTION 2.** ORS 151.213 is amended to read:

27 “151.213. (1) The [Public Defense Services Commission] **Oregon Public Defense Commission** is
28 established in the judicial branch of state government. Except for the appointment or removal of
29 commission members, the commission and employees of the commission are not subject to the exer-
30 cise of administrative authority and supervision by the Chief Justice of the Supreme Court as the
31 administrative head of the Judicial Department.

32 “(2)(a) [*The commission consists of*] **Nine voting members and four nonvoting members shall**
33 **be appointed to the commission** by order of the Chief Justice[. *In addition to the nine appointed*
34 *members, the Chief Justice serves as a nonvoting, ex officio member. The Chief Justice shall appoint*
35 *at least three persons who are not bar members, at least one person who was formerly engaged in the*

1 *provision of public defense services and at least one person who has been formerly represented by a*
2 *public defense provider in this state. All members must have a demonstrated record of commitment to*
3 *public defense. Except for the Chief Justice or a senior judge under ORS 1.300, a member may not*
4 *serve concurrently as a judge, a prosecuting attorney or an employee of a law enforcement agency. A*
5 *person who is primarily engaged in providing public defense services may not serve as a member of*
6 *the commission.] as follows:*

7 **“(A) The Chief Justice shall appoint:**

8 **“(i) One voting member who is a retired judge, or who is serving as a senior judge under**
9 **ORS 1.300, with criminal law experience.**

10 **“(ii) Two additional voting members, one of whom has experience as a public defense**
11 **provider in criminal or juvenile delinquency cases.**

12 **“(B) The Chief Justice shall appoint, from among persons recommended by the Governor:**

13 **“(i) One voting member who has been represented by a public defense provider.**

14 **“(ii) Two additional voting members, one of whom has experience as a public defense**
15 **provider in criminal or juvenile delinquency cases.**

16 **“(iii) Two nonvoting members who are currently employed as public defense providers in**
17 **this state, one of whom is from an urban area and one of whom is from a rural area.**

18 **“(C) The Chief Justice shall appoint, from among persons recommended by the President**
19 **of the Senate:**

20 **“(i) One voting member who is a current dean or faculty member of an Oregon law**
21 **school.**

22 **“(ii) One nonvoting member who is a member of the Senate at the time of appointment.**

23 **“(D) The Chief Justice shall appoint, from among persons recommended by the Speaker**
24 **of the House of Representatives:**

25 **“(i) One voting member who has expertise in juvenile law and criminal law, or who is a**
26 **juvenile justice advocate.**

27 **“(ii) One nonvoting member who is a member of the House of Representatives at the time**
28 **of appointment.**

29 **“(E) The Chief Justice shall appoint one voting member from among persons jointly re-**
30 **commended by the President of the Senate and the Speaker of the House of Representatives.**

31 **“(b) When recommending and appointing members of the commission, the Chief Justice,**
32 **Governor, President of the Senate and Speaker of the House of Representatives shall:**

33 **“(A) Consider input from individuals and organizations with an interest in the delivery**
34 **of public defense services.**

35 **“(B) Consider geographic, racial, ethnic and gender diversity.**

36 **“(C) Ensure that members appointed to the commission have significant experience with**
37 **issues related to public defense or in the case types subject to representation by public de-**
38 **fense providers.**

39 **“(D) Ensure that members appointed to the commission have demonstrated a strong**
40 **commitment to quality public defense representation.**

41 **“(c) The following persons may not be appointed to and may not serve as members of the**
42 **commission:**

43 **“(A) A prosecuting attorney.**

44 **“(B) A judge, magistrate or other person who performs judicial functions, other than a**
45 **senior judge under ORS 1.300.**

1 “(C) An employee of a law enforcement agency.

2 “(d) A person who is primarily engaged in providing public defense services and who has
3 a financial interest in the delivery of public defense services at the state level may not serve
4 as a voting member of the commission.

5 “(3) The term of a member is four years beginning on the effective date of the order of the Chief
6 Justice appointing the member. A member is eligible for reappointment if qualified for membership
7 at the time of reappointment, **but may serve no more than two consecutive four-year terms.**
8 [A member may be removed from the commission by order of the Chief Justice.] **The Chief Justice**
9 **may remove any member of the commission at any time for cause.** If a vacancy occurs for any
10 cause before the expiration of the term of a member, the Chief Justice shall make an appointment
11 **to fill the vacancy, in the same manner as an appointment to a full term,** to become imme-
12 diately effective for the unexpired term. **If the Chief Justice has not filled a vacancy within 45**
13 **days after the vacancy occurs, the remaining voting members of the commission shall, by a**
14 **majority vote, select a member to fill the vacancy for the remainder of the term.**

15 “(4) A chairperson and a vice chairperson shall be [appointed by order of the Chief Justice]
16 **elected by the voting members of the commission** every two years with such functions as the
17 commission may determine. A member is eligible for [reappointment] **reelection** as chairperson or
18 vice chairperson.

19 “(5) A majority of the voting members constitutes a quorum for the transaction of business.

20 “(6) **The members of the commission shall:**

21 “(a) **Appoint, by a two-thirds vote of the voting members, an executive director for a**
22 **term of office of four years. The term may be terminated for cause by a majority vote of the**
23 **members of the commission after notice and a hearing. When the term of an executive di-**
24 **rector ends without termination, the members of the commission may reappoint the person**
25 **currently in the position by a majority vote.**

26 “(b) **Review and approve the policies, procedures, standards and guidelines required by**
27 **ORS 151.216 before those policies, procedures, standards and guidelines may take effect.**

28 “(c) **Review and approve the budget of the commission before submission to the Legisla-**
29 **tive Assembly.**

30 “(d) **Meet as needed to carry out the duties described in this subsection.**

31 “(7) **The members of the commission may not:**

32 “(a) **Make any decision regarding the handling of any individual case;**

33 “(b) **Have access to any case file; or**

34 “(c) **Interfere with the executive director or any member of the staff of the executive**
35 **director in carrying out professional duties involving the legal representation of public de-**
36 **fense clients.**

37 “[(6)] (8) A member of the commission is [not] entitled to compensation for services as a member,
38 [but is entitled] **and** to expenses, as provided in ORS 292.495 [(2)].

39 “**SECTION 3.** ORS 151.216 is amended to read:

40 “151.216. (1) The [Public Defense Services Commission] **Oregon Public Defense Commission**
41 shall:

42 “(a) Establish and maintain a public defense system that ensures the provision of public defense
43 services consistent with the Oregon Constitution, the United States Constitution and Oregon and
44 national standards of justice.

45 “[(b) Establish an office of public defense services and appoint a public defense services executive

1 *director who serves at the pleasure of the commission.]*

2 “[(c) (b) Adopt policies for *[contracting for]* public defense providers *[not employed by the office*
3 *of public defense services]* that:

4 “(A) Ensure compensation, resources and caseloads are in accordance with national and re-
5 gional best practices; **and**

6 “(B) *[Promote policies]* **Provide** for public defense provider compensation and resources that are
7 comparable to prosecution compensation and resources[;].

8 “[(C) *Ensure funding and resources to support required data collection and training requirements;*
9 *and]*

10 “[(D) *Recognize the need to consider overhead costs that account for the cost of living and business*
11 *cost differences in each county or jurisdiction, including but not limited to rent, professional member-*
12 *ship dues, malpractice insurance and other insurance and other reasonable and usual operating*
13 *costs.]*

14 “[(d) *Establish operational and contracting systems that allow for oversight, ensure transparency*
15 *and stakeholder engagement and promote equity, inclusion and culturally specific representation.]*

16 “[(e) *Review the caseload policies described in paragraph (c)(A) of this subsection annually, and*
17 *revise the policies as necessary and at least every four years.]*

18 “[(f) *Adopt a statewide workload plan, based on the caseload policies described in paragraph (c)(A)*
19 *of this subsection, that takes into account the needs of each county or jurisdiction, practice structure*
20 *and type of practice overseen by the office of public defense services.]*

21 “[(g) (c) Submit the budget of the commission *[and the office of public defense services]* to the
22 Legislative Assembly after the budget is submitted to the commission by the **executive** director and
23 approved by the **voting members of the** commission. The Chief Justice of the Supreme Court and
24 the chairperson of the commission shall present the budget to the Legislative Assembly.

25 “[(h) *Review and approve any public defense services contract negotiated by the director before the*
26 *contract can become effective.]*

27 “[(i) (d) Adopt a compensation plan, classification system and *[personnel]* **affirmative action**
28 **plan** for the *[office of public defense services]* **commission** that are commensurate with other state
29 agencies.

30 “[(j) (e) Adopt policies, procedures, standards and guidelines regarding:

31 “(A) The determination of financial eligibility of persons entitled to be represented by appointed
32 counsel at state expense;

33 “(B) The appointment of counsel, including the appointment of counsel at state expense regard-
34 less of financial eligibility in juvenile delinquency matters;

35 “(C) The fair compensation of counsel appointed to represent a person financially eligible for
36 appointed counsel at state expense;

37 “(D) Appointed counsel compensation disputes;

38 “(E) *[Any other]* **The** costs associated with the representation of a person by appointed counsel
39 in the state courts that are required to be paid by the state *[under ORS 34.355, 135.055, 138.500,*
40 *138.590, 161.346, 161.348, 161.365, 419A.211, 419B.201, 419B.208, 419B.518, 419B.908, 419C.206,*
41 *419C.209, 419C.408, 419C.535, 426.100, 426.135, 426.250, 426.307, 427.265, 427.295, 436.265 or 436.315*
42 *or any other provision of law that expressly provides for payment of such compensation, costs or ex-*
43 *penses by the commission];*

44 “[(F) *Professional qualifications for counsel appointed to represent public defense clients;*]

45 “[(G) *Performance for legal representation;*]

1 “[(H) *The contracting of public defense services;*]
2 “[(I) *Contracting with expert witnesses to allow contracting with out-of-state expert witnesses only*
3 *if in-state expert witnesses are not available or are more expensive than out-of-state expert witnesses;*
4 *and]*
5 **“(F) The qualifications required for senior staff of the commission; and**
6 **“(G) The types of fees and expenses subject to a preauthorization requirement.**
7 “[(J) *Any other matters necessary to carry out the duties of the commission.*]
8 “[(k) *Establish a peer review system for the approval of nonroutine fees and expenses incurred in*
9 *cases involving aggravated murder and the crimes listed in ORS 137.700 and 137.707. The review shall*
10 *be conducted by a panel of attorneys who practice in the area of criminal defense.*]
11 “[(L) *Establish a complaint process that allows district attorneys, criminal defense counsel and the*
12 *public to file complaints concerning the payment from public funds of nonroutine fees and expenses*
13 *incurred in cases.*]
14 “[(m)] **(f)** Reimburse the State Court Administrator from funds deposited in the Public Defense
15 Services Account established by ORS 151.225 for the costs of personnel and other costs associated
16 with location of eligibility verification and screening personnel pursuant to ORS 151.489 by the State
17 Court Administrator.
18 **“(g) Establish minimum standards for the delivery of public defense services that provide**
19 **for the effective assistance of counsel to eligible persons throughout this state. The mini-**
20 **imum standards must be designed to ensure that public defense services meet all require-**
21 **ments for the effective assistance of counsel under statute and the Oregon and United States**
22 **Constitutions.**
23 **“(h) Establish and implement policies, procedures, standards and guidelines necessary to**
24 **guarantee the right of eligible persons to the assistance of counsel as required by statute**
25 **and by the Oregon and United States Constitutions.**
26 **“(i) Develop and oversee the implementation, enforcement and modification of minimum**
27 **policies, procedures, standards and guidelines to ensure that public defense providers are**
28 **providing effective assistance of counsel consistently to all eligible persons in this state as**
29 **required by statute and the Oregon and United States Constitutions. The policies, proce-**
30 **dures, standards and guidelines described in this paragraph apply to employees of the com-**
31 **mission and to any entity that contracts with the commission to provide public defense**
32 **services in this state.**
33 **“(j) Set minimum standards by which appointed counsel are trained and supervised.**
34 **“(k) Establish procedures for the mandatory collection of data concerning the operation**
35 **of the commission and all public defense providers.**
36 **“(L) Enter into contracts to bring the delivery of public defense services into compliance**
37 **with the minimum policies, procedures, standards and guidelines described in this subsection.**
38 **“(m) At least once every two years, report to the interim committees of the Legislative**
39 **Assembly related to the judiciary, in the manner provided in ORS 192.245, and to the Gover-**
40 **nor and Chief Justice, concerning compliance metrics for the minimum standards described**
41 **in this subsection and recommendations for legislative changes.**
42 **“(n) Develop standard operating expectations for persons providing public defense ser-**
43 **vices.**
44 **“(o) In consultation with the Judicial Department, ensure the existence of policies that**
45 **create a standardized process for determining and verifying financial eligibility for appointed**

1 counsel under ORS 151.485.

2 **“(p) Centralize services and resources, including training, so that the services and re-**
3 **sources can be utilized by both commission employees and public service providers who**
4 **contract with the commission.**

5 **“(q) Establish any other policies, procedures, standards and guidelines for the conduct**
6 **of the commission’s affairs and promulgate policies necessary to carry out all powers and**
7 **duties of the commission.**

8 **“(2) When establishing the minimum policies, procedures, standards and guidelines de-**
9 **scribed in this section, the commission shall adhere to the following principles:**

10 **“(a) Appointed counsel shall be provided sufficient time and a space where attorney-client**
11 **confidentiality is safeguarded for meetings with clients.**

12 **“(b) The workload of appointed counsel must be controlled to permit effective represen-**
13 **tation. Economic disincentives or incentives that impair the ability of appointed counsel to**
14 **provide effective assistance of counsel must be avoided. The commission may develop work-**
15 **load controls to enhance appointed counsel’s ability to provide effective representation.**

16 **“(c) The ability, training and experience of appointed counsel must match the nature and**
17 **complexity of the case to which the counsel is appointed.**

18 **“(d) The same appointed counsel shall continuously represent a client throughout the**
19 **pendency of the case and shall appear at every court appearance other than ministerial**
20 **hearings.**

21 **“(e) The commission shall establish continuing legal education requirements relevant to**
22 **the practice of public defense or juvenile representation for public defense providers who are**
23 **employed by or contract with the commission.**

24 **“(f) The commission and public defense providers shall systematically review appointed**
25 **counsel for efficiency and for effective representation according to commission standards.**

26 **“(3) The commission shall be organized in a manner for the effective delivery of public**
27 **defense services as prescribed by the policies and procedures created pursuant to statute to**
28 **financially eligible persons and consistent with the budgetary structure established for the**
29 **commission by the Legislative Assembly.**

30 **“(4) The commission shall hire attorneys to serve as appointed counsel at the trial level**
31 **in Oregon circuit courts, and may establish a trial division within the commission consisting**
32 **of attorneys employed by the commission who are trial-level public defense providers.**

33 **“(5) The policies, procedures, standards and guidelines adopted by the commission must**
34 **be made available in an accessible manner to the public on the commission’s Internet**
35 **website.**

36 **“[(2)] (6) Policies, procedures, standards and guidelines adopted by the commission supersede**
37 **any conflicting rules, policies or procedures of the Public Defender Committee, State Court Admin-**
38 **istrator, circuit courts, the Court of Appeals, the Supreme Court and the Psychiatric Security Re-**
39 **view Board related to the exercise of the commission’s administrative responsibilities under this**
40 **section and transferred duties, functions and powers as they occur.**

41 **“[(3)] (7) The commission may accept gifts, grants or contributions from any source, whether**
42 **public or private. However, the commission may not accept a gift, grant or contribution if accept-**
43 **ance would create a conflict of interest. Moneys accepted under this subsection shall be deposited**
44 **in the Public Defense Services Account established by ORS 151.225 and expended for the purposes**
45 **for which given or granted.**

1 “[(A) *The commission may not:*]

2 “[(a) *Make any decision regarding the handling of any individual case;*]

3 “[(b) *Have access to any case file; or*]

4 “[(c) *Interfere with the director or any member of the staff of the director in carrying out profes-*

5 *sional duties involving the legal representation of public defense clients.*]

6 “**SECTION 4.** ORS 151.219 is amended to read:

7 “151.219. (1) The [*public defense services*] executive director **of the Oregon Public Defense**

8 **Commission** shall:

9 “**(a) Appoint a deputy director of the commission who serves at the pleasure of the**

10 **executive director.**

11 “**(b) Hire necessary staff for the commission.**

12 “[(a)] **(c)** Recommend to the [*Public Defense Services*] commission how to establish and maintain,

13 in a cost-effective manner, the delivery of legal services to persons entitled to, and, where applica-

14 ble, financially eligible for, appointed counsel at state expense under Oregon statutes, the Oregon

15 Constitution, the United States Constitution and consistent with Oregon and national standards of

16 justice.

17 “[(b)] **(d)** Implement and ensure compliance with contracts, policies, procedures, standards and

18 guidelines adopted by the commission or required by statute.

19 “[(c)] **(e)** Prepare and submit to the commission for its approval the biennial budget of the

20 commission [*and the office of public defense services*].

21 “[(d)] **(f)** Negotiate contracts, as appropriate, for providing legal services to persons eligible for

22 appointed counsel at state expense. [*No contract so negotiated is binding or enforceable until the*

23 *contract has been reviewed and approved by the commission as provided in ORS 151.216.*]

24 “[(e)] **(g)** Employ personnel or contract for services as necessary to carry out the responsibilities

25 of the **executive** director and the [*office of public defense services*] **commission.**

26 “[(f)] **(h)** Supervise the personnel, operation and activities of the [*office of public defense*

27 *services*] **commission.**

28 “[(g)] **(i)** Provide services, facilities and materials necessary for the performance of the duties,

29 functions and powers of the [*Public Defense Services*] commission.

30 “[(h)] **(j)** Pay the expenses of the commission [*and the office of public defense services*].

31 “[(i)] **(k)** Prepare and submit to the **members of the** commission an annual report of the ac-

32 tivities of the [*office of public defense services*] **commission.**

33 “[(j)] *Prepare and submit to the Legislative Assembly a biennial report on the activities of the office*

34 *of public defense services.*]

35 “[(k)] **(L)** Provide for legal representation, advice and consultation for the commission, its

36 members, the **executive** director and staff of the [*office of public defense services*] **commission** who

37 require such services or who are named as defendants in lawsuits arising from their duties, functions

38 and responsibilities. If requested by the **executive** director, the Attorney General may also provide

39 for legal representation, advice and consultation for the commission, its members, the **executive**

40 director and staff of the [*office of public defense services*] **commission** in litigation.

41 “**(m) Assist the commission in developing standard operating expectations for persons**

42 **providing public defense services. The executive director may establish a standards advisory**

43 **group to assist in developing the expectations.**

44 “(2) The **executive** director may designate persons as representatives of the **executive** director

45 for the purposes of determining and paying bills submitted to the [*office of public defense services*]

1 **commission** and determining preauthorization for incurring fees and expenses under ORS 135.055.

2 “**SECTION 5.** ORS 151.221 is amended to read:

3 “151.221. Officers and employees of the [*office of public defense services, who are appointed under*
4 *a personnel plan adopted by the Public Defense Services Commission,*] **Oregon Public Defense**
5 **Commission** are state officers or employees in the exempt service and are not subject to ORS
6 chapter 240.

7 “**SECTION 6.** ORS 151.225 is amended to read:

8 “151.225. (1) The Public Defense Services Account is established in the State Treasury, separate
9 and distinct from the General Fund. The Public Defense Services Account is continuously appropri-
10 ated to the [*Public Defense Services Commission*] **Oregon Public Defense Commission** for:

11 “(a) Administration and support of the public defense system;

12 “(b) Reimbursement of the State Court Administrator under ORS 151.216 [(1)(m)] (1)(f); and

13 “(c) Legal representation of parents and children involved in foster care for which matching
14 funds under 45 C.F.R. 1356.60(c) may be used.

15 “(2) The following moneys shall be deposited in the Public Defense Services Account:

16 “(a) Moneys received by the commission from the State Court Administrator under ORS 151.216
17 [(1)(m)] (1)(f);

18 “(b) Moneys received by the Judicial Department under ORS 135.050 (8), 151.487 (1), 419A.211
19 or 419B.198 (1);

20 “(c) Federal matching funds received under 45 C.F.R. 1356.60(c); and

21 “(d) Miscellaneous revenues and receipts of the commission.

22 “(3) All gifts, grants or contributions accepted by the commission under ORS 151.216 shall be
23 deposited in a separate subaccount created in the Public Defense Services Account to be used by
24 the commission for the purpose for which the gift, grant or contribution was given or granted.

25 “**SECTION 7.** ORS 135.055 is amended to read:

26 “135.055. (1) Counsel appointed pursuant to ORS 135.045 or 135.050 shall be paid fair compen-
27 sation for representation in the case:

28 “(a) By the county, subject to the approval of the governing body of the county, in a proceeding
29 in a county or justice court.

30 “(b) By the [*public defense services*] executive director **of the Oregon Public Defense Com-**
31 **mission** from funds available for the purpose, in a proceeding in a circuit court.

32 “(2) Except for counsel appointed pursuant to contracts or counsel employed by the [*public de-*
33 *fense services executive director*] **Oregon Public Defense Commission**, compensation payable to
34 appointed counsel under subsection (1) of this section:

35 “(a) In a proceeding in a county or justice court may not be less than \$30 per hour.

36 “(b) In a proceeding in a circuit court is subject to the applicable compensation established
37 under ORS 151.216.

38 “(3)(a) A person determined to be eligible for appointed counsel is entitled to necessary and
39 reasonable fees and expenses for investigation, preparation and presentation of the case for trial,
40 negotiation and sentencing. The person or the counsel for the person shall upon written request
41 secure preauthorization to incur fees and expenses that [*are not routine to representation but*] are
42 necessary and reasonable in the investigation, preparation and presentation of the case **and that**
43 **require preauthorization under a policy of the Oregon Public Defense Commission**, including
44 but not limited to [*nonroutine*] travel, photocopying or other reproduction of [*nonroutine*] documents,
45 necessary costs associated with obtaining the attendance of witnesses for the defense, investigator

1 fees and expenses, expert witness fees and expenses and fees for interpreters and assistive commu-
2 nication devices necessary for the purpose of communication between counsel and a client or wit-
3 ness in the case. Preauthorization to incur a fee or expense does not guarantee that a fee or
4 expense incurred pursuant to the preauthorization will be determined to be necessary or reasonable
5 when the fee or expense is submitted for payment.

6 “(b) In a county or justice court, the request must be in the form of a motion to the court. The
7 motion must be accompanied by a supporting affidavit that sets out in detail the purpose of the re-
8 quested expenditure, the name of the service provider or other recipient of the funds, the dollar
9 amount of the requested expenditure that may not be exceeded without additional authorization and
10 the date or dates during which the service will be rendered or events will occur for which the ex-
11 penditure is requested.

12 “(c) In a circuit court, the request must be in the form and contain the information that is re-
13 quired by the policies, procedures, standards and guidelines of the [*Public Defense Services Com-*
14 *mission*] **Oregon Public Defense Commission**. If the [*public defense services*] executive director **of**
15 **the commission** denies a request for preauthorization to incur [*nonroutine*] fees and expenses
16 **subject to a preauthorization requirement**, the person making the request may appeal the deci-
17 sion to the presiding judge of the circuit court. The presiding judge has final authority to preau-
18 thorize incurring [*nonroutine*] fees and expenses under this paragraph.

19 “(d) Entitlement under subsection (7) of this section to payment for fees and expenses in circuit
20 court is subject to the policies, procedures, standards and guidelines adopted under ORS 151.216.
21 Entitlement to payment of [*nonroutine*] fees and expenses **subject to a preauthorization require-**
22 **ment** is dependent upon obtaining preauthorization from the court, if the case is in county or justice
23 court, or from the [*public defense services*] executive director **of the Oregon Public Defense Com-**
24 **mission**, if the case is in circuit court, except as otherwise provided in paragraph (c) of this sub-
25 section and in the policies, procedures, standards and guidelines adopted under ORS 151.216. Fees
26 and expenses shall be paid:

27 “(A) By the county, in respect to a proceeding in a county or justice court.

28 “(B) By the [*public defense services*] executive director **of the commission** from funds available
29 for the purpose, in respect to a proceeding in a circuit court.

30 “(C) By the city, in respect to a proceeding in municipal court.

31 “(4) Upon completion of all services by the counsel of a person determined to be eligible for
32 appointed counsel, the counsel shall submit a statement of all necessary and reasonable fees and
33 expenses of investigation, preparation and presentation and, if counsel was appointed by the court,
34 a statement of all necessary and reasonable fees and expenses for legal representation, supported
35 by appropriate receipts or vouchers and certified by the counsel to be true and accurate.

36 “(5) In a county or justice court, the total fees and expenses payable under this section must
37 be submitted to the court by counsel or other providers and are subject to the review of the court.
38 The court shall certify that such amount is fair reimbursement for fees and expenses for represen-
39 tation in the case as provided in subsection (6) of this section. Upon certification and any verifica-
40 tion as provided under subsection (6) of this section, the amount of the fees and expenses approved
41 by the court and not already paid shall be paid by the county.

42 “(6) In a county or justice court, the court shall certify to the administrative authority respon-
43 sible for paying fees and expenses under this section that the amount for payment is reasonable and
44 that the amount is properly payable out of public funds.

45 “(7) In a circuit court, the total fees and expenses payable under this section must be submitted

1 to and are subject to review by the [public defense services] executive director **of the Oregon Public**
2 **Defense Commission**. The [public defense services] executive director **of the commission** shall
3 determine whether the amount is necessary, reasonable and properly payable from public funds for
4 fees and expenses for representation in the case as provided by the policies, procedures, standards
5 and guidelines of the [Public Defense Services Commission] **commission**. The [public defense
6 services] executive director **of the commission** shall pay the amount of the fees and expenses de-
7 termined necessary, reasonable and properly payable out of public funds. The court shall provide
8 any information identified and requested by the [public defense services] executive director **of the**
9 **commission** as needed for audit, statistical or any other purpose pertinent to ensure the proper
10 disbursement of state funds or pertinent to the provision of appointed counsel compensated at state
11 expense.

12 “(8) If the [public defense services] executive director **of the Oregon Public Defense Commis-**
13 **sion** denies, in whole or in part, fees and expenses submitted for review and payment, the person
14 who submitted the payment request may appeal the decision to the presiding judge of the circuit
15 court. The presiding judge or the designee of the presiding judge shall review the [public defense
16 services] executive director’s decision for abuse of discretion. The decision of the presiding judge
17 or the designee of the presiding judge is final.

18 “(9) The following may not be disclosed to the district attorney prior to the conclusion of a case:

19 “(a) Requests and administrative or court orders for preauthorization to incur [nonroutine] fees
20 and expenses **subject to a preauthorization requirement** in the investigation, preparation and
21 presentation of the case; and

22 “(b) Billings for such fees and expenses submitted by counsel or other providers.

23 “(10) Notwithstanding subsection (9) of this section, the total amount of moneys determined to
24 be necessary and reasonable for [nonroutine] fees and expenses **subject to a preauthorization re-**
25 **quirement** may be disclosed to the district attorney at the conclusion of the trial in the circuit
26 court.

27 “(11) As used in this section unless the context requires otherwise, ‘counsel’ includes a legal
28 advisor appointed under ORS 135.045.

30 **“(Transfer of Duties)”**

31
32 **“SECTION 8. (1) The Public Defense Services Commission is abolished. On the operative**
33 **date of this section, the tenure of office of the members of the Public Defense Services**
34 **Commission and of the public defense services executive director ceases.**

35 **“(2) All of the duties, functions and powers of the Public Defense Services Commission,**
36 **except as those duties, functions and powers are modified by the amendments to ORS 151.213,**
37 **151.216 and 151.219 by sections 2 to 4 of this 2023 Act, are imposed upon, transferred to and**

3 session of the records and property, and shall take charge of the employees and employ them

5 without reduction of compensation but subject to change or termination of employment or
6 compensation as provided by law.

24 public or private, who consults a lawyer referral service with a view to obtaining professional legal

26 “(b) ‘Confidential communication’ means a communication not intended to be disclosed to third
27 persons other than those to whom disclosure is in furtherance of the rendition of professional legal
28 services to the client or those reasonably necessary for the transmission of the communication.

29 “(c) ‘Lawyer’ means a person authorized, or reasonably believed by the client to be authorized,
30 to practice law in any state or nation.

31 “(d) ‘Lawyer referral service’ means an entity that, as a regular part of its business, refers po-
32 tential clients to lawyers, including but not limited to a public nonprofit entity sponsored or oper-
33 ated by the Oregon State Bar.

34 “(e) ‘Representative of the client’ means:

35 “(A) A principal, an officer or a director of the client; or

36 “(B) A person who has authority to obtain professional legal services, or to act on legal advice
37 rendered, on behalf of the client, or a person who, for the purpose of effectuating legal represen-
38 tation for the client, makes or receives a confidential communication while acting in the person’s
39 scope of employment for the client.

40 “(f) ‘Representative of the lawyer’ means one employed to assist the lawyer in the rendition of
41 professional legal services, but does not include a physician making a physical or mental examina-
42 tion under ORCP 44.

43 “(2) A client has a privilege to refuse to disclose and to prevent any other person from disclos-
44 ing confidential communications made for the purpose of facilitating the rendition of professional
45 legal services to the client:

1 “(a) Between the client or the client’s representative and the client’s lawyer or a representative
2 of the lawyer;

3 “(b) Between the client’s lawyer and the lawyer’s representative or the client’s lawyer referral
4 service;

5 “(c) By the client or the client’s lawyer to a lawyer representing another in a matter of common
6 interest;

7 “(d) Between representatives of the client or between the client and a representative of the
8 client;

9 “(e) Between lawyers representing the client; or

10 “(f) Between the client or a representative of the client and a lawyer referral service.

11 “(3) The privilege created by this section may be claimed by the client, a guardian or
12 conservator of the client, the personal representative of a deceased client, or the successor, trustee,
13 or similar representative of a corporation, association, or other organization, whether or not in ex-
14 istence. The person who was the lawyer or lawyer referral service or the lawyer’s representative
15 at the time of the communication is presumed to have authority to claim the privilege but only on
16 behalf of the client.

17 “(4) There is no privilege under this section:

18 “(a) If the services of the lawyer or lawyer referral service were sought or obtained to enable
19 or aid anyone to commit or plan to commit what the client knew or reasonably should have known
20 to be a crime or fraud;

42 “42.125. (1) For the purposes of ORS 40.510 (1)(a) and (d), each state officer and state agency
43 may have a seal which, unless specifically provided otherwise by law, shall consist of an impression,
44 imprint or likeness of the state seal accompanied by the name of the state officer or state agency.

45 “(2) As used in this section:

1 “(a) ‘Seal’ has the meaning given that term in ORS 42.110.

2 “(b) ‘State agency’ means every state officer, board, commission, department, institution, branch
3 or agency of the state government, except:

4 “(A) The Legislative Assembly and the courts and their officers and committees; and

5 “(B) The [*Public Defense Services Commission*] **Oregon Public Defense Commission.**

11 and a hearing officer or the designee of a hearing officer shall appoint a qualified interpreter in an
12 adjudicatory proceeding, whenever it is necessary:

13 “(A) To interpret the proceedings to a non-English-speaking party;

14 “(B) To interpret the testimony of a non-English-speaking party or witness; or

24 duties and responsibilities of the court, agency or hearing officer. A fee may not be charged to any
25 person for the appointment of an interpreter if appointment is made to determine whether the person
26 is non-English-speaking for the purposes of this section.

27 “(3) Fair compensation for the services of an interpreter appointed under this section shall be
28 paid:

29 “(a) By the county, subject to the approval of the terms of the contract by the governing body
30 of the county, in a proceeding in a county or justice court.

31 “(b) By the city, subject to the approval of the terms of the contract by the governing body of
32 the city, in a proceeding in a municipal court.

33 “(c) By the state in a proceeding in a circuit court. Amounts payable by the state are not
34 payable from the Public Defense Services Account established by ORS 151.225 or from moneys ap-
35 propriated to the [*Public Defense Services Commission*] **Oregon Public Defense Commission.** Fees
36 of an interpreter necessary for the purpose of communication between appointed counsel and a cli-

40 “(d) By the agency in an adjudicatory proceeding.

41 “(4) If a party, victim or witness is dissatisfied with the interpreter appointed by the court, the
42 hearing officer or the designee of the hearing officer, the party, victim or witness may request the
43 appointment of a different interpreter. A request under this subsection must be made in a manner
44 consistent with the policies and notice requirements of the court or agency relating to the appoint-
45 ment and scheduling of interpreters. If the substitution of another interpreter will delay the pro-

1 ceeding, the person making the request must show good cause for the substitution. Any party may
2 object to use of any interpreter for good cause. Unless the court, hearing officer or the designee of
3 the hearing officer has appointed a different interpreter for cause, the party using any interpreter
4 other than the interpreter originally appointed by the court, hearing officer or the designee of the

13 “(5) Fair compensation for the services of an interpreter or the cost of an assistive communi-
14 cation device under this section shall be paid:

15 “(a) By the county, subject to the approval of the terms of the contract by the governing body
16 of the county, in a proceeding in a county or justice court.

17 “(b) By the city, subject to the approval of the terms of the contract by the governing body of
18 the city, in a proceeding in a municipal court.

19 “(c) By the state in a proceeding in a circuit court. Amounts payable by the state are not
20 payable from the Public Defense Services Account established by ORS 151.225 or from moneys ap-
21 propriated to the [*Public Defense Services Commission*] **Oregon Public Defense Commission**. Fees
22 of an interpreter necessary for the purpose of communication between appointed counsel and a cli-
23 ent or witness in a criminal case are payable from the Public Defense Services Account or from

26 “(d) By the agency in an adjudicatory proceeding.”.

4 “(a) The number of protective proceedings initiated, broken out by case type and case subtype;

17 protected persons and the average number of hours court-appointed counsel spent per case.

18 “**SECTION 24.** ORS 125.080 is amended to read:

19 “125.080. (1) The court may require that a hearing be held on any petition or motion in a pro-
20 tective proceeding.

21 “(2) A hearing must be held on a petition or motion if the respondent or protected person makes
22 or files an objection to the petition or motion and the objection is not withdrawn before the time
23 scheduled for the hearing.

24 “(3) A hearing must be held on a motion to modify a guardian’s powers under ORS 125.323.

25 “(4) The respondent or protected person may appear at a hearing in person or by counsel.

17 “(b) The defendant requests aid of counsel;
18 “(c) The defendant provides to the court a written and verified financial statement; and
19 “(d) It appears to the court that the defendant is financially unable to retain adequate repre-
20 sentation without substantial hardship in providing basic economic necessities to the defendant or
21 the defendant’s dependent family.
22 “(2) Suitable counsel for a defendant shall be appointed by a circuit court if:
23 “(a) The defendant is before the court on a matter described in subsection (5) of this section;

21 assets, liabilities and income in the previous year and the director determines that the person is
22 eligible for preparation of a transcript at state expense.

23 “(b) The cost of the transcript preparation under paragraph (a) of this subsection shall be in the
24 amount prescribed in ORS 21.345 and paid for as provided by the policies, procedures, standards and
25 guidelines of the [*Public Defense Services Commission*] **Oregon Public Defense Commission**.

26 “(4) After submission of the original brief by counsel, the [*public defense services*] execu-
27 tive director **of the Oregon Public Defense Commission** shall determine the cost of briefs and any other
28 expenses of appellant, except transcripts, necessary to appellate review and a reasonable amount
29 of compensation for counsel appointed under this section. Compensation payable to appointed coun-
30 sel shall be as established under ORS 151.216. On any review by the Supreme Court of the judgment
31 of the Court of Appeals the [*public defense services*] executive director shall similarly determine the
32 costs of briefs and any other expenses necessary for review and a reasonable amount of compen-
33 sation for counsel appointed under this section.

10 138.510 to 138.680 or to employ suitable counsel possessing skills and experience commensurate with
11 the nature of the conviction and complexity of the case for the proceeding may proceed as a finan-
12 cially eligible person pursuant to this section upon order of the circuit court in which the petition
13 is filed.

14 “(2) If the petitioner wishes to proceed as a financially eligible person, the person shall file with
15 the petition an affidavit stating inability to pay the expenses of a proceeding pursuant to ORS
16 138.510 to 138.680, including, but not limited to, the filing fee required by ORS 138.560, or to employ
17 suitable counsel for such a proceeding. The affidavit shall contain a brief statement of the
18 petitioner’s assets and liabilities and income during the previous year. If the circuit court is satisfied
19 that the petitioner is unable to pay such expenses or to employ suitable counsel, it shall order that
20 the petitioner proceed as a financially eligible person. If the court finds that a petitioner who has
21 been sentenced to death is not competent to decide whether to accept or reject the appointment of

24 matter of petitioner’s proceeding as a financially eligible person shall be determined by the latter

26 “(3) If a petitioner who has been sentenced to death qualifies for the appointment of counsel
27 under this section but rejects the appointment, the court shall determine, after a hearing if neces-
28 sary, whether the petitioner rejected the offer of counsel and made the decision with an under-
29 standing of its legal consequences. The court shall make appropriate findings on the record.

30 “(4) In the order to proceed as a financially eligible person, the circuit court shall appoint
31 suitable counsel to represent petitioner. Counsel so appointed shall represent petitioner throughout

3 to appointed counsel for petitioner as provided in this subsection shall be paid by the [*public defense*
4 *services*] executive director **of the Oregon Public Defense Commission** from funds available for
5 the purpose. At the conclusion of proceedings on a petition pursuant to ORS 138.510 to 138.680, the
6 [*public defense services*] executive director shall determine and pay, as provided by the policies,
7 procedures, standards and guidelines of the [*Public Defense Services Commission*] **Oregon Public**
8 **Defense Commission**, the amount of expenses of petitioner and compensation for the services of
9 appointed counsel in the proceedings in the circuit court.

10 “(7) If the [*public defense services*] executive director **of the Oregon Public Defense Commis-**
11 **sion** denies, in whole or in part, expenses and compensation submitted for review and payment, the
12 person who submitted the payment request may appeal the decision to the presiding judge of the
13 circuit court. The presiding judge or the designee of the presiding judge shall review the [*public*
14 *defense services*] executive director’s decision for abuse of discretion. The decision of the presiding
15 judge or the designee of the presiding judge is final.

16 “(8)(a) When a petitioner has been authorized to proceed as a financially eligible person, all

9 lishment of a defense under ORS 161.295 unless:

10 “(a) The court, in its discretion, permits the evidence to be introduced when just cause for
11 failure to file the report is shown; and

12 “(b) If the defendant is charged with a felony, the defendant is tried by a jury.

13 “(5)(a) A court may not accept a plea of guilty except for insanity to a felony unless a report
14 described in subsection (4) of this section is filed with the court. If the report has not been filed, the
15 court may order that a psychiatric or psychological evaluation of the defendant be conducted by a
16 certified evaluator and a report of the evaluation be filed with the court.

41 under ORS chapter 19 except that the court shall advance the appeal on the court's docket in the
42 same manner as appeals in criminal cases.

43 "(7)(a) Except as provided in ORS 419A.208 (2), or when otherwise ordered by the appellate
44 court, the filing of an appeal does not suspend an order or judgment of the juvenile court nor dis-
45 charge the ward or adjudicated youth from the custody of the person, institution or agency in whose

1 custody the ward or adjudicated youth may have been placed nor preclude the juvenile court after
2 notice and hearing from entering such further orders relating to the ward or adjudicated youth's
3 custody pending final disposition of the appeal as it finds necessary by reason only of matters
4 transpiring subsequent to the order or judgment appealed from. The trial court administrator shall
5 immediately file certified copies of any such order or judgment with the Court of Appeals.

6 “(b) Notwithstanding the filing of an appeal from a jurisdictional or dispositional judgment or
7 an order entered pursuant to ORS 419B.449 or 419B.476, the juvenile court may proceed with the
8 adjudication of a petition seeking termination of the parental rights of a parent of the ward who is

15 “(m) Assist the commission in developing standard operating expectations for persons providing
16 public defense services. The executive director may establish a standards advisory group to assist
17 in developing the expectations.

18 “(2) The executive director may designate persons as representatives of the executive director
19 for the purposes of determining and paying bills submitted to the commission and determining pre-
20 authorization for incurring fees and expenses under ORS 135.055.

22 “(Reporting to Legislature)
23

24 “**SECTION 86.** (1) No later than May 15, 2024, the Oregon Public Defense Commission
25 shall provide a comprehensive report on the commission’s plan for providing public defense
26 services in this state to the interim committees of the Legislative Assembly related to the
27 judiciary, in the manner described in ORS 192.245, that includes at least the following infor-
28 mation:

29 “(a) Financial projections for the commission based on anticipated workload;

30 “(b) A description of the commission’s proposed method for providing public defense
31 services based on anticipated workload;

32 “(c) The establishment of training and supervision requirements for public defense pro-
33 viders;

34 “(d) Steps taken to determine a reasonable hourly rate for appointed counsel who are not
35 employees of the commission that accounts for overhead expenses; and

36 “(e) Steps taken to improve oversight and enforcement of statewide objective standards
37 for the provision of public defense.

38 “(2) Beginning no later than December 1, 2025, and biennially thereafter until December
39 1, 2035, the commission shall provide the interim committees of the Legislative Assembly
40 related to the judiciary with an updated version of the report described in subsection (1) of
41 this section.

42 “**SECTION 87.** Section 86 of this 2023 Act is repealed on January 2, 2036.
