

Senate Bill 41

Sponsored by Senator FINDLEY (at the request of Oregon Business and Industry) (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates Task Force on Regulatory Efficiency.
Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

2 Relating to administrative law; and prescribing an effective date.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Task Force on Regulatory Efficiency is established.**

5 **(2) The task force consists of 12 members appointed as follows:**

6 **(a) The President of the Senate shall appoint two members who are not members of the**
7 **same political party from among members of the Senate.**

8 **(b) The Speaker of the House of Representatives shall appoint two members who are not**
9 **members of the same political party from among members of the House of Representatives.**

10 **(c) The Governor shall appoint eight members as follows:**

11 **(A) One representative of the Department of Environmental Quality.**

12 **(B) One representative of the Occupational Safety and Health Division of the Department**
13 **of Consumer and Business Services.**

14 **(C) One representative of the Employment Department.**

15 **(D) One representative of the Department of Land Conservation and Development.**

16 **(E) One representative of labor unions.**

17 **(F) One representative of an organization relating to the environment.**

18 **(G) One representative of an organization relating to minority-owned businesses.**

19 **(H) One representative of a statewide organization relating to business.**

20 **(3) The task force shall:**

21 **(a) Review agency regulatory managerial effectiveness and organizational competence,**
22 **jurisdictional overlap or conflict among regulatory bodies, managerial accountability, inter-**
23 **nal agency incentive structures, customer focus and how agency cultures influence regula-**
24 **tory oversight, including the rulemaking process.**

25 **(b) Evaluate whether a permanent regulatory efficacy commission is necessary to provide**
26 **independent evaluations of agency performance and remedy shortcomings of existing state**
27 **audit functions.**

28 **(4) A majority of the voting members of the task force constitutes a quorum for the**
29 **transaction of business.**

30 **(5) Official action by the task force requires the approval of a majority of the voting**
31 **members of the task force.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 **(6) The task force shall elect one of its members to serve as chairperson.**

2 **(7) If there is a vacancy for any cause, the appointing authority shall make an appoint-**
3 **ment to become immediately effective.**

4 **(8) The task force shall meet at times and places specified by the call of the chairperson**
5 **or of a majority of the voting members of the task force.**

6 **(9) The task force may adopt rules necessary for the operation of the task force.**

7 **(10) The task force shall submit a report in the manner provided by ORS 192.245, and**
8 **may include recommendations for legislation, to a committee or interim committee of the**
9 **Legislative Assembly related to general government no later than September 15, 2024.**

10 **(11) The office of the Governor shall provide staff support to the task force.**

11 **(12) Members of the Legislative Assembly appointed to the task force are nonvoting**
12 **members of the task force and may act in an advisory capacity only.**

13 **(13) Members of the task force who are not members of the Legislative Assembly are not**
14 **entitled to compensation or reimbursement for expenses and serve as volunteers on the task**
15 **force.**

16 **(14) All agencies of state government, as defined in ORS 174.111, are directed to assist**
17 **the task force in the performance of the duties of the task force and, to the extent permitted**
18 **by laws relating to confidentiality, to furnish information and advice the members of the task**
19 **force consider necessary to perform their duties.**

20 **SECTION 2.** **Section 1 of this 2023 Act is repealed on December 31, 2024.**

21 **SECTION 3.** **This 2023 Act takes effect on the 91st day after the date on which the 2023**
22 **regular session of the Eighty-second Legislative Assembly adjourns sine die.**
