Senate Bill 5504

Introduced and printed pursuant to House Concurrent Resolution 23 (2023) (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Department of Corrections for certain biennial expenses.

Limits certain biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by department. Limits biennial expenditures by department from federal funds.

Declares emergency, effective July 1, 2023.

1 <u>SECTION 3.</u> Notwithstanding any other law limiting expenditures, the amount of \$300,000 2 is established for the biennium beginning July 1, 2023, as the maximum limit for payment of 3 expenses from federal funds collected or received by the Department of Corrections.

4 <u>SECTION 4.</u> Notwithstanding any other law limiting expenditures, the amount of 5 \$39,205,052 is established for the biennium beginning July 1, 2023, as the maximum limit for 6 payment of expenses by the Department of Corrections from American Rescue Plan Act 7 Coronavirus State Fiscal Recovery Fund moneys received by the Oregon Department of Ad-8 ministrative Services and transferred to the Department of Corrections.

9 SECTION 5. This 2023 Act being necessary for the immediate preservation of the public
10 peace, health and safety, an emergency is declared to exist, and this 2023 Act takes effect
11 July 1, 2023.
